

# Old Saint Paul's Church Cemetery Restoration Project Gets Underway

One of the AKDHA's most ambitious projects became a reality on Saturday, June 29, 2013, when the restoration of Old Saint Paul's Lutheran Church Cemetery (OSP) began with major repairs to four markers, the cleaning of 20-25 markers, and the resetting of six bases and stones.

The old white clapboard church at Old Saint Paul's was built about 1818 and replaced two previous structures. This historic building remains the oldest existing church in North Carolina west of the Catawba River. The OSP Cemetery has gravestones dating back to the 1700's. Graves of Andreas Killian descendants can be found there. The Andreas Killian monument, our association's first project, stands prominently in the cemetery. Time has taken its toll. More than two hundred gravestones and markers are in need of critical repairs and cleaning.

Planning this project goes back more than two years. Dan Sipe, Program and Projects Director of AKDHA spearheaded the effort. Steve Killian was appointed OSP Project Leader. Together they educated themselves on what this project would require. The leadership at Old Saint Paul's Church was approached and wholehearted gave their support and cooperation. In a strategy meeting in October 2012, all agreed it was necessary to hire a "Cemetery Restoration Consultant". Mr. Jason Harpe of Harpe Consulting of Charlotte, NC (and former speaker for the AKDHA Reunion) was chosen to lead this project. His extensive credentials as an historic preservation specialist and his passion for this type of project made a perfect fit.



The next hurdle was funding. We are fortunate to have Dan Sipe as an active member of the AKDHA (a legal 501(c)(3) nonprofit) and an employee of Duke Energy Corporation. With this criteria, Dan applied and received funding several times from the Duke Energy Corporation grant program.

On June 29th, 31 people donning blue t-shirts provided by Duke Energy attended training on how to safely repair and clean gravestones. Members of three other churches attended as well. Jason brought his associate, Bill Beam, so we could have two teams working simultaneously. It was a full day of hands-on work. The most challenging task involved gravestone bases buried below the grass line tilting the markers in precarious positions. Those required a bit of digging for removal and resetting to level status.

This day begins a journey of repairs that will take a long time to accomplish for sure. We now have AKDHA volunteers trained to perform many of the restoration tasks needed. With Jason's leadership skills, other workdays will be planned this year. Our Killian family will honor our departed ancestors by making their resting place a safe and enjoyable place to visit.

Don't miss this: If you missed the training session and would like to learn how to clean stones, be sure to sign up for the Saturday tour at the 2013 Reunion. Plans are in the works for Killian cousins to assist in cleaning and resetting a few stones during the tour stop at OSP. You're welcome to give it a try, anyone can do it. Wear clothing you won't mind getting a little dirty. Tents will be set up in case of rain or high temperatures. The old church building will be opened for viewing and seating. It is truly a gratifying experience.

# Greetings from Germany, from William "Bill" McCreight May 23, 2013

Our most distant known Kilian cousins in Germany welcomed another member to the family. Markus Kilian and his wife Dagmar had a baby girl named Linea Kilian. She was born on the 14th of February, 2013. This is the 4th grandchild of DNA project member Walter Kilian born 1940 in Germany.

In May, Walter Kilian had a stroke. I have been keeping up with his recovery. Walter's daughter Andrea says he is getting "better and better". She went on to say, "... There are still some confusion, he sometimes has problems with remembering the days (Monday, Tuesday, weekend or not) and also with the time (morning, afternoon) but everything else is more or less fine. He's still not in his old physical condition but he feels more or less good. There are days which are better and days which are not so good. Anyway, we are really thankful having him back in such a good condition..."

Bill will not be at this year's AKDHA Reunion, but he has sent a PowerPoint presentation based on his latest research on two families living in Germany today who descend from Sebastian Kilian born before 1560 in Kühnhard, Württemberg.

## **Oscar Daniel Killian**

February 4, 1897-April 16, 1978

Andreas Killian (1702-1788) > Andrew Killian Jr. > Daniel Killian> Andrew Jackson Killian > John Lafayette Killian > Oscar Daniel Killian Submitted by Billy Mack Killian

My grandfather, John Lafayette Killian, abandoned Gilmer County, Georgia, in 1879 after the death of his wife Mary Jane Reeves. He left his two-year-old daughter with her maternal grandparents. Arriving in Texas that year, he stopped in the Lockhart-Martindale area of Caldwell County. On August 2, 1885, he married Mary Ellen Cruesturner of Martindale in Lockhart, Texas.

My father, Oscar Daniel Killian, was born in Martindale, Texas, on February 4, 1897. Oscar was the fifth of the eleven children of John L. Killian. According to the 1900 census, John was an itinerant farmer and lived in Kaufman County, Texas. The birth certificate of Oscar's brother, Jim Gaddy, shows the family lived in Erath County, Texas, in 1905. The 1910 census shows the family in Mitchell County, Texas. This would place them in or near Colorado City, Texas, where both John and Mary Ellen remained and were buried in Colorado City Cemetery.

Oscar would have helped his father with farm work. When war broke out in Europe, the United States decided to enter the action. A chance for adventure attracted young men. Oscar, a man who loved his country, its values, and principles, traveled to Dallas, Texas, with his younger brother, Norman, to enlist in the Texas National Guard.

Their enlistment was July 19, 1917, in the 36th Division (Texas Division). Their assignment was Battery D First Artillery. Oscar and Norman landed in France on July 18, 1918. Oscar showed leadership abilities. He was offered a field commission, but turned it down having promised his mother he would stay with and take care of Norman. Oscar became the victim of a mustard gas attack in the Argonne Forest. He left the front to allow his burned lungs to heal. Upon recuperation, Oscar was assigned to Bakery Company with the 321st Quarter Master Corp. He was honorably discharged on May 10, 1919.

Oscar's time with the Quarter Master Corp may have inspired a career in business when he returned to the states. He went to work in a store in Alvord, Wise County, Texas. The town is near Decatur, Texas, where my mother Viola Fowler and her family lived.

Oscar earned a partnership in a dry goods store. He joined the Masonic Lodge in Alvord, becoming a 32nd degree mason. Viola taught school in nearby Rhome, Texas, in 1926. They started seeing each other at this time. Oscar's efforts in business were successful. While acquiring enough capital to look for his own business, Oscar and Viola married on December 24, 1928. The couple moved to Slaton, Lubbock County, Texas, in 1929.

Oscar purchased a dry goods store in Slaton and Viola taught school. Viola's mother, brother, and sister lived with them. The store was a successful venture. Oscar Jr. was born on February 4, 1934. Joe Lee was born on November 12, 1938. The business provided enough capital for Oscar to acquire a grocery store in Andrews, Andrews County, Texas. According to the 1940 census, a residence was maintained in Lubbock and Andrews concurrently. By 1942, the business in Andrews had sold. Oscar registered for the World War II draft in Lubbock that same year.

Seeing the possibilities in real estate, Oscar sold the store in Slaton and joined a real estate office in Lubbock.

In 1945, he opened the Killian and Cox Real Estate Office. In 1947, the business moved downtown to an office in the Conley Building. A third son, Billy Mack, was born on November 25, 1949. A second office was opened in Stephenville, Erath County, Texas. In 1953, Oscar started buying mineral rights and land. One investment included buying a 24,000 acre ranch in Kent County, Texas. This was divided into smaller tracts and sold. This type of investing continued as he made purchases in Yoakum and Gains Counties.

Our family farmed and ranched in an area close to the New Mexico/Texas state line. That's what you do in Texas. Yet when Oscar passed away on April 16, 1978, he and Viola were still selling real estate in Denver City, Texas.

Many thanks to Billy "Bill" Mack Killian for submitting this narrative on his father. In this year's World Fish Carving Championships, Bill's trout won second place and his red drum won first place. Congratulations!

**FRANKLIN L. HERMAN,** Private, Company E, 72nd Regiment, NC Troops [B-246]. He was born 07 FEB 1821 in what was Lincoln County, NC, and died 29 JAN 1900 in Catawba County, NC. He married Orpha Mahala ISENHOUR on 14 NOV 1844 in Catawba County, NC. She was born 03 MAR 1827 in NC and died 01 APR 1914 in Catawba County, NC. She shares the gravestone with her husband. He was the son of John Daniel HERMAN and Mary KILLIAN, daughter of Samuel C. KILLIAN.

WILLIAM F. KILLIAN, Private, Company F, 23nd Regiment, NC Troops - Resided in Catawba County where he enlisted 6 JUN 1861. Present or accounted for until wounded at Seven Pines, VA, on 31 MAY 1862. Returned to duty prior to 14 SEP 1862, when he was captured at South Mountain, MD. Confined at Fort Delaware, DE, until paroled and transferred to Aiken's Landing, James River, VA, on 2 OCT 1862, for exchange. Declared exchanged at Aiken's Landing on 10 NOV 1862. Returned to duty prior to 1 MAY 1863. Present or accounted for until wounded in the right ankle and captured at Gettysburg, PA, on 1 JUL 1863. Hospitalized at Gettysburg and at Baltimore, MD, until paroled at Baltimore on 23 AUG 1863, and transferred to City Point, VA, where he was received 24 AUG 1863, for exchange. Returned to duty in JAN-APR, 1864. Present or accounted for until paroled at Appomattox Court House, VA, on 9 APR 1865 [NCT-7:200]. He died 15 FEB 1873 aged 34 years and 10 months. His headstone reads: "Farewell my wife children dear; Keep Christ the Lord in your fear; And if in heaven we all shall meet; We'll shout around the saviour's seat." His wife and children have not been identified. He was the

son of Andrew KILLIAN, son of Samuel C. KILLIAN, and Sophie REESE.


NOAH W. KILLIAN, Private, Company F, 32nd Regiment, NC Troops - Resided in Catawba County and enlisted at Camp Hill at age 20, on 17 OCT 1862. Present or accounted for until he died 14 DEC 1863, of disease. Place of death not reported [NCT-9:61]. He was born 18 JUL 1837 in Lincoln County, NC. He was the son of Frederick KILLIAN, son of Samuel C. KILLIAN, and Catherine LUTZ.

**SAMUEL E. KILLIAN, Private, Company K, 46th Regiment, NC Troops** - Born in Catawba County where he resided as a farmer prior to enlisting in Catawba County at age 18, on 13 MAR 1862. Present or accounted for until wounded in the left hand at Wilderness, VA, on 5 MAY 1864. Returned to duty in JUL-AUG, 1864. Detailed for light duty in the division commissary department on 29 OCT 1864, by reason of disability for field service. Surrendered at Appomattox Court House, VA, on 9 APR 1865 [NCT-11:234]. He was born 9 SEP 1842 in Catawba County, NC, and died 22 MAR 1919 in Catawba County, NC. After the war he farmed and later became involved in merchandising. He was a local Magistrate for 30 years and a Notary Public for ten years. He married Frances FRY on 20 NOV 1866 in Catawba County, NC. She was born 31 OCT 1846 in Catawba County, NC, and died 20 JUN 1884 in Catawba County, NC. She was buried 22 JUN 1884. He married, second, Alice Minerva HUNSUCKER about 1886, NC. She was born 20 NOV 1860 in Catawba County, NC, and died 06 SEP 1919 in Catawba County, NC. She was buried 08 SEP 1919 in Oakwood Cemetery, Hickory, Catawba County, NC. He was the son of Frederick KILLIAN, son of Samuel C. KILLIAN, and Catherine LUTZ.

**JOHN SUMMEY COULTER,** Private, Company E, 72ND Regiment, NC Troops [M-4:321, P-326] He was born 30 JAN 1847 in Columbia, Richland County, SC, and died 7 OCT 1925 in Catawba County, NC. He married Sarah Ann Saphronia Herman; she is a descendant of John Daniel HERMAN and Mary KILLIAN, daughter of Samuel C. KILLIAN.

Since names are repeated in the same generation, researching these lineages proved to be a test of tenacity. Derick reviewed this article and reported that descendants of Andreas' son, John, are also buried at OSP. As of today, the descendants of John have not been verified. We hope to have that research completed for the Winter 2014 issue of the Killian Family Newsletter.

# Heirs of John Bowman vs. George Killian & Thomas Black

State of North Carolina, Burk County To wit

Agreeable to a Dedimous Potestatem from the workshipfull Court of Burk County we have call'd before us Robt Brank as a witness in a suit Between George Killian plantiff & the Heirs of John Bowman Decd Defft Being Duly sworn Deposeth & sayeth—That about Eighteen or ninteen years past Josias Black Came on the premises now in Dispute Between the Contending parties & made a small Improvement theron & went Home to Mack-lingburg—And in a few Days after that Andrew Killian Came to the House of the Deponent & Requested of him to go & help him to Raise a Cabbin on the aforesd premises to Keep the Divels out which the sd Deponent sayeth he understood to be the Blacks And the Deponent further sayeth that he never heard that George Killian laid any Righ or Title to the above premises until Andrew Killian went off with the Torys. That the first Improvement was made by Black by Deading Two trees & Cutting down One sapling & the Second by Andrew Killian who Erected a cabbin thereon about 12 or 14 feet square & cover'd & that young Andrew Killian went into the Cabbin & live'd there some time and cleard some ground. Then the sd Blacks Returned & Built an other Cabbin twenty & Sixteen feet & cover'd & liv'd in it On which young Andrew Killian mov'd away—

And this Deponent further sayeth that there was at that time great quarreling Between the Killians & the Blacks & that he believ'd it to be on acct of the aforesd Land & further that he believes from every surcomstance that a Certain Abraham Scott During above Dispute Join'd with the Killians Against the Blacks—And further the Deponent sayeth not

Sworn & subscribed this 8<sup>th</sup> Sepr 1785 before us

# The Family of North Carolina Pioneer Andreas Killian (1702-1788) Addendum, June 2013

## Correction of Page 89 and Page 95

Transcription of Burke County Estate Papers, John Bowman (1781)

The original citation on pages 89 and 95 were based on review of a partial transcription [abstract] of the original document. The following is revised as of 27 June 2013 after reading the complete testimony of Robert Brank from the original document photocopy. The Burke County, NC, Court record about the George Killian vs. Josias Black case is dated 8 September 1785 and found in the Estate Files of John Bowman from the NC Archives and posted at FamilySearch.org. After further study, I [Gene Killian] realized that 19-20 years past would have been in 1764-65, and that date was when Josias Black came to the property in dispute and "made improvements" that Brank described.

#### Page 89

In 1773, George Killian, brother of Andrew, received a grant for 300 acres of land on Hunting Creek in Burke County, NC. About 1779, a dispute between the John Bowman heirs, Josias Black, and George Killian arose about the 300 acres of land. Josias Black sold the 300 acres to John Bowman and gave bond for the title. In a deposition to the court in 1785, Robert Brank said, "that 18 or 19 years ago, Andrew Killian came to the house to keep the "Divels" out (Josias Black), until he (Andrew) went off with the Tories". The 18 or 19 years was probably a transcription error, and probably should have read 8 or 9 years ago, 1776-1777. "That about Eighteen or ninteen years past Josias Black Came on the premises now in Dispute Between the Contending parties & made a small Improvement theron. . . And the Deponent further sayeth that he never heard that George Killian laid any Righ or Title to the above premises until Andrew Killian went off with the Torys."

#### Page 95

About 1776-77 1764-1765, Josias Black claimed [improved] the 300 acres on Hunting Creek that George received in 1773. Josias sold this 300 acres plus other acreage to John Bowman and gave bond to guarantee title to the 300 acres. John Bowman was the sheriff of Burke County and was killed in the battle of Ramsour's Mill in 1780. In 1785, a lawsuit arose between the John Bowman heirs and George Killian. A witness in the lawsuit, Robert Brank Sr., said in a deposition that 18 or 19 years ago, Andrew Killian (most likely the brother of George) came to the house to keep the "Divels" out, (meaning the Josias Black family) until he (Andrew) went off with the Tories". The 18 or 19 years was probably a transcription error or copied wrong later. We assume the correct date to be 1776-77. "That about Eighteen or ninteen years past Josias Black Came on the premises now in Dispute Between the Contending parties & made a small Improvement theron... And the Deponent further sayeth that he never heard that George Killian laid any Righ or Title to the above premises until Andrew Killian went off with the Torys."

The partial transcription [abstract] of that record is essentially correct, but leaves out some very important details, such as naming the "young Andrew Killian."

"Second by Andrew Killian who Erected a cabbin thereon about 12 or 14 feet square & cover'd & that **young Andrew Killian** went into the Cabbin & live'd there some time and cleard some ground. Then the sd Blacks Returned & Built an other Cabbin twenty & Sixteen feet & cover'd & liv'd in it On which **young Andrew Killian** mov'd away—"

The document <u>does not</u> indicate which Andrew Killian "went off with the Torys." An unidentified Andrew Killian was found listed in British pay records in 1780-82 and a George (Killin/Killen/Killon) name appears in British pay records 1777-79-81. Descendants of George Killian (born 1740), son of Andreas, reject the implication that the soldier on British payrolls was Andrew Killian Jr., the son of Andreas Killian. This leaves a question: Were both Andreas Killian and Andrew Killian Jr. soldiers in the North Carolina Tory Militia commanded by the British? Or, could Andrew Killian Sen., son of Leonard, have been one of the Andrew Killians named in British pay records?

AKDHA would like to thank: Kathy Gunter Sullivan for transcribing and publishing the Estate Record of John Bowman (1781); Gwinn Sherrill passing the information along to Dan Sipe; Dan Sipe sending the information onward; and Gene Killian for interpreting what the original image of the document was implying. An abstract gave enough information to form an opinion, but the complete document gave a more accurate account of the very important detail of naming the young Andrew Killian and the time line. There is nothing like reading the original document before forming an opinion.

## **New Andreas Killian Descendants Y-DNA Project Members**

Let us welcome two descendants of Andreas Killian to the Kilian/Killian/Killian Y-DNA project. Mr. John I. Killian joined in April 2013. He is a descendant of Samuel C. Killian. Mr. Eugene "Gene" Killian of Paris, IL joined the project in May 2013. He is a descendant of Leonard Killian. A full DNA project report is scheduled for the Winter 2014 Killian Family Newsletter.

# What Some Descendants of Andreas Killian Are Doing

"It is amazing what you can accomplish if you do not care who gets the credit." This quote from Harry S. Truman is very true when it comes to teamwork.
