

## **Andrew Killion vs. Elijah Isaacs**

While editing *The Family of North Carolina Pioneer Andreas Killian (1702-1788)*, Thomas Eugene "Gene" Killian gave me a short essay of who was *A Slave Named Primus*, page 217. In some compiled research given to me by Gene before he passed away, he did analysis of the known Andrew Killians in 1783; Andreas born 1702; Andrew Jr. Born 1737; Andrew III born 1771 (son of Andrew Jr.); Andrew "Sen" born 1752 (son of Leonard).

During colonial times there were District Courts in which several counties comprising one district. Tryon County (abolished in 1779) was in the Salisbury District. In 1782, the Salisbury District was divided, and Lincoln, Burke, Rutherford, and Wilkes were declared a separate district by the name of Morgan. Morgan District Court was held at the courthouse in Burke County. This is the court of the Andrew Killion and Elijah Isaacs case.

In July 1783, Morgan District Superior Court Case Andrew Killion vs. Elijah Isaacs, Andrew Killion complained of "casually" losing a slave in Wilkes County; that Elijah Isaacs had the slave, but had refused to return him. Killion demanded damages of 250 Pounds. A. Moore, "Pro Pltff.", for Andrew Killion. ["Pro Pltff." means that A. Moore stood in for Andrew Killion and Andrew was not actually there.]

In March 1786, the Morgan District Court commanded the Sheriff of Wilkes County to "seize of the goods, chattels, lands and tenements of Elijah Isaacs you [*sic*] cause to be made the sum of nine pounds and twelve shillings...our Superior Court of Law and Equity, held for the district of Morgan Andrew Killion recovered against him...in said suit." The suit was apparently satisfied by executing "one entry of land adjoining William Guist land. Satisfied by the Defendant...".

In 1796, a Burke County Court Record mentions attendance at the dwelling house of John Lindsey on May 10 for a deposition, and (then) at George Gordon's (dwelling) in Wilkes County on June 26 to take (a) deposition of Col. Elijah Isaacs. This indicates that Elijah Isaacs lived in Wilkes, but there is still no evidence showing that this Andrew Killion actually lived in Wilkes County.

So, who was this Andrew Killion in the court cases of 1783 and 1786? I will try to interpret data using notes from Gene.

In *The History of the Killian Family in North Carolina* by J. Yates Killian there is a clue which may point to the identity of Andrew Killion. J. Yates Killian, quoted James Killian Jr., of Little Rock, AR (in 1925), saying that "Andrew Killian Jr., settled in Iredell County and was twice married." It is known that Daniel "Killion" (b.1777) bought land in 1802 in Iredell County at age 25, and was living there until 1815. Daniel Killion sold his remaining property in Iredell County NC in 1815. He was in Buncombe County NC for the 1820 census as "Daniel Killion" with "(Iredell)" written after his name. In 1925, James Killian Jr. had assumed that his ancestor, Andrew, was Andrew Jr., son of Andreas, and this Daniel born 1777 was the one listed in Andreas's Will. This was not the case; the Daniel of Andreas' Will can be identified from other records.

When was first introduced to Gene, he was assuming that Daniel Killion of Iredell County was a relative of Henry and Shadrach Killian of the 1790 census of Wilkes County and I understand why. But in 2006, Leon M.

“Chip” Killian III of Haywood County, NC submitted DNA which proved Daniel Killion of Iredell County was a descendant of Andreas Killian and not related to the Killians of the 1790 census of Wilkes County, NC.

As Gene wrote, “...there is still no evidence showing that this Andrew Killion actually lived in Wilkes County”. After reviewing the data, my interpretation is Andrew Killion did not live in Wilkes County. In the late 1700s, Western North Carolina was no longer the frontier which Andreas and his family helped settle. There is very little information on the children of Leonard, son of Andreas. The data points to Andrew Killion as being Andrew Killian “Sen” of the 1800 census of Lincoln County, NC. This Andrew was married twice and would be the correct age to be the father of Daniel Killion born 1777 of Iredell County, NC.

Now, would Andrew “Sen” have been Andrew Killion who “casually” lost Primus? He is the most likely suspect.

## In Memory of William D. "Bill" Killian

(12 May 1922-17 Mar 2019)

Dr. William David "Bill" Killian, age 96, died March 17, 2019 after a period of declining health. A native of Lincoln County, he was born on May 22, 1922 to the late David Coon and Bessie Era Lantz Killian. He was preceded in death by his beloved, beautiful wife, Helen Shufford Killian in 2011. They had been married 63 years. He was also preceded in death by his three siblings; Frank Killian, Robert Killian and Elizabeth Killian Mosteller.

He was a graduate of Appalachian State Teacher's College with a Bachelor's of Science Degree in Mathematics and Science Education respectively. Like many young men, he was called on to serve his country during World War II enlisting in the United States Navy. After his separation from duty he enrolled at North Carolina State University and obtained another Bachelor's Degree in Agricultural Education. His passion for education was not simply his understanding that knowledge was not only powerful, but the sharing of knowledge to eager students was extremely rewarding to him as well. As a Vocational Agriculture Education instructor, Professor Killian's positions allowed him and his family to reside in several cities in NC including; Lincolnton, Stony Point and Cleveland, North Carolina. In 1962 after accepting a teaching position at Catawba County Technical Institute (CCTI), he shifted to an administration career with the acceptance of the Agricultural Technical Coordinator and then as the Director of Evening Programs of CCTI. He left CCTI long enough to complete his Doctorate studies at North Carolina State prior to resuming his administrative duties at CCTI.

In 1969, Dr. Killian had been made aware of the plans for a community institute to be created in the Hendersonville area to provide secondary education as well as industrial training for local students and applied for the position with the current Board of the Henderson County Commissioners.

He eagerly accepted the position of the first President of the Henderson County Technical Institute a public two year institution which was granted its charter with the North Carolina State Board of Education on July 21, 1969. He successfully nurtured the institute which later became a two year college. He retired in June 1987.

On Sunday, October 2, 1988, the \$2 million, 32,000 square foot student center at the Blue Ridge Community College in Henderson County was dedicated to him, with Robert Scott, President of the North Carolina Community College System, giving the keynote address. He was also inducted in the Henderson County Education Hall of Fame in 2002, and was a proud recipient of the Order of the Long Leaf Pine. He was an active member of the Rotary Club of Hendersonville as well as a Paul Harris Fellow Rotarian.

In December 2005, he published a book entitled "Things I Remember (Stories of the Killian Family)". This interesting book is about his family and the area he grew up; The Daniels Community in Lincoln County, NC. He has been an active member in the Killian Family Association of North Carolina with respect to their annual meetings. Bill and his wife attended the unveiling of the Andreas Killian Monument in 1952. Bill served as Historian (1982-89) and President (1993-94). Bill mailed reunion announcements for 30 years and helped George Weldon Killian with the Killian Family Newsletter for 9 years.

Bill's brother, Frank, was at the 1<sup>st</sup> Killian Reunion. It is families like this who have kept the Killian Reunion in North Carolina going for 85 years. Bill, Frank, and Robert have been missed, but they will not be forgotten.

### **In Memory of Walter Kilian of Germany**

(Nov 1, 1940-Jan 27, 2019)

Walter Kilian of Schainbach Germany was born in Germany, November 1, 1940. He had a stroke in May 2013. With his health declining, he passed away January 27, 2019.

He lived in Schainbach where Andreas' father, Georg, was born. In 2011, Mr. William McCreight spoke to Walter about joining the Killian/Killion DNA project and Walter agreed. The test proved he shares a common ancestor with descendants of North Carolina pioneer Andreas Killian. The DNA test and documentary evidence of Walter Kilian's genealogy proves conclusively the Andreaß Kilian from Steinbach an der Holzecke was in fact the North Carolina pioneer Andreas Killian born 1702.

Walter Kilian was a 111 Marker match with 5 descendants of Andreas Killian. These results came back in 2018. The new 111 Marker test confirms Walter Kilian and the descendants of Andreas Killian are a 99% match of sharing a common ancestor within the last 16 generations. Considering all the documentation, DNA proves without any doubt that Mr. McCreight found the correct Kilian family in Germany of the NC pioneer Andreas Killian.

## **George “Lane” Killian, Boxing Champion**

My son George “Lane” Killian is a former Corporal of the United States Marine Corps. He was inducted into the All Marine Boxing Team Alumni Hall of Fame at a formal gala held at Camp Lejeune in North Carolina on April 14, 2018. Lane Killian is a native of Fort Payne and a descendant of Daniel Killian born 1790.

Lane Killian started boxing when he was 15 years old. I had a boxing gym. Lane was the Alabama Golden Gloves Champion 1976-1978; AAU All-State 1977-1978; All Southeastern 1978; All Marine Boxing Champion 1979-1981; Inter-service Champion 1980; Ranked number 3 in the United States in 1980; 1980 USMC US All Star Champion; 1980 North Carolina Golden Gloves Champion; and Member of the Tennessee, Alabama and Georgia Boxing Halls of Fame. He was a 1980 Olympic Team finalist, but did not go to Moscow because President Carter pulled the US teams from the 1980 games.

After leaving the Marines, Lane turned pro and made his debut January 13, 1983. His alias was Flamin' Lane Killian. Lane competed in the bantamweight class, won 15 of 17 pro bouts, 13 by knockout during a two-year pro career. Both of his losses were to Keven Seabrook. Lack of an available sparring partner and failure to find quality opponents were the reasons Lane gave for his retirement. His amateur record was 132-21 and he won numerous amateur titles.

Lane is also an avid runner. In 1996 , he was chosen as an Olympic Torch bearer in Rome, GA. He carried the torch to the stage set up for the week of celebration in Rome and lit the Cauldron starting the celebration.

Lane is the son of George and Ann Killian; Grandson of L. B. “Jack” and Annie Killian; and Great-Grandson of Demoville and Mary Ellen Killian. Andreas is Lane’s 7th great grandfather.

## **Hart Square Village AKDHA Reunion Tour**

Hart Square Village began as the collection of early American antiques and log buildings of Dr. Bob (retired MD) and Becky Hart of Hickory, NC. The expansive collection includes one of three functioning pre-civil war cotton gins in the U.S., a print shop, a doctor’s office, a one room schoolhouse, a chapel and countless artifacts that will never be found anywhere else.

Hart Square Village is now the nation’s largest collection of historic log structures in one place. Every structure is furnished with Appalachian antiques, displaying the various professions and nineteenth century experiences. The interiors are authentic, from every pewter spoon on the dining table to every butter churn and rope bed.

The Annual Hart Square Festival is in October, so we are going to a ghost town. So you say, why go? The AKDHA reunion trip to Hart Square Village is a glimpse into life of North Carolina pioneers. The village is authentic off-grid living, with the exception of toilet facilities. Wouldn’t you like going back to Andreas’ “house” on Killian’s Creek? To walk the path he walked? This is as close as we will ever get to living West of The Catawba in colonial times
