Furthurmore, we would be delighted to have some of your family meet some time with our Klan- The time has been fixed permantly as the second Sunday in each September at Salem-Lutheran Reformed Church in Lincoln County, N.C.

As you may have read from our brief history book we unveiled a marker to Pioneer Andreas Killian and Cletus Hugo Killian (now deceased was then living in Brooklin N.Y.) His widow Leota, now lives with some of her children in Rochester, N.Y.

She mailed me the copies of of which I enclose, you undoubtably know some of these people and kindred-- He had a compleat lineage of the Killians back beyond Martin Luther at the time he visited here.

I also had a request for a book from Duane Killian of Rt 1 Box 267 of Rigby, Idaho. She also must be connected some way with your line.

We also have another groupe of descendentts from Samuel C. Killian who was the 10th child of Pioneer Andreas, who meet the first Sunday of May in South Carolina(or Chester County) Mr. J.Yates Killian who was the organizer of our N.C.Klan and secured most of the data we have was a descendant of Samuel C. also, Dr James Rhyne Killian former President of M.I.T. in Boston and now chairman of the board is from this same line.
