INTRODUCTION

From: Oliver Johnson DENOMINATIONAL BACKGROUND

The Associate Reformed Presbyterian denomination developed from the Church of Scotland. The first part of the name, "Associate," denotes our ancestry from the Associate Presbytery, which was organized at Gairney Bridge, near Kinross, Scotland, on December 6, 1733. The second part of the name, "Reformed," denotes our ancestry from the Reformed Presbytery, organized in Scotland, in 1743, by the Covenanters. The "Presbyterian" in the name of our denomination indicates the form of church government under which we operate. Presbyterian form of government is government by presbyters, who are representatives of the congregation, called elders. Elders are called "Ruling elders" and the pastor is the "Teaching elder." The elders comprise the session, which is the local church court. The Presbytery, comprised of churches in a certain geographic area, is a higher court; and the Synod is the highest court of the denomination.

Early settlers of Pennsylvania and New York, coming from Associate churches in Scotland and Northern Ireland, organized the Associate Presbytery of Pennsylvania, in November, 1753, and the Associate Presbytery of New York, in 1776. The first Associate ministers to come to America were Alexander Gellatly and Andrew Arnot. By the time of the American Revolution, there were 13 Associate ministers in the colonies. Members of the Associate Church were called "Seceders" because of the secession from the Scottish National Church, which was led by Ebenezer Erskine, Alexander Moncrief, William Wilson, and James Fisher. These pastors had been deposed by the Church of Scotland for preaching against abuses in the Church, one of which was patronage, the custom in Scotland by which the large landowner, "the patron," had the privilege of choosing the pastor for his parish. In other words, the members of the Church of Scotland were denied the right to elect their own pastors. The other abuse was a doctrinal one. The seceding pastors believed "that the sinner is not justified on account of obedience to the law, but by faith in Jesus Christ. The ground of the sinner's pardon and justification is the obedience and suffering of the Lamb of God."<sup>1</sup>

Reformed ministers, the Covenanters, had come to America as early as 1685, settling in New Jersey, Pennsylvania, the New England States and, some years later, in South Carolina. The first Reformed minister in America was John Cuthbertson, who came



in 1752. He was followed in 1774 by Matthew Linn and Alexander Dobbin who were sent to this country by the Presbytery of Ireland. These three ministers constituted the Reformed Presbytery of North America. The Covenanters for many years had dissented from the Church of Scotland and had suffered severe persecutions. They had organized themselves into societies.

At the time of the historic meeting for the organization of the Associate Reformed Presbyterian Church, on November 1, 1782, in Philadelphia, Pa., there were 14 ministers and 6 elders present. There were two ministers of the Associate Presbytery of Pennsylvania who remained outside the union of 1782, and they apparently revitalized the Associate Church through competition with the newly formed A.R.P. Church.<sup>2</sup> The distinguishing feature of the Associate Reformed Church was that she was "supposed to be thoroughly Scottish in Her character and traditions, whereas the General Assembly Presbyterians formed a mixture of Scottish, English and Congregationalist Presbyterians."<sup>3</sup>

There were also Reformed ministers (Covenanters) who did not enter the A.R.P. Church in 1782. In Philadelphia, in 1798, the Reformed Presbytery of U.S. of North America was formed, and its Synod was organized in 1809. In the Carolinas there were Covenanters who had churches; in Southeast Chester County there were several Covenanter (Reformed) ministers and thriving congregations. Rev. William Martin was the first Covenanter minister who came to S.C. from Ireland in 1772. He lived on the north side of Big Rocky Creek in Chester County. Because of his anti-British sermons he was arrested during the Revolutionary War by the British. He was jailed at Rocky Mount and at Camden and was tried by Lord Cornwallis in Winnsboro, in 1780.

When Lord Cornwallis reprimanded Rev. Martin for "preaching rebellion from the pulpit," the old man replied, "For many months I have been held in chains for preaching what I believe to be the truth. As to King George, I owe him nothing but goodwill. I am not unacquainted with his private character. I was raised in Scotland; educated in its literary and theological schools; was settled in Ireland, where I spent the prime of my days, and emigrated to this country seven years ago. As a king, he was bound to protect his subjects in the enjoyment of their rights. Protection and allegiance go together, and where the one fails, the other cannot be exacted. The Declaration of Independence is but a reiteration of what our Covenanting fathers have always maintained. I am thankful you have given me liberty to speak, and will abide your pleasure, whatever it may be."<sup>4</sup> He was pardoned and released and continued his preaching at Mt. Olivet and Jackson Creek Churches in Fairfield County, and at Richmond Meeting

The old Covenanters objected to the government of the United States in that "there is no acknowledgement of God or the Christian religion in its Constitution; also that it upheld slavery; that it admits men to office by swearing or affirming, without the name of God."<sup>6</sup> They were strenuous advocates of an inspired Psalmody. They refused to commune with other denominations. The strict Covenanter refused to serve on juries or to hold civil office.

In 1803, the Associate Reformed Synod of the Carolinas was organized at Ebenezer Meeting House on Little River in Fairfield County, South Carolina. This Synod, with the Synods of Pennsylvania, New York and Scioto, organized the General Synod in 1804, with headquarters in Philadelphia. Each Synod became independent, and in 1822 the Synod of the Carolinas, which had grown beyond the Carolinas, became the Synod of the South.

In 1858, the Northern Synods joined to form the United Presbyterian Church, which in 1968 merged with the Presbyterian Church, U.S.A., to become the United Presbyterian Church, U.S.A. Thus the Synod of the South was the remaining organization of the Associate Reformed Presbyterian Church, which had been in existence since 1782 and which had been composed of four synods at one time.

When the A.R.P. Synod of 1903 met in Winnsboro, S.C., at Bethel A.R.P. Church, it was designated "the Centennial Synod," and it commemorated the organization of the Synod of the Carolinas, which had occurred 100 years earlier at Ebenezer Meeting House, later called The Brick Church. This was not an anniversary of the founding of the denomination; that had taken place 121 years before in Pennsylvania. The event which happened at the Brick Church was the birth of a synod, the southern part of the denomination, which, with three other synods, Pennsylvania, New York, and Scioto, comprised the denomination which was called Associate Reformed Presbyterian.

The denomination today consists of churches in South Carolina, North Carolina, Florida, Mississippi, Tennessee, Missouri, Arkansas, Kentucky, Georgia, Alabama, Virginia, West Virginia and New York. Strong National churches are growing in Mexico and Pakistan where our missionary efforts are being successfully expanded.

Erskine College and Seminary, the first full-fledged denominational school in South Carolina, is continuing to produce ministers and leaders of quality for the ongoing extension of that branch of Christ's Church known as Associate Reformed Presbyterian.

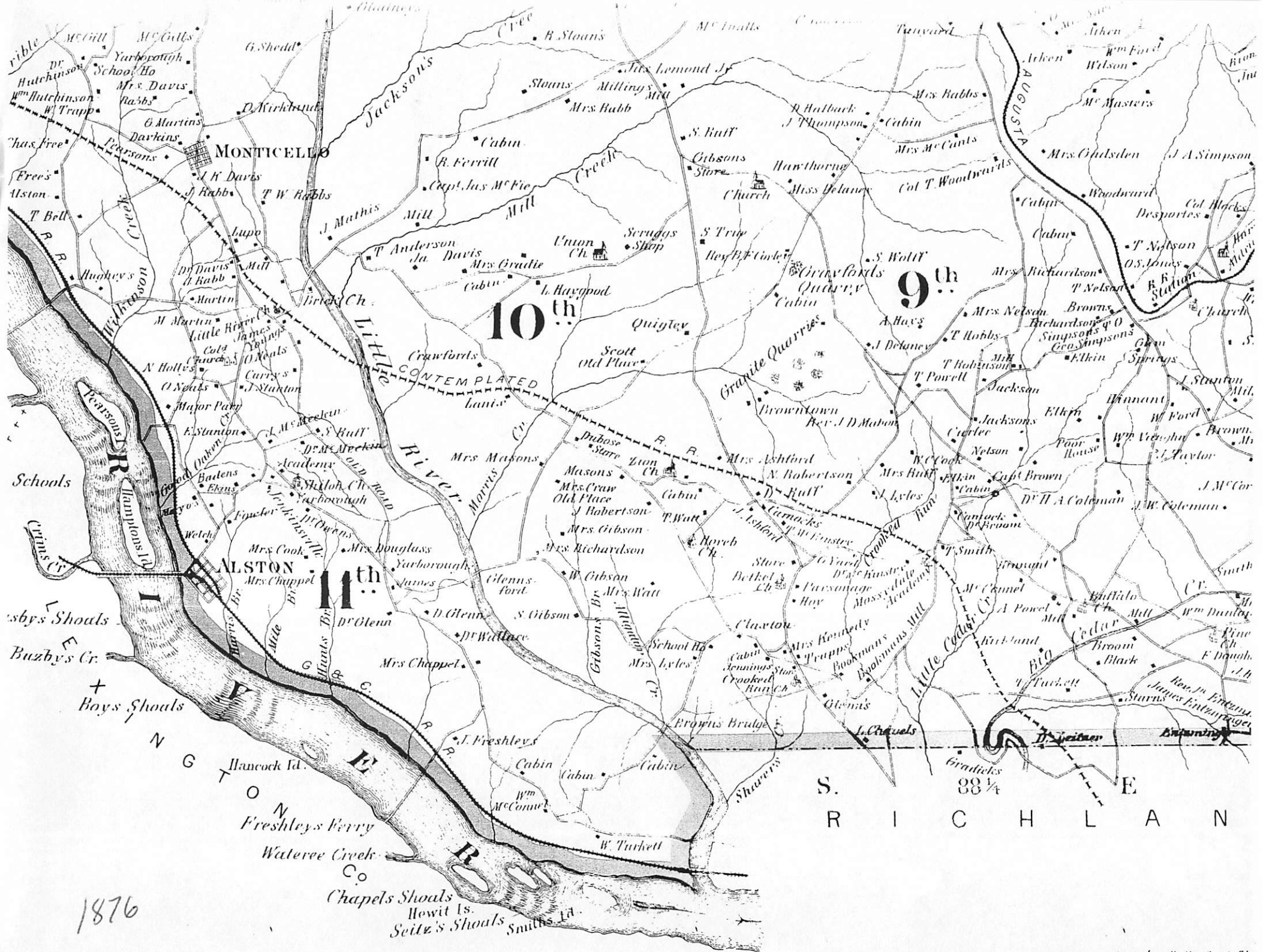

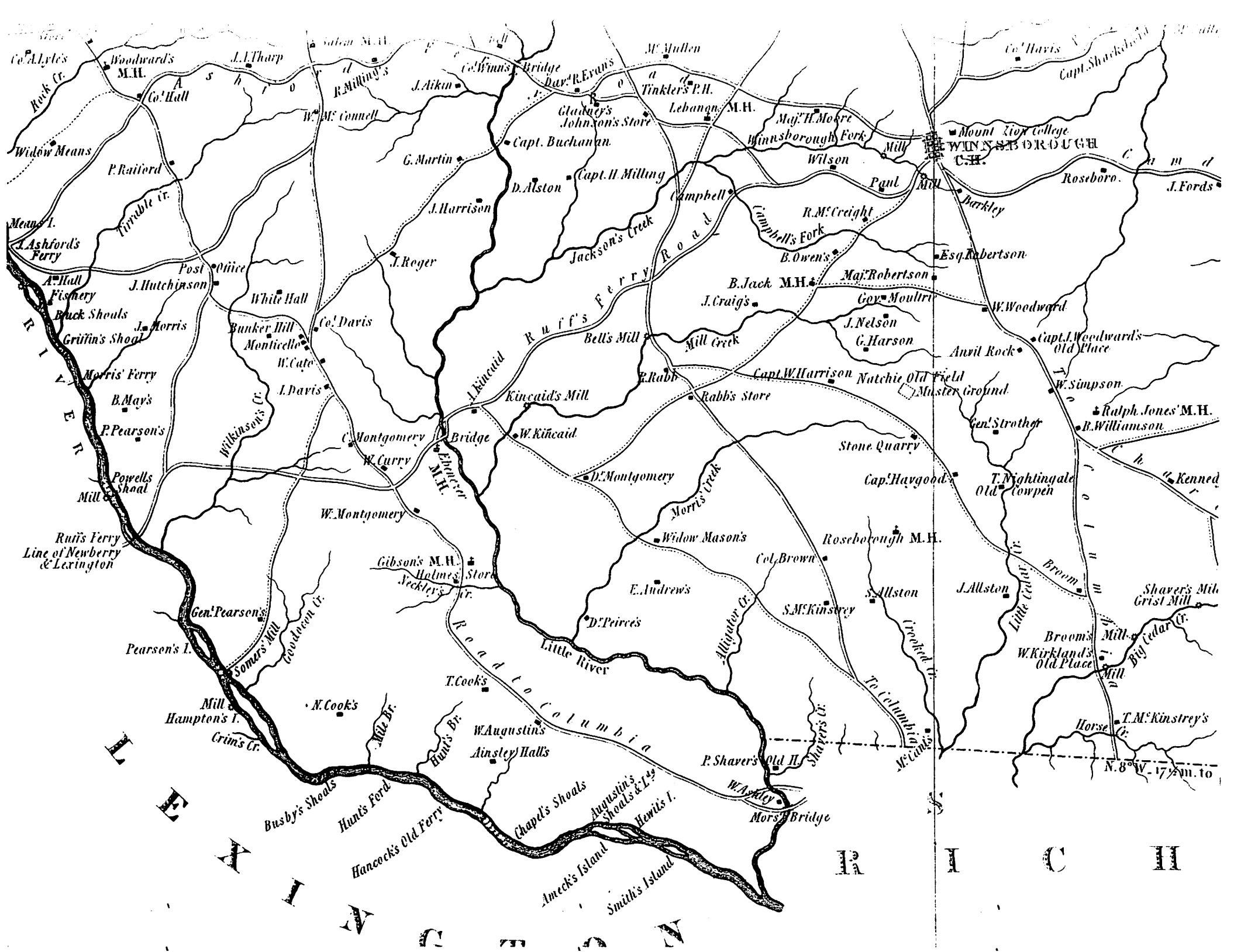

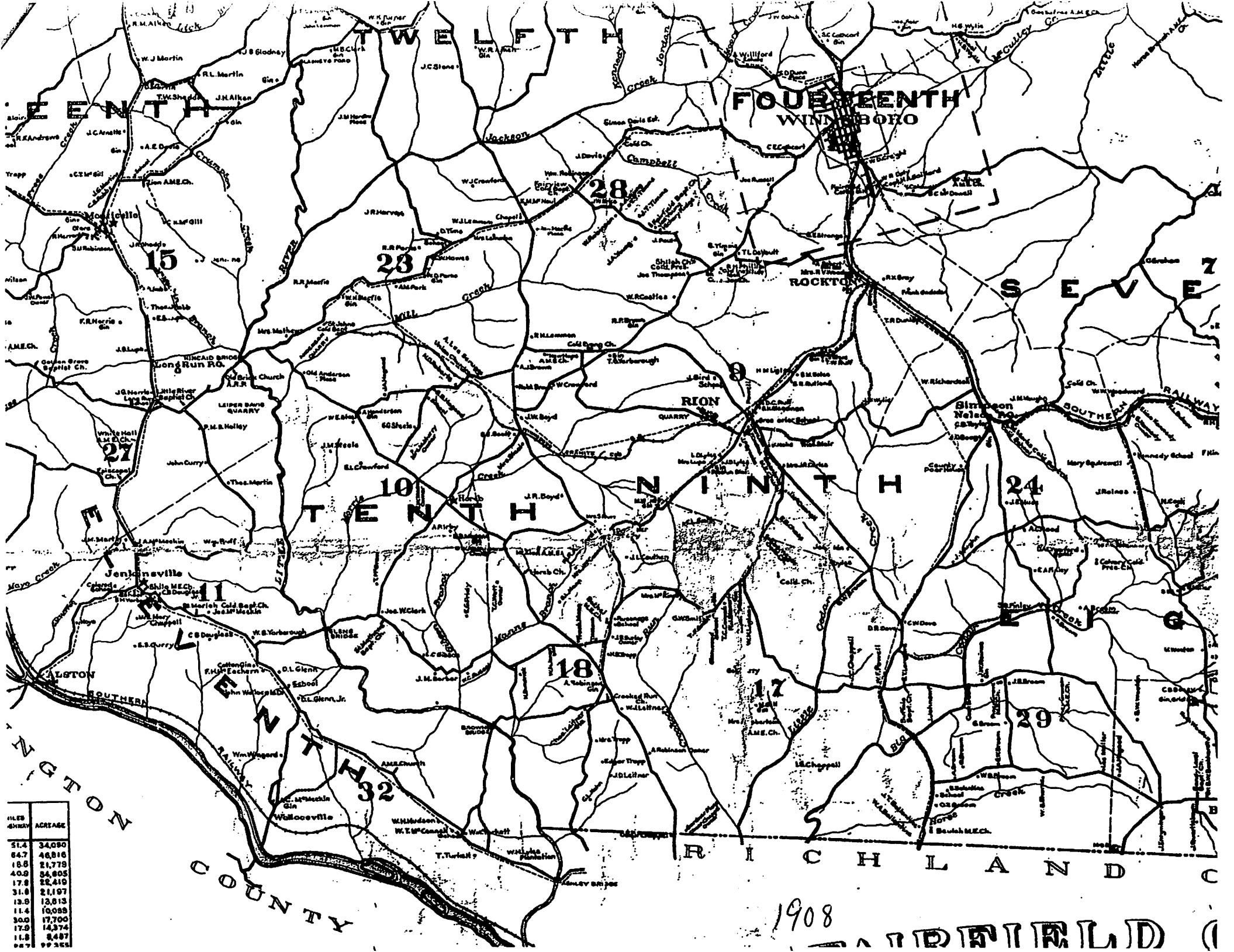
