of our Lord 1791 and containing acres

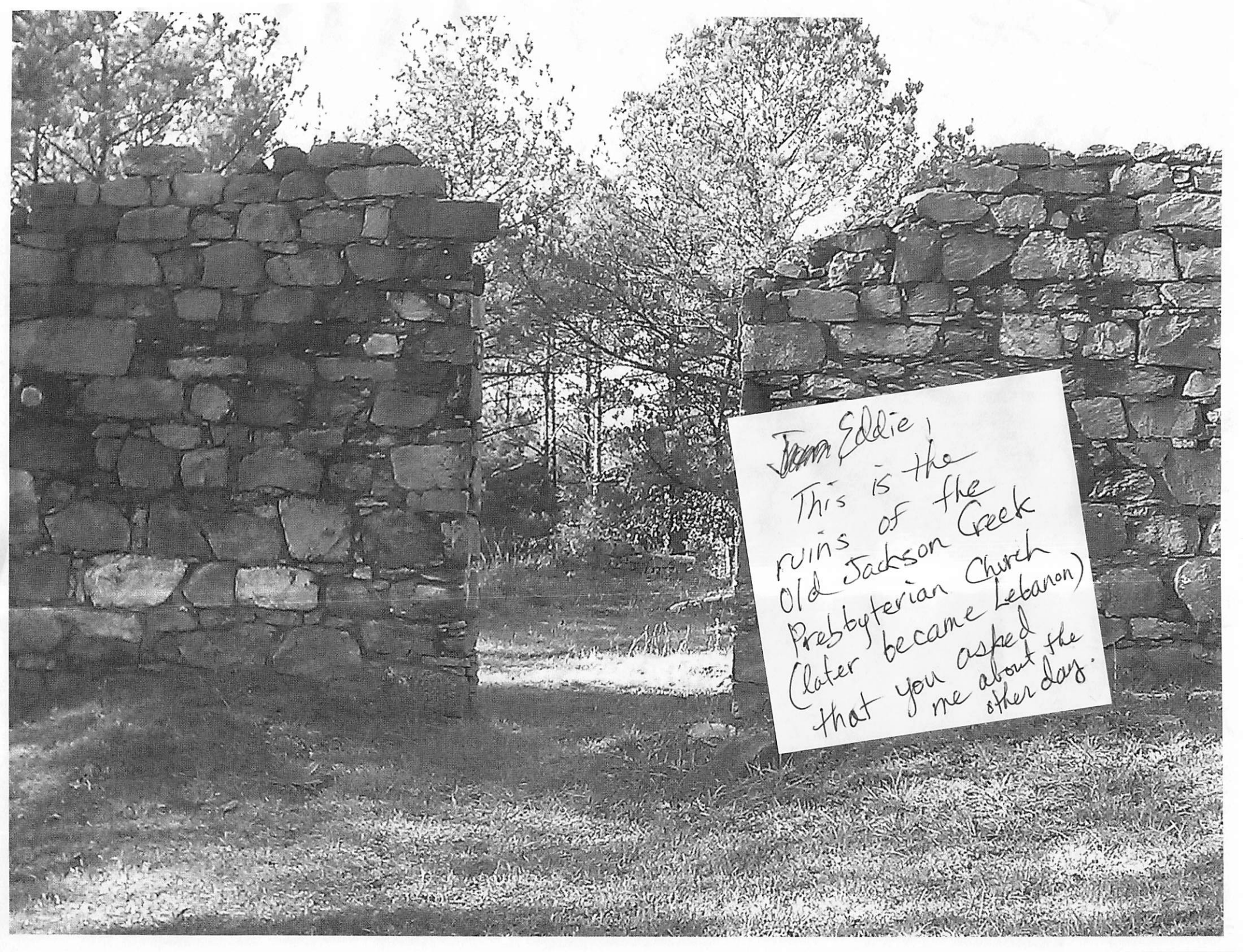
