The "handed down" story is that he came from North Ireland or Scotland to South Carolina and lived in Fairfield or Chester County until about 1839 when he moved to Snapping Shoals in Newton County, He married GRIZZELLAH (GRIZZIE) WELDON, daughter of SAMUEL WELDON and AGNES ARNET WELDON, and had 7 daughters and 2 sons. The all lived in Fairfield or Chester County and all moved to Snapping Shoals, Newton County, Georgia around 1839. They were ARP Presbyterians and members of Hopewell ARP Presbyterian Church at Snapping Shoals in Newton County, Georgia. JOHN WILLIAM AIKEN was born in 1765 and died in 1853 in Newton County, Georgia. This sis the 'handed down" story so I don't know how much of it is true. Some members of my family have previously identified JOHN WILLIAM AIKEN as being the son of JAMES and ELIZABETH REID AIKEN; however, I believe this is incorrect as the JOHN AIKEN who was the son of JAMES and ELIZABETH REID AIKEN died in 1835 in South Carolina. My purpose is to find out anything that will help me in determining the true heritage and ancestry of JOHN WILLIAM AIKEN.
