Anderson, Susannah A. Box 7 #88. Probate Judge Office. Pickens, S.C. I Susannah Anderson of Pickens Dist. being of sound and disposing mind and memory, but weak in body.. I give to my mother Fanny Knox all the ready money in my possession and what is owing to me, except one debt owed by my brother Isaac Knox which I give him. I also give to my mother Fanny Knox, my negro girl Frances to be enjoyed during her lifetime, at her death, I wish said negro be appraised, and my sister Sarah McClure to pay my brother William Knox one half of the appraisment and give the said negro to his (her) daughter Susan. I give to my brother Samuel Knox one feather bed. I give to Susan Dendy one feather bed.. I give to my sister Mary Knox all my bed furniture. I appoint my brother Samuel Knox and James H. Dendy my executors. Dated this 2 June 1837. Wit.: Geo. W. Liddele, Mary A. Knox, Rebecca C. Liddell. Signed Susan Anderson, seal. Susan A. Anderson. Recorded the 4 Sept. 1837..by James H. Dendy, O.P.D.

ASHWORTH

Ashworth, John. Land Grant Court. Elbert County, Ga. A land Court held at Elberton on Tuesday the 5 Jan. 1836. Present John Nunnelee, Benjamin Winn, Lindsay H. Smith Esqs. issued a warrant to John Ashworth for 50 acres in full of his head rights now proven.

ATWELL

Atwell, Joseph. Will Bundle DDD 33. Probate Judge Office. Charleston, S.C. I Joseph Attwell Senr. of James Island in Berkley County, carpenter, being sick and weak in body, but of sound and perfect mind and memory. I will and ordaine that all debts as I owe be justly and honestly paid.. I give to my sons Joseph and Benjamin Atwell all my plantation lands, houses, stock of cattle, swine, sheep and one Indian woman called Mareah, each to have one bed and furniture to be equal divided between them.. I give to my dtr. Mary Atwell one Mahaw boy slave named Boat-swain.. I give to my dtr. Abigale Atwell one Mahaw boy slave named Tom to her heirs forever.. I will the remains of my estate to be equally divided among my chn. to wit. Joseph, Benjamin, Mary, Abigale Atwell.. I appoint my friend Samuel Scriven, and John Brown executors.. Witter..
