1. JOHN ARNETT

North Carolina & South Carolina Service of JOHN ARNETT
PENSION NR. 31,527

John Arnett was born June 20, 1760, place not stated. While a resident of ANSON COUNTY, NORTH CAROLINA, he enlisted July 1776 or 1777, and served 3 months as Private in Capt. John Culpepper's Company in Colonel David Love's North Carolina Regiment. He went on an expedition against the Cherokee Indians and aided in burning the Hiwassee and Valley Towns. While living in Chesterfield, South Carolina he enlisted April 1779 and served 3 Months as Private in Capt. McManis' Company in Col. Hicks' South Carolina Regiment.

He was allowed pension on his application executed May 6, 1833, at which time he was a resident of Decatur County, Georgia, having previously lived in Screven County, Georgia.

In 1833 his brother, WILLIAM ARNETT was living in Screven County, Ga.

If the reader desires a search made for the Final Payment papers of JOHN ARNETT, they should write to this compiler and quote: Certificate No. 16486, Issued Aug 27, 1833, at rate of \$20.00 per annum, commenced March 4, 1831, under Act June 7, 1832 at the Georgia Agency. Pension # S-31527.**

When he applied in Screven County, Ga., 1833, stating he was a resident of Decatur County, Ga., he stated he served as a drafted soldier in Anson County, North Carolina under John Culpepper, Captain; David Love, Colonel & George Davidson, was marched against the Cherokee Indians, served 3 months and discharged at Pleasant Gardens, North Carolina. He was born 1760, June 20.

In tours of duty he marched thru North Carolina to Cherokee Nation, crossed the Catawea River at Beaty's Ford, crossed the Blue Ridge at what was then call the Narrow Passage. He knew General Rutherford, who was the General in Command, and Capt. Hawthorn, Captain Speed, Captain Robertson, Captain Hay of Colonel Love's Regiment, which he served 3 monthask in ;the Cherokee expedition, he was at the Hiwassee Towns, which was burnt and the corn destroyed, was also at the Valley Towns and destroyed them.

Following from letter either by or for John Arnett:
State of Georgia, Screven County
May 6, 1833

JOHN ARNETT, resident at present of Decatur County, Ga. but for last 30 years resident of Screven County, Ga. Age 72. Entered Service July 1776 as drafted Soldier in Anson County, NC under John Culpepper, Captain; David Love, Colonel; Geo. Davidson, Major; was marched against the Cheorkee Indians, was in no battle, served 3 months, discharged at Pleasant Gardens, N. C.

April 1779 in service again as a Volunties, at Chesterfield, S.C., under Capt. McMains, served 3 months. Discharged Camden, S. C. That his brother WILLIAM ARNETT of Screven County, Georgia will prove the Service of this applicant. That he was born in the year 1760, 20th June. WILLIAM ARNETT, age 66 (in 1833).

4. JOHN ARNETT

TO: JOHN OWENS

This indenture made this ninth day of January in the year of our Lord One Thousand Eight Hundred & Twenty fourth and Twenty fifth of American Independence between JOHN ARNETT of the County of Anson and State of North Carolina of the one part and JOHN OWENS of the County & State aforesaid of the other part. Witnesseth that for and in consideration of the sum of fifty pounds currency of said State paid to the said JOHN ARNETT by him the said JOHN OWENS before the Sealing and Delivering of these presents, the receipt & payment whereof is hereby acknowledged, hath granted bargained sold conveyed & confirmed and by these presents doth grant bargain sell convey & confirm unto him the said JOHN OWENS his heirs Executors administrators & assigns forever one certain tract or parcel of land lying on both waters of CRIBBS CREEK beginning at a red oak on the bank of said Creek in THOMAS PRESSLERS line and runs North 32 East 14 chains 25 links to a stake in ARTHUR DAVIS'S line then North 60 West 17 chains & 50 links to a red oak then South 82 West 35 chains to a stake thence South 30 East 33 chains to a White oak in said PRESSLERS line thence with said line North 58 East 28 chains to said PRESSLERS corner stake with a red oak & post oak pointers thence to the beginning - Entered the 20 of November 1795 as of Plat. Together with all woods waters mines minerals here _____ and appurtenances to the said land belonging or appertaining to hold to the said JOHN OWENS his heirs and assigns forever without the least molestation or any lawful interuption whatever and him the said JOHN ARNETT doth for himself his heirs Exes. & adm'. forever warrant and defend the above discribed land & primases unto the said JOHN OWENS his heirs & assigns forever agreeable to the intent and true meaning of these. In witness whereof the said JOHN ARNETT hath hereunto set his hand & seal the day and year first above written
