## ARLEDGE

The earliest record that I have located on anyone by the name of Arledge being in South Carolina is 1768 where Abel, Isaac, and William Arledge were property owners. Isaac owned 500 acres by the end of the year shown to be in Craven County, on Waters of Peedee, and Waters of Edisto. Abel owned 400 acres in Craven County, Waters of Broad River, and William Arledge owned 500 acres in Craven County and on the "waters thereof." The name is spelled Akridge, Alridge, Alderage in these early records.

This line has been traced back to William Arledge who left a will which is filed in Apt. 3, Pck 68 in Camden District, South Carolina. Joseph Arledge applied for administration August 6, 1784. Joseph Arledge, Isaac Arledge and Clement Arledge received 3000 lbs. sterling August 18, 1784. Amos Arledge was a witness. The relationship of Amos to this family is unknown. The record does not show if there were any daughters, nor is mention made of a wife. The line will be traced through the son Isaac.

## ISAAC ARLEDGE, SR.

Isaac Arledge, Sr., died November, 1790, Fairfield Co., S.C. His wife was named Anna. They had the following children:
