





LAST WILL AND TESTAMENT) State of South Carolina. In the
 MARY BAIRD deceased : name of God Amen. I Mary Baird of
 -----) the district of Abbeville being
 sick and weak in Body but of a sound
 & disposing mind memory & understanding thanks be to God for the
 same do make this my last will & Testament in manner following.
 First I give & bequeath to my daughter Rebecca Rowe one Negro
 Girl named Incky at the death of my second daughter the Girl &
 her increase to go to her children. I give & bequeath to my son
 James R. Baird the tract of land that I purchased of John Hamil-
 ton adjoining the tract of land I now live on. Also one half of
 all the cash that may be in my possession at my death Third I
 give & bequeath to my son William P. Raiford four beds & furni-
 ture Kitchen furniture & all my household furniture & all my
 horses that is not given away also one half of all the Cash that
 I may die possessed of also is my Will that whatever Corn & fod-
 der or other produce & plantation tools that I may have at the
 time of my death is to be equally divided between my two sons
 William P. Raiford & James R. Baird. Fourthly I give & bequeath
 to my grandson John M. Raiford one sorrel Colt Fifthly I giv
 & bequeath to my Grandson John Bötts Baird one sorrel Colt two
 years old 6th I give & bequeath to my Grand daughter Luiza Baird
 all my Clothes & one bed & furniture also I give to grand daugh-
 ter Mary Baird one bed & furniture. 7th and lastly I do hereby
 nominate, constitute and appoint my two sons Wm. P. Raiford &
 James R. Baird my Executors to this my last Will & Testament.
 In Witness whereof I the said Mary Baird have hereunto set my
 hand & seal this fourth teenth day of April in the year of our
 Lord one thousand eight hundred & eighteen-signed sealed & pub-
 lished by the above named Mary Baird as& for her last Will & Tes-
 tament in the presence of us who at her request have subscribed
 our names as Witnesses thereto. Witnesses
