- (2) "Among early settlers on Beaver Creek and McClures Creek (S.C.) were ---BEAM, ----.". From Edrington's History of Fairfield County, S.C.

- (3) Plat for 100a. land surveyed 25 Apr 1767 on Bowers Mill Creek of Broad River adjacent to William Hill and Richard Walker --- Albert did not take this land. From Leonardo Andrea Collection, Item 3.
- (4) A memorial tax return made in Charleston B May 1771 for 200a. land on Beaver Creek of Broad River by vacant land and land of William Hart. From Leonardo Andrea Collection, Item 5.
- (5) A memorial tax return made in Charleston 12 Dec 1774 for 50a. land on Sandy Fork of Broad River at Beaver Creek adjacent to lands of Mr. Minnick and Michael Miller and vacant land and it being part of an original grant to Samuel Moberley dated 10 Jun 1766 and sold to Albert Beam by deed dated 11 Feb 1774. - (9) U.S. 1790 census, Fairfield District, Camden County, S.C. shows Albert Beam as head of household with 2 Males over 16, 2 males under 16 and 5 females. This is no doubt the early Albert.
- (10) Heirs of Albert Beam (His grandchildren Ferdinan Beam, Edith Beam, Nancy (Beam) Coleman and her husband David Coleman) sell for \$250 all their rights to the estate of their grandfather, Albert Beam, to Robert Fitz Coleman. The document also names Albert Beam's children as "sons John, Jesse, Albert and William as well as daughters, Edith Coleman, Mary Coleman, Sarah Coleman and Dorcus Beam" and "Elijah Beam who died before his father". Elijah was father of Ferdinan, Edith and Nancy (above). This deed recorded Fairfield Co., S.C. Deed Book Y, pp.326 to 328. Deed dated 7 Jan 1817, Recorded 14 Apr 1817.

- (1) Most of this information from "THE EARLY HALSELL FAMILY OF SOUTH CAROLINA" compiled by Cyrus Happy and is on microfilm at LDS Library, SLC.
- (2) Thomas HALSELL #2 was born by 1721, if at least 21 years of age when he signed a petition with the MOBBERLYs and John TURNER in 1742 in Prince George County, Maryland, that part which is now in Frederick County, MD.
- (3) He was taxed in Lunenburg County, Virginia (Now Bedford County) with the MOBBERLYs, John Turner, the HILLs and the MEADORs.
- (4) A Thomas HALSEY received a S.C. Memorial (Grant) of 100 acres in Craven County on the north branch of Little River, called Bower's Mill Creek on 25 Sept 1766. This is about the same time and area where the MOBBERLYs, HILLs, TURNERs, MEADORS and Albert BEAM received their Land Memorials.
- Note: It is not proved but dates, ages, etc. would seem to indicate this Thomas HALSELL is the father of the Sarah HALSELL who was married to Albert BEAM.
