Ezekiel Beam. John Beam and Turner Beam my Sons Sarah Dye Ann Widener and Margaret Widener my daughters. Share and share alike

And that if either of the aforesaid children should die before they come of full age their share of said Estate be Equally divided amongst the survivors. Disannulling all former Wills by me heretofore made. Declaring this to be my last Will. In Testimony whereof I have set my hand and seal in presence of as December 13th 1819
