his to Collect all my Debts & Discharge all my Creditors.——
Lastly. I Likewise Costitute make and ordern my sons James
à filliam Blair to be the sols Executors of this my Last will
& testament and I De hereby utterly Dissillow Revoke and Disannul all & Every other former testament wills Legecies Bequests & Executors by me in any ways before maned willed & bequests & Executors by me in any ways before maned willed & bequested Ratifying & Confirming this and No other to be my Last
will & testament in witness Whereof I Have berequite set my hand
& seal this Courteenth Day of September in the year of our






BLAIR, PATRICK, PLAT FOR 100 ACRES IN CRAVEN COUNTY.




BLAIR, THOMAS, PLAT FOR 100 ACRES IN CRAVEN COUNTY.






