He is recorded in Spottslvania records as being there, later moved to Essex Co. and from there to N.C. and thence to S.C. in Ninety Six Dist.
- 2. Nancy Goggans' was a daughter of Daniel Goggans and Nancy Williams. The Goggans were first found in Richmond Co., Va., moved to Culpeper Co. Va. in 1750 and to S. C. in August 1766.
- 3. Elizabeth Boulware is buried in the Boulware Cem. in close proximity of the Daniel Goggans Cem. on Goggans Branch, Little River, S. C. (now Newberry Co.)
