Dear Mr. Beach,



Will of Agness BOYD, Vol. 2, Book 12, p. 1. Son: Samuel, John; dau: Margaret as long as they remain unmarried; son Hugh 1 dollar; Andrew 1 dollar; David 1 dollar; John and Samuel, executors - 30 March 1829.
