



About four miles north of Chambersburg is one of the beautiful springs of Cumberland Valley, at which the pioneer Presbyterian settlers were wont to assemble for the worship of God. The early history of this church is wrapped in a great deal of obscurity. It is generally agreed that its organization occurred about 1739. That was a period of intense excitement in the Presbyterian church on questions concerning the Old and New Side controversy, and which culminated the following year in the rending of the church. In some instances in the Presbytery of Donegal complete division occurred in congregations; in other: entire congregations arrayed themselves on one side or the other. Rocky Spring church belonged to the latter class. It and Middle Spring and Big Spring, occupying contiguous territory, all identified themselves with the New Side branch of the church, and in 1742 secured the services of the Rev. John Blair. Mr. Blair was a member of the Presbytery of New Castle (New Side). Thus it occurs that in the records of the Presbytery of Donegal we do not find any mention of him or his churches during his pastorate, which extended, presumably, to 1755. (See Big Spring church, foot-note.) For a number of years after this the church was dependent upon supplies appointed by Presbytery. In 1768 the Rev. John Craighead became their second pastor. He was not only an eloquent preacher of the gospel, but also a zealous patriot and a fearless soldier. In the Revolutionary struggle he marched at the head of a company raised by himself in his own congregation, and joined the army of Washington. Here he did not forget his high calling as an ambassador for Christ, but when in camp acted as chaplain to the soldiers. The history of old Rocky Spring church in connection with the Indian troubles and Revolutionary war is full of thrilling interest. But we may not enter upon it here.

Their first "meeting-house" was a small log building, erected in 1740, which stood near the site of the present church. It soon proved too small for the congregation. To remedy this "a small square building was attached to the south side of the church, extending one-half its length, and the roof was extended from the main building over it. There were no windows in this addition. Hence it was poorly lighted and ventilated. Subsequently an addition of like character was put to the end of this. In this way a lop-sided appearance was given to the structure. The present brick building was erected in 1794. It remains almost intact, an object of mingled interest and curiosity. In the chapter on church property" will be found a description of it. It remains, but its aisles are no longer crowded with devout worshipers. Time and change have done their sad work. The descendants of the original settlers have passed away, seeking homes and helping to build up churches elsewhere; and other people of other faith have come in to occupy

their farms and their places in the community.

Rev. John Craighead was the pastor of Rocky Spring Church (1768-1799), at the time of John Boyd's death. It is interesting to learn that Rev. John Craighead purchased a tract of land called the "parsonage" on July 31, 1769 from Samuel Boyd, younger brother of John Boyd, who moved about that time to Charlotte County, Va. (See Chapter II.)

The parsonage was located about $1\frac{1}{2}$ miles from Rocky Spring church. John Boyd served in the Bouquet expedition of 1764. In an article appearing in the Somerset Co., N.J. Historical Quarterly (Vol. 7, Pages 280-284) concerning the life of Rev. William Boyd, son of John and Mary, "John Boyd is said to have been born at Irvine, Scotland, but married in Ireland and, about or prior to 1750, removed to Franklin Co., Pa., (Cumberland Co. at that time), where he was doubtless a farmer." On May 24, 1753, a land warrant for 200 acres was surveyed for John Boyd (Ref. Pa. Archives Land Warrants 1750-1874 - A (3) XXIV, p. 632 - Co. of Cumberland). Tax lists for Cumberland Co., Pa. list John Boyd for the years 1751, 1753 in Lurgan Township and later years 1763, 1764 in Letterkenny Township. (Ref. Historical Society Library, Carlisle, Pa.)(Letterkenny Township was formed from Lurgan Township in the year 1761-1762). Children of John and Mary (Ref. Letterkenny Township Cumberland County, Pa.

Last Will and Testament of JOHN BOYD, late of Letterkenny Township, Cumberland County, Penna., deceased... Will No. 9, Recorded in Will Book "B", page 47 —Will Proven in Register's Office April 25, 1770.

IN THE NAME OF GOD, AMEN! in the Seventh day of July in the year of our Lord 1769, I, John Boyd of Letterkenny Township, Cumberland County, being sick in body but of perfect mind and memory and calling to mind the mortality of my body and knowing that it is appointed for all men once to die do make and ordain this my last will and testament that is to say:

First of all I give and recommend my Soul to the hands of God that gave it and for my body I recommend it to the earth to be buried in a Christian and decent manner at the discretion of my Executors.

And as touching such worldly estate as it hath pleased God to give me in this life, I give, devise and dispose of the same in the manner and form following:

In the first place I give and bequeath to my beloved wife, Mary the one third of the yearly profits arising from my plantation during her natural life while she remains single but if she marries I alow and order one horse and saddle the horse to be valued to ten pounds, also one feather bed with suitable furniture belonging thereto with her clothing.

Also I give to my daughter Elizabeth Boyd the sum of fifty pounds to be payd to her in cash and goods which goods I alow to be taken of my personall estate first of all before any division be made to the other legatees.

Also I order and allow in part the income and profits arising yearly from my plantation to be appropriated and for the use of my younger children in order to their maintenance and education until the time they come of age.

I likewise give and bequeath to my son James Boyd one sixth part of my lands and improvements I now possess to be divided equally into quantity and quality after payment of all first debts due upon the estate.

I give and order to the said James a two child's part of all my moveables.

Next I give and bequeath to my son Robert Boyd a one sixth part of my lands in quantity and quality also I give to him a one child's part of all my moveables. Next I give to my son William Boyd one sixth part of my lands and likewise I

give to him one child's part all my moveables.

Next I give to my son Samuel Boyd one sixth part of all my lands and also a

child's part of all my moveables.

Next I give to my son John Boyd one sixth part of all my lands in quantity and

quality and also I give to him one child's part of all my moveables. Next I give to my son Thomas Boyd the one sixth part of all my lands to be divided according to quantity and quality and also one child's part of my moveables.

I do also constitute and ordain my wife Mary and my son James Boyd my only and sole Executors of this my last Will and Testament and I do hereby utterly disannull all former Wills and Testaments by me at any time made and I do hereby ratify and confirm this and no other.

IN WITNESS WHEREOF I have hereunto set my hand and seal the day and year above

The above will was signed July 7, 1769 - Proven April 25, 1770. John Boyd signed his name to said will. Inventory filed June 14, 1770 - No. 23.

Following John Boyd's death, orphan court records show the following:

Page 205 - Orphan's Court held at Carlisle County of Cumberland (in year circa 1770) appeared Samuel Boyd minor son of John Boyd late of Letterkenny twp. and asked the Court to appoint a Guardian over his person and estates, he Samuel being a minor over the age of 14 years. Court appointed Alexander McConnel as his Guardian.

At the same Court appeared Mary Boyd the widow and relict of John Boyd late of Letterkenny township and prayed the Court to appoint a Guardian over her sons their persons and estates, John Boyd and Thomas Boyd (who were minors under age 14 to have mother appear for them). Court appointed Samuel Culberson (Culbertson) of Letterkenny

township Guardian. June 8, 1781 John Boyd, son of John Boyd, deceased, aged about 18 years prayed the Court to appoint Alexander McConnell of Hamilton (later Franklin County) as his Guardian. Court made the appointment.

Searching for gravestone records of the Boyd family, the following is found in the Rocky Spring Presbyterian churchyard, which is situated in the section not far removed from the Boyd home in Letterkenny township.

The grave inscriptions occur in a "History of the Churches of the Valley" (Cumberland) published in 1852 by the Rev. Alfred Nevin. This Church is now well cared for by the Franklin County Chapter DAR. The tombstones read as follows:

"In memory of John Boyd, who departed this life in the year 1770." "In memory of Mary Cummins who departed this life on Nov. 9th, 1790, age 17 years." "In memory of Elizabeth, wife of Charles Cummins, who departed this life 9th Sept.

1802 - aged 54 years." (b. 1748).
"The author says: "these last three graves stand side by side and contain members of the same family. Near the latter is another old stone of the same kind and upon which the following words appear -"In memory of Mary, wife of John Boyd, who died June 30,

"In Memory of Elizabeth Cummins who died Dec. 30, 1792, aged 12 years."

Wife, Agnes; Children James, Agnes, John, Mary Morrow, William. (Bk. "C" p. 591. Franklin Co., Pa.).

James is shown a member of Rocky Spring Presbyterian Church, holding Pew #21 in the brick church at the Commencement of Rev. Francis Herron's ministry in 1800.

Another item of interest found in the Franklin Co. records - Bk. 2, Page 178 -11-12-1789 - James and Agnes Boyd of Franklin sold to John Slaighton for 241 lbs, 13 sh. & 9 Pence - 60 acres and 88 perches -Witnesses John Scott & Robert Boyd. In all probability this is James' brother, Robert, who was in Chester Co., S.C. 3 years later.

Bk. 1, Page 331 - "This indenture made 29 Apr. 1786 between John Boyd, student one of the heirs and devises of John Boyd late of Letterkenny Township, then Cumberland Co, Now Franklin -State of Pa. - to James Boyd of said township - for 310 lbs., 10 sh., p'd by James - sells land which formerly was the property of John Boyd the father which he bequeathed to his son John —the said parcel being in full of an undivided right or 6th part of all the real estate of John Boyd my father deceased - containing 115 acres."

III. ROBERT BOYD (1755-Mar. 1812), son of John & Mary Boyd of Cumberland Co., Pa., moved to Chester County, South Carolina, as proven by the following Power of Attorney —

To all people whom it may concern, Robert Boyd of the State of South Carolina, County of Chester, sendeth Greetings. Whereas the said Robert Boyd is seized in fee simple by the death of his brother, Samuel Boyd, late of Franklin County, of Pennsylvania of a Messuage Tenement of parcel of land lying and situate in the county of Franklin in the state of Pennsylvania, being one sixth part of a tract of land of which the said Samuel Boyd, deceased, was seized and possessed of land lying and situate in Franklin County in the State of Pennsylvania, as aforesaid. Now, know ye that the said Robert Boyd doth by these presents constitute, authorize and convey to the Reverend John Boyd, formerly of Franklin County, and State of Pennsylvania to sell, grant or convey the said messuage or tenement land and premises in fee simple to such person or persons for such price or sum of money as he shall think convenient and also for him the said Robert Boyd and in his name to sell, execute and deliver such Deeds and Conveyances, Bargains and sales for the absolute sale and disposal thereof or any part thereof with such clauses, Covenants and agreements therein be contained as the said John Boyd shall think fit and expedient hereby ratifying and confirming all such Deeds, Bargains, sales and other Conveyances which shall at another time hereafter be made, sealed, executed, and delivered by him the said John Boyd touching or conveying the Premises as aforesaid. IN WITNESS WHEREOF the said Robert Boyd hath hereunto set his hand and seal this tenth day of December in the year of our Lord one thousand seven hundred and ninety-two-And, of the Independence of the United States of North America, the seventeenth.

The 1800 Census, Chester Co., S.C., lists the following for family of Robert Boyd - 2 males, ten yrs. or under; 1 male 10-16; 1 male 16-26; 1 male 45 & up. 1 female 10-16; 1 female 45-up. (Husband, wife, 4 boys & 1 girl.).

According to records compiled by Leonardo Andrea, Columbia, S.C., for Mrs. Angie Boyd Hansen, a descendant of Robert Boyd, it is noted Robert enlisted in the 3rd S.C. Regiment of the Continental Army under Col. William Thompson on the 24th day of July, 1776. Robert Boyd was in service 1779-80-81-82 with Captain James Young. Served as Clerk with Captain Terrance Campbell in August 1782. (See Penn. Archives, Fifth Series, Volume 6, pages 100, 111, 127, 183, 290, and 548).

From S.C. Pension data it is noted that Robert Boyd applied for Pension from the State of S.C. on the 30th of Nov., 1811 and to be retroactive until 1790 —Robert Boyd received a wound in the foot at Rocky Mount while fighting with General Thomas Sumter in 1780. Pension was allowed. Robert died in March 1812 and his estate was administered by John Boyd. Receipt for the pension money 27 May 1812 was signed by John Boyd, who is also listed as a Minor — Mary Boyd signs receipt.

Robert Boyd's estate administered 4th of Sept. 1812 by John Boyd and his Bond signed by James Boyd and William Boyd for \$200. Inventory made by John Neely, Thomas Neely, William Boyd. Reports were made by John Boyd from time to time during period 1813 to 1813. Each portion was divided into 3 parts. Andrea stated this shows there were 8 children and no widow —unless the widow elected (under S.C. law she could do so) to take a child's part and if she did so elect —Robert Boyd left a widow and 7 children. Citation was read at Hopewell Meeting House. John Boyd died or else moved from S.C. The estate was again

Under date of October 28, 1958, Mrs. Hansen wrote - "If John Boyd of Chester County, the admr. was oldest child of Robert and named for the father's father, he (according to the Census of 1800) would be about age 28-38 when Robert, the father, died in 1812. John, the administrator, disappeared and did not finish the administration of Robert Boyd. He worked on it from 1812-1818 and then it seemed to remain unattended until about 1822 when another son, Robert P. Boyd, (see below), became of age and obtained L/A (Letter of Administration) for finishing the settlement of Robert Boyd's estate."

"Robert P. (Patterson) Boyd was born in Chester Co., S.C. around 1790. He moved from Chester Co., S.C. about 1825 to Newton Co., Ga. He belonged to an ARP church in Chester County which tradition says was Hopewell Church near Blackstock, S.C., but a bit of 1847 history in a church magazine states they came from Union Church near Richburg, S.C. He is listed as one of the founders of Hopewell Church in Newton County in 1830."

(Mrs. Hansen spent many years of her life researching Boyd families in general in the states of Georgia, North Carolina, South Carolina, Virginia and Pennsylvania. She was very thorough in her work, always seeking documentary proof. It was your author's privilege to work with and exchange data developed from various sources with her. She furnished me copies of her records which are very voluminous. I am informed that additional copies were placed with the Georgia Archives in Atlanta a short time before she died in the late 1960's. It is my plan to leave the copies she furnished me, together with my own files which should be preserved, with the Mary Willis Library in Washington, Wilkes County, Georgia. Mrs. Hansen and I worked together over 10 years (1954-1965) concentrating on our own Boyd family lines which we strongly felt tied in somewhere along the line. I have now found the tie -namely Captain Robert Boyd, who died in 1760-61, Cumberland County, Pa. Mrs. Hansen descended from his eldest son John, I descend from his youngest son, Samuel Boyd). The next 2 pages are copied verbatim from Mrs. Hansen's records. It includes data on her father, William Boyd (12-25-1851 - 2-4-1927), her grandfather, John Patterson Boyd (4-10-1824 - 12-24-1892) and her great grandfather, Robert Patterson Boyd (1790-1849), including his Bible records.

According to tradition John Patterson Boyd was the baby and only child coming with parents to Newton County, Georgia. Presumably he was baptized in Chester County, S.C. as all the other children were baptized at Hopewell Church in Newton County, Ga. (ARP).

More data on these children: The first baby was buried in Chester County, S.C. The second child, Margaret, also died in infancy and was interred in Chester Co. John Patterson Boyd married 2 July 1846 to Sarah Paul Robinson. Martha Jane Boyd remained single. William Perry Boyd died in Battle of Rosaca or Atlanta.

ROBERT WATSON BOYD died in Prison Camp in Virginia at Camp Chase. He married 18 Sept. 1849 to Miss Mary Ann Robinson, had five children born in Newton County, moved to Cobb County. After death of Robert Watson Boyd, his widow and children moved to Ala.

I enjoyed the visit of Mr. Charley F. Boyd, wife Lilly Mae Biddy Boyd of Blair, Okla., and Mr. John Riley Boyd, Jr. and wife of Hobart, Okla. On Jan. 20, 1977, I wrote asking them for information on their Boyd line to be included in this family history. Mrs. Charley F. Boyd replied on Jan. 26,

We received your nice letter. Yes, we meant to gather everything we could to help

you with your writing.

We arrived home safely from our trip into S.C. and Georgia, on Oct. 18th, 5 p.m. Then on Nov. 9th, our only child, our son, died suddenly. He was only 48. That made us feel like life wasn't worth living. He was so much help to us and every one who knew him. He was enjoying life, was always so happy. He had retired after 20 years on the Oklahoma Hi-way Patrol, and was Deputy Sheriff of Okla. County, living in Oklahoma City. So of course we lost all interest in everything.

I, his mother, had entered the hospital just a few hours before his death, with a bleeding ulcer. I was down to 40% and taking blood when they brought me the sad message. They took me to the church in an ambulance with nurse, just to see him and right back to the hospital. We miss him so much. It's the saddest thing that ever happened to us. With care and treatment, the ulcer seems to be healed, but I have to keep on guard. I went to Hobart to talk to John R. and his wife about this information. We plan to

get busy and mail you as much as we can find real soon. Sorry for the delay.

We surely enjoyed being at your house. It was so nice of you to take the time
to see and talk to us. Our entire trip was just perfect. The boys, Charley & John R.,

were so happy with everything they heard about the family.

Our grandson was here to see us last week. He would so love to make a trip to Georgia, but he has so little time off. He's with the police force in Norman, Okla. He has a wife, a little girl 4 years and a boy two years. He's also taking college work. Charley says if you could write us when and where this reunion is held that you spoke of, our grandson, Mark, and Charley would so love to come. Mark tries to get us interested again.

Sorry if I've bored you and hope everything goes well with you. Glad to hear from
