Subject: Research Request - Bratton-DuBose Plantations

Hi Eddie (or to whomever this is appearing)!

I am almost ready to start writing the book about the Carolina Brattons, but still have a few lose ends to tie up. One involves plantations owned and/or operated by General John Bratton. I really haven't been able to find much information about whether he ever actually owned or operated Roseland and Farmington Plantations; I think I have figured out he managed Farmington, which was owned by the DuBoses and eventually auctioned off. According to Luke Austin's book about Gen. Bratton, the general assumed control of the combined holdings of the Bratton and DuBose families after the Civil War and formed a partnership with a banker in Baltimore, who furnished the capital, but I can't find any references regarding that. Also according to Luke, the general concentrated on farming cotton and raising imported cattle, sheep, and swine, but I've seen nothing about that, either.

I have found literally nothing about Canaan Plantation, although I know it existed as I have seen it mentioned in *Slave Narratives* by at least two ex-slaves. It shows up on the following website as being owned by a Bratton - if it is the correct one - but indicates it was in another county: http://south-carolina-plantations.com/georgetown/canaan.html

In an article in one of your newsletters (I've been doing extensive research on your website), there was also an indication that one of the properties owned by Theodore S. DuBose was named Rock Hill, but I don't know if that had ever been was an actual plantation, or just involved some buildings and property. ("Winnsboro: A Century of News," *Fairfield Genealogical Society Newsletter*, vol II, no. 3, September 1996).

I know that all of the plantations were eventually sold off, but do you have any specifics? I realize that Reconstruction and the ensuing lack of slave labor, then the Great Depression and "the end of cotton farming due to the boll weevil" in the county had an effect.

John Bratton of Sewanee indicated that there was a fire that destroyed many of the family's records, so maybe some or much of this is a dead end, but anything that you can find would be greatly appreciated!

Please say hello to Pelham for me. I just finished transcribing the interview I did with her father, and it brought back such wonderful memories of my trip to Winnsboro:)

Your request is now number #11 of the 19 remaining request.

Thanks for your patience with us.

Apparently good news, the word must be out about us (see FYI below). However, we are still supplied by a volunteer staff.

As FYI: we were getting on average about 3 request per month, this past year our average was 20 request per month;

our walk-in visitors is up from January 2014, 110, to an average of 139 walk-ins per month in 2014, 226 last month;

Pat.

How is John Bratton of Sewanee these days? I used to correspond with him many years ago and know he would be getting up in years. I think Luke spent days at a time with our genealogy collection previous to my becoming the museum director, also came here for a book signing event and we have corresponded much in the past. My brother is a grad of Sewanee and I believe he knew Mr. Bratton. Another family connected to that period at Sewanee was the Means/Kirbysmith. The famous sculptor, Maria Kirbysmith lives in nearby Camden and is a friend of mine. We are presently embarking on a plan to begin restoration work in the Means family cemetery in western Fairfield County, so will soon be in touch with relatives of that family group. My memory is not as good as I'd like, but it seems I remember that Isabella Means was the mother (grandmother?) of Gen. Bratton.

Also, I suspect you may already have contacted Karen Stokes of the SC Historical Society Foundation in Charleston. If not, I will forward her contact information to you when I get in to work shortly. I don't know if our paper files on the Bratton family contain more recent additions to the collection since that time or not, but we have greatly upgraded our research room with the addition of a part-time manager. Eddie Killian can take your questions via email and will be the person you need to correspond with on the planned dates to come visit us at the museum facility. Copying to him here for that. There is some small fee setup for research at a particular level, but we encourage researchers to join the genealogical society which entitles one to free services. Eddie can explain this better. Also, his help in-house when you come is gratis.

My father, who turns 96 next week, remembers Randall Bratton as I was walking in the cemetery with him recently (St. John's Episcopal Ch.) and he pointed out the grave. Also, our UDC chapter (and also the local SCV chapter) are named for General Bratton and we recently had a small ceremony on his birthday placing flowers at the grave (which is in need of maintenance).

I don't know if you are interested or not, but the Bratton house is still in existence, known as Wynne Dee for its maternal connections with the Winns and Brattons. Unfortunately, the mother-daughter residents are not particularly open to visits as their economic status has not allowed for proper upkeep of the structure. I will inquire, however, if you would at least like to walk around the yard for photos. The daughter and granddaughter of Joe Cathcart have lived in the house all of their lives, but I don't think they have familial connections to the Bratton lines. In looking at the tax assessor's online information

at http://qpublic5.qpublic.net/sc_display.php?county=sc_fairfield&KEY=126-01-11-022-000, it looks like Tirzah Ketchin Cathcart sold the property to Joe in 1942. Beyond that, I am not sure of Tirzah's connections, but as she was a Ketchin, there may have been a marital connection in her family to the last of the Brattons who lived there. That is something Eddie can find out. She has been dead many years, but there may be descendants we can furnish you references for. We look forward to meeting you when you come to Winnsboro. Dear Ms. Lyles,

I have been commissioned by one of the descendants of General John Bratton to write a book, a family history, on some of the Brattons from Carolina (Col. William Bratton of Brattonsville, Gen John Bratton, Bishop Theodore Bratton, etc.), and will be in Carolina the week of July 29th. I will be leaving that Wednesday or Thursday the 3rd or 4th, and was wondering if your organization would have any information on General John Bratton. According to your website, you are closed on Mondays, but I could come by on Tuesday or Wednesday. Should I go ahead and make an appointment with you for one of those days?

I believe you may have had a visit with Luke Austin, who wrote a book about General John Bratton (Letters to his wife that he wrote during the Civil War). I will be focusing on General Bratton's post-war political and civil career after that period, so that is the sort of information I will be looking for. I will also be doing research at the University of South Carolina Libraries and Collections, and may also be visiting the York County Historical Society.

I don't know if you can truly answer my questions about whether any material is available on General Bratton without doing research, but I would be glad to pay you or one of your volunteers to at least do a limited search to see if there is information I could explore on General Bratton.

Dea Eddy and Suzanne,

I've been emailing with Pelham Lyles (I think she has copied you two on at least one of our emails) and would like to see what information you might have available regarding General John Bratton. I have been commissioned by one of his descendants, John Bratton of Sewanee, TN, to write a family history focusing on four of the more well known or famous Bratton families from Carolina, and one chapter will focus on Gen. Bratton and his family. Mr. Bratton (of Sewanee) wants me to concentrate on Gen. Bratton's post civil war life his social, civic, and political life after the war, since there has already been a book written by Luke Austin about the general's time in the Civil War. I would also like to know more about his family life while he was growing up. I want the readers of this book to come away with a real feel for what these families were like, not with just a list of facts.

I am coming to the Columbia area next week, about a week earlier than I had originally planned, as I realized I needed more time. I will be driving to Columbia next Monday, June 22, and staying in the area through Saturday, June 27th, when I will be driving unto Raleigh for a couple of days.
