THOMAS BROWN

STATE OF SOUTH CAROLINA IN THE NAME OF GOD, AMEN!

I Thomas Brown of Fairfield District, do make and declare this my last will and Testament- First. To my niece Parthenia Rugeley wife of John Rugeley I devise one half of my Lands on the Wateree River, where I now plant; the part hereby devised is to be gaid off on the upper part of the said Blantation or Tract of Land, by a line to begin on the river at the fence which divides the land planted by the said John Rugeley from the land planted by myself and to follow the said fence untill it comes to the main Road then to go up the main Road untill it comes to a crofs fence on the left side of said Road (which fence runs below John Rugeley's negro Houses) and to follow the said Fence from the said Road untill its termination and then from the termination of the said fence by a straight line to the back line of the said Tract of Land: To have and to hold the said Lands to the said Parthenia during the Term of her natural life only (hereby intending to give her a life Estate merely) and from and immediately after her death, to the Ifsue of her Body who may be then living share and share alike absolutely and in fee simple; and in case she should die without leaving ifsue of her Body then living, I give and devise the said Lands one half to my nephew John Irvin and his Heirs and afsigns for ever, and the other half of the said land to my niece Mary MCCall wife of Hugh MCCall; to have and to hold the same to the said Mary MCCall during the Term of her natural life only, and from and immediately after her death to the ifsue of her Body who may be living at the time of her death share and share alike, absolutely and in fee simple. SECONDLY. To Venus a negro woman formerly belonging to me but now emancipated and free, I give and bequeath her two children Milly a Girl about eight years old, and Eliza a Girl about five years old, and also thirty Dollars a year for life to be paid

To the said negro woman Venus I also give and bequeath the House she has lately occupied at my upland or sand Hill place and the enclosed Lot whereon it stands containing about five or six acres and also twenty acres of Land lying on the North West side of the said House and lot and the nearest to the said House and Lot; To have and to hold the said House and Lot and twenty acres of Land unto the said Venus for and during the Term of her natural life. Neverthelefs the store House standing on the said Lot hereby given to the said Venus I hereby give give to my nephew John Irvin who is authorized and required as soon as pofsible after my death to remove away the said store House from the said Premises. FOURTHLY. I give and devise to my niece Mary M. Call wife of Hugh M. Call all that part of my upland or sand Hill Tract of Land which lies on the North side of the Road leading from Damden to Winnsborough including my dwelling House with the building appertaining thereto; (reserving out of the same the life Estate of the said Negro woman Venus in the House, Lot and twenty acres of Land above given to her) To have and to hold the said Lands to the said Mary M.Call during the Term of her natural life only (hereby intending to give her a life Estate merely) and from and immediately after her death, to the ifsue of her Body who may be then living share and share alike absolutely and in fee simple; and in case she should die without leaving such ifsue then living, I give and devise the said Lands one half to my nephew John Irvin his Heirs and afsigns for ever, and the other half of the same to my miece Parthenia Rugeley for and during the Term of her natural life only, and from and immediately after the death of the said Parthenia to the ifsue of her Body who may be then living share and share alike absolutely and in fee simple: Reserving in all events the life Estate of the said Negro woman Venus in and to the House and Lot and twenty acres of Land above given. FIFTHLY. I give and bequeath unto Thomas Salmond his Executors and Administrators in Trust for the intents, uses and purposes






