SOUTH-CAROLINA.

PURSUANT to an ACT of the GENERAL ASSEMBLY passed the 16th of March, 1783. We, the COMMISSIONERS of the TREASURY, have this day delivered to

Mrs Sarah Bryant

this our INDENTED CERTIFICATE for the Sum of

Three Pounds Four Shillings and two Pence Sterling for a Debt for Militia us in 1702 as per Account Audited

the said *Sarah Bryant her* Executors, Administrators, or Assigns will be entitled to receive from this Office the Sum of *Four Shillings and five Pence*

on the Demand *for* one Year's Interest on the Principal Sum of *Three Pounds four Shillings and two Pence* and the like Interest Annually

The said *Sarah Bryant her* Executors, Administrators or Assigns, will be entitled also to receive, and shall be paid, if demanded, the principal Sum of *Three Pounds four Shillings and two Pence* on the *Twenty fourth of January 1707*

And the said *Sarah Bryant her* Executors, Administrators, or Assigns, may make any Purchases at any Public Sales of Confiscated Property, (except such as shall be ordered by the Legislature for special Purposes;) and this INDENT shall be received in Payment.

For the true performance of the several payments in manner abovementioned, the PUBLIC TREASURY is made liable, and the FAITH of the STATE pledged by the aforesaid ACT

GIVEN under our Hands at the TREASURY OFFICE, in CHARLESTON, the *Twenty fourth* Day of *January* one thousand seven hundred and eighty *five*
