JOHN WOODWARD 4/ (SON OF WILLIAM 3/)

John Woodward 4/ attended school at Milledgeville, Georgia, married Miss Mary Mobley in early life and had the following children: Samuel, who was one of the Shakespeare scholars of his day. He never married, went to California in 1849, was kicked by a mule and died in an infirmary; Joseph Woodward who married Nancy Pickett, had one child Nannie, who married Reubin Lumpkin. Dr Thomas Woodward, who was graduated at the College of Physicians in Paris. He died early in life leaving a daughter in Atlanta. The daughter Mary, married Thomas DeGraffenreid Satterwhite, a very handsome, bold, high tempered man. They emigrated to Texas. An incident shows the nature of Satterwhite. In crossing the Mississippi River he took notion to land further down than the boat's schedule allowed. He took charge of it at the point of the pistol and had his way. He came to a violent end to the best of my information, being killed by a Texas school teacher in a quarrel over his children.

Mary his wife died, leaving two sons, that both became notable men. John and Thomas Satterwhite. While fatherless and motherless, they put out from Texas with a herd of cattle across the plains with their uncle Sam Woodward to California and both labored in the gold mines, John sometimes being the cook of the mining camp, but sharing with the other diggers as prospectors. John accumulated some means, married a Mormon girl of Utah and for a long time was State senator in California. He left a delightful family and their descendents are in California and Oregon. The son Thomas, after working in the mines, attracted the notice one day of Don Cameron, a Senator from Pennsylvania, who gave him a chance for education, took him later in his law office where he studied and was admitted to the bar. Arizona being a territory, through Cameron's influence, he was appointed Attorney General of that territory and was later a Probate Judge at Tuscon. He visited his uncle Captain William Woodward in 1883

and was the handsomest man I ever saw and could speak both the Sapanish language and the Indian dialect.

JOHN BARRETT WOODWARD 4/.

JOHN BARRETT WOODWARD 4/ SON OF REV. WILLIAM WOODWARD 3/ & NANCY ELIZABETH BARRETT WAS BORN CA. 1796 IN FAIRFIELD COUNTY, S.C., MARRIED MARY MOBLEY, (1796-1879) A DAUGHTER OF SAMUEL MOBLEY SR. & ELIZABETH PICKETT WHITEHEAD. JOHN 4/ DIED ON 14TH MAY 1829 IN GEORGIA. THE WIDOW MARY REMARRIED TO JOHN ROBINSON (ROBERTSON).

John Barrett Woodward 4/ was born in 1796 in Fairfield County, S.C., married on 14th May 1817 to Mary Mobley. It is known that they moved to Georgia, where John died in 1827. Mary Mobley married 2nd time to John A. Robinson (Robertson?)

Their Children were:

1. Samuel Mobley Woodward 5/, died in California as the result of being kicked by a mule, no dates listed.
2. Captain William B. (Barrett?) Woodward 5/, born 24th December 1818, married Eliza Boulware Pickett on 14th May 1829. He died on 4th October 1897.
3. Mary Woodward 5/, married Thomas DeGraffenreid Satterwhite. They went to Texas where Thomas was killed by a school teacher in a quarrel. They had two sons; **John & Thomas Satterwhite, who went to California to join their uncle Samuel.
4. Nancy Mobley Woodward 5/, born 19 August 1823, married (cousin) John Woodward Rabb.
5. Joseph Woodward 5/ married Nancy Pickett, had a daughter Nannie, who married Reuben Lumpkin.
6. Dr. Thomas Mobley Woodward 5/, graduated from College of Physicians in Paris, practiced medicine in Atlanta, died early in life, is known to have married and had a daughter that married a Dr. White.

Note: John & Thomas Satterwhite worked in the California gold mines for a spell. John accumulated some means, married a Mormon woman of Utah. He was a state Senator in California. Thomas attracted the attention of a Pennsylvania Senator named **Don Cameron, who educated him and was admitted to the bar, became Attorney General for the Territory of Arizona and a probate judge at Tucson..

July Court Term 1799

29. (Same Book, page 174) Thursday 18 July 1799
John Robertson, Alexander Robertson, Orphans, appeared in court and chose Hugh McEwen as their guardian, the court so ordered.

Margaret Agnes Robertson, orphan, chose **Simeon Cameron** as her guardian, the court so ordered.

The court then ordered that the estate of Alexander Robertson have the liberty to sell the personal property of the deceased, so as to make a division among the legatees.

This John Robertson, Alexander Robertson and Margaret Agnes Robertson appear to be the children of a deceased Alexander Robertson, who's relationship to the other Robertsons (William, John & Henry) is unknown.

Alexander Robinson Jr. sold **John Cameron** the upper 200 acres out of the tract of 400 acres that he had bought from John Stedman for \$300, on March 19, 1803.

James (and Joel) Butler sold John Robinson 107 acres of land in the forks of **Cameron Creek** for \$300 on November 17, 1806. This land was part of 600 acres that had been granted Thomas Colvill in August 1785, and transferred to David Hopkins on February 1, 1786, and to James Butler on September 1, 1787.
