From: "The Clans & Tartans of Scotland," by Robert Bain: Cameron: Crest Badge: A sheaf of five arrows tied with a band, gules, Old Motto: Ma righ's mo dhuchaich (For king and country), Gaelic Name: Camshron (origin of name: Camshron from Gaelic com (wry) and Stron (nose), wry-nose.) War Cry: Chlanna nan con thigibh a so's gheibh sibh feoil (Sons of the hounds come here and get flesh). Pipe Music: Piobaireachd Dhomuill Duibh.

Cameron of Lochiel: same badge as Cameron. same pipe music, same war cry. Plant Badge: Oak, Crowberry.

The history of the Camerons of Lochiel is inseparably bound up with the history of the clan, as witness the references in the preceding, but in 1528, the lands of the "Captain of Clan Cameron" were erected into the barony of Lochiel by a charter granted by King James V in which the "Captain" is for the first time described as "of Lochiel".

During the time of Sir Ewen, 17th of Lochiel, the castle of Achnacarry was built, and has remained the home of the Camerons of Lochiel until the present day, although the original house was destroyed in 1746, and the present castle was not finished until about 1837. Sir Ewen, who built the original mansion, was the celebrated chief of the clan who waged war against the troops of Cromwell. In the end the Camerons were allowed to retain their arms on their promise to live peaceabley, and "no oath was required of Lochiel but his word of honour."

Donald, 19th of Lochiel, "the Gentle Lochiel" whose bravery and heroism was amply proved during the '45, constantly endeavoured to ameliorate the horrors of war as far as possible. He is said to have saved the city of Glasgow from being pillaged during its occupation by the Jacobite army in 1745.

In 1796 Donald, 22nd chief was by decree of Lyon Court established as chief of the family of Lochiel and as chief of Clan Cameron.

Cameron of Erracht: Regimental Cap Badge: Within a wreath of thistle, the image of St. Andrew holding before him his cross. Gaelic Name: shown on Badge. The Queen's own Cameron Highlanders wear this tartan, which according to regimental tradidtion was designed by the mother of the founder of the regiment, although widely worn, it is not a Clan Tartan. The progenitor of the Camerons of Erracht was Ewen, son of Ewen, Chief of the Clan Cameron, by his second wife, Marjory Mackintosh. In the first half of the 16th century. At the Jacobite Rising in 1745, Cameron of Erracht supported Prince Charles and was second in command of the Clan Cameron.

Alan Cameron of Erracht, who was born c. 1753, served in America and after his return home, he raised the original 79th Regiment, Cameron Highlanders in 1793. He was appointed Lieut. Col. Commandant and commanded the reg. throughout the Flanders Campaign of 1794-95. In 1979 the reg. was disbanded and many of the men joined The Black Watch. etc. etc.

The Clan Cameron described as "fiercer than fierceness itself" are reputed to be one of the ancient clans of Scotland, and for centuries associated with Lochaber. It consisted originally of three branches, the MacMartins of Letterfinlay, the MacGillonics of Strone,

and the MacSorlies of Glen Nevis. The Camerons of Locheil descended from the Strone branch are said to have obtained their lands and the chiefship of the clan through intermarriage with the Letterfinlay branch. For a time the clan were subject to the Lords of the Isles and John assisted Donald, Lord of the Isles at the battle of Harlaw in 1411. Later, however the Camerons withdrew from their association with their powerful allies and a long period of feuds followed.

A notable chief was Sir Ewen of Locheil, born in 1629, who was received in London by King Charles !! in 1660, and was knighted in 1680. He fought at Killiecrankie ten years later. The Camerons were always strong adherents of the Stuarts, and Sir Ewen never submitted to Cromwell. When too old for military service, Sir Ewen, in 1715, sent the clan under his son, to help the Earl of Mar. Sir Ewen's grandson Donald, known as "the Gentle Locheil," joined Prince Charles in 1745, and he will ever be honoured as one of the outstanding personalities of the '45. He escaped to France and died there in 1748. The family estates were forfeited, but on their restoration under the General Act of Amnesty of 1784, the Gentle Locheil's grandson, Donald, 22nd chief resumed possession. Auchnacarry Castle is the home of the chief.

From "A Short History of Scotland" by R. L. Mackie: p. 244-45: (ca 1745) Prince Charlie's army's standard raised in Glenfinnan, before a small army of MacDonalds and Camerons. etc. during battle, after darkness had fallen, the Camerons made a detour to the south of the city (Edinburgh) and crept in silently, etc..P. 242: Lochiel, head of Clan Cameron, one of the most faithful supporters of the exiled Stewarts, made up his mind to see the Prince and convince him that it was his duty to abandon the enterprise and go back to France. His brother, knowing his romantic and chivalrous disposition, advised him not to venture into the Prince's presence, but to carry on the debate by letter. Lochiel refused to take his advice, was granted an interview with the Prince, and explained to him why the expedition was certain to fail. Prince was determined..., so Lochiel decided he and his followers would go with him. risking all, knowing they had no hope of success. P. 251: Prince hid for a time in a cave occupied by 7 robbers, til he was able to make his way to "Cluny's Cage", a hut hidden in a tangle of brushwood on the side of Ben Alder, where he dwelt some time with Macpherson of Cluny, the owner of the cage and Cameron of Lochiel. Prince escaped to France Sept. 1746.

P. 182: 1680, some of the Coventers headed by Richard Cameron the preacher, rode into Sanquhar and at the market cross declared war against the King and all who supported him.Grim, unlovable men these Cameronians must have been, immovable in their opinions, certain that they were right and that the rest of the world was hopelessly wrong. Presbyterians....would not accept a compromise from a King who had not taken the Covenant. Wanted everyone, England & Scotland, to be Presbyterian. P. 184: The Cameronians formed a regular regiment, fought the Highlanders who outnumbered them 4 to 1, P. 261: the Reformed Presbyterians were the descendants of the Cameronians. 1876.

Also buried at Ebenezer are: Mrs. Celia Rogers, died 9-21-1818 age 30 (b. 1788) and Mrs. Jane Wilson Rogers, died 7-30-1803, age 20 (born 1778), and Mrs. Martha Fullerton Rogers, died 8-20-1827 at age 30 yrs. 2 mos. 25 days. (born 1797) Any one or all of these women could have been spouses of Rev. James Rogers.



Thomas Richardson Will of 1783, proved 1786: Margaret Richardson, widow of Thomas, planter, applied for administration 25 August, 1786, citation not returned. Will, written, one is part missing: wife, Margaret 1/3, 200 ac. on Little River, son Wm., son Thos, Jr., and daughter Margaret got 100 ac. of his 300 ac. of "his land at Packlet", son Robt is ex, daughter Jennet Kennedy, Son Samuel, James Rabb & wife Hannah appeared before John Winn, J.P. witnessed. Thos Cameron appeared saying Thos. made a cupative will, widow & 4 children who <u>still lived with him</u>: viz Samuel, Robt, Mary & Margaret. estate appraised, Oct 18 by John Hawthorn, John Elliot and Thos Richardson. Will Probate, Fairfield, Apt. 59, Pkg. 2070 - some of will missing.
