Hughes sold 150A part of survey 26 Nov 1804 to Andrew Moyers (Nby Deeds I-46). 100A (N part) of survey conveyed to Robert Brannon who conveyed to Humphrey Williamson & by Williamson & wife, Abigail, sold 1 Apr 1801 to John Dominick (Nby Deeds I-15).

Benjamin Pearson's LWT of 10 Dec 1784 leaves wife, Margaret, a life estate in tract then to sons: William, Abel, Samuel, Robert, Joseph & John. Shown on plat of Enoch Pearsons survey of 20 July 1767 as land of Robert Pearson (Nby Deeds J-161).

PEARSON, BENJAMIN

200A, 13 Aug 1771, 19:107. Scotts Cr. Maps-Pp. 57 & 60.
According to LWT of Benjamin Pearson, land had been sold to brother William Pearson, deceased, in 1784. Shown in 1800 as land of Samuel Pearson (Plat of Coate to Nance, Nby Deeds D-600). Eastern part of survey sold 1813 by Robert Rutherford to Young John Harrington (Nby Deeds K-206).

Wife of Jacob Frye, Sr. 100A part of survey left in 1799 LWT of Jacob Frye Sr. to Jacob Frye Jr. Conveyed 9 June 1804 by Jacob Frey to William Holeman Sr. then conveyed 31 Oct 1808 by William Holman Sr. to Jr. Sold 1810 by John Myrick to Benj. Lindsey (Nby Deeds J-587).
