John Blocker J P. Recorded 14th March 1797.

p.548-549 Obediah Kilcrease [Killcrease], planter, to John Daulton. Deed, 13 March 1797, \$20, 8 acres part of 100 acres granted unto me by State of SC on Beaverdam Creek of Savannah river adj land of Wm Coursey, long branch, and original grant. Wit James Lyon, a Constant (+) Oglesby. /s/ Obediah (O) Killcrease. Proven 13 March 1797 by Constant Oglesby; John Blocker J P. Rec 14th March 1797.

p.549-553 Samuel Harris and wife Martha Harris to Samuel Hill. L&R, 12 Sept 1787/12 Sept 1787, granted 2 April 1773 by Lt Gov Wm Bull to Levi Harris 200 acres on Gunnels Creek of Stevens Creek adj Saml Harris, Thomas Stephenson, Levi Harris; sd Samuel Harris now for £100 sterling paid by Samuel Hill sells sd 200 acres. Wit Henry Key, James Thomas, Jeffery (H) Hill. /s/ Samuel (x) Harris, /s/ Martha (+) Harris. Proven 23 February 1797 by James Thomas; Henry Key J P. Rec 14 March 1797.

→ p.553-554 Henry, Michael & Catherine Muckenfuss & Mary Desel to Jiles Chapman. Deed, 15 November 1796, £40 sterling, 200 acres on Clouds Creek of Little Saluda. Wit Adam Efurt, Mathew Burden, Samuel Gruber. /s/ Michael Muckenfuss, /s/ Henry Muckenfuss, /s/ Katharine Muckenfuss, /s/ Mary Desel. Proven 7 Feby 1797 by Adam Efurt; Russel Wilson J P. Recorded 14th March 1797.

p.555-556 James Wilson of Abbeville County, Inn Keeper in Cambridge, to Charles Cooper. Deed, 1 November 1796, £85 sterling, 300 acres on Ninety Six Creek of Saluda River adj land of sd James Wilson, originally granted to William Bell 6 Feby 1786, conveyed by Bell to sd Jas Wilson 16/17 May 1790. Wit Benjn Glover, J Nichols Junr. Judge Chas J Colcock certifies relinquishment of dower by Tabitha Wilson wife of James Wilson, 10 March 1797. Proven 11 March 1797 by Benjamin Glover; Jno Trotter J P. Recorded 14th March 1797.

p.557-558 Joseph Hightower to David Quarles. Deed, 31 December 1796, \$273 109 acres and 24 perches on Chavers Creek bounded by lands granted unto John Buckhalter & Richard Quarles. Wit David Glover, Dudley Carter. /s/ Joseph Hightower. Proven 11 Feb 1797 by Dudley Carter; Chas Old J P. Rec 14th March 1797.

p.558 Michael Buckhalter to Henry Buckhalter. Deed, 6 June 1796, £50 sterling, Negroe man Charles about seventeen years old. Wit Absolam Napper, George Grigory. /s/ Michael (EB) Buckhalter. Proven 21 December 1796 by Absolam Napper; Van Swearingen J P. Recorded 14th March 1797.

p.559-560 Michael Buckhalter to Henry Buckhalter. Deed, £50 current money, 50 acres on branch of Big Horse Creek, originally granted to John Randal 5 June 1786, from him conveyed to Michael Buckhalter, also another tract of 97 acres originally granted to Thomas Bickum. Wit Absolam Napper, George Grigory. /s/ Michael (EB) Buckhalter. Proven 21 Decr 1796 by Absolom Napper; Van Swearingen J P. Recorded 14th March 1797.

p.560-562 Benjamin Harry to Thomas Adams. Deed, 14 March 1797, £20, 100 acres originally granted to William Mosley Junr 21 May 1772 by Gov Montague and conveyed by Wm Mosley 1775 to Benjamin Harry, lying in Granville County now Edgefield, on Nobles Creek adj lands of Lawrence Rambo and John Powman White.
