Benjamin Hatcher, NW by William Ward, NE by Thomas Turner, lying on Baileys Branch. Wit James Howze, Susan Turner. /s/ Joab Wilson. Proven 29 October 1808 by James Howze; Gn Christian J P. Rec 26 October 1809.

p511 Martha Lefever to John Talbert, Deed of conveyance, 24 December 1808, One hundred Dollars, my part of nine hundred acres originally granted to Henry Key decd by Gov Chas Montague 5 January 1773 and conveyed to his daughter Mellinda Letcher by Deed of Gift 4 March 1776, on Beach Creek, bounding S on lands of Calliham Yarby at time of survey, NE by sd Key, NW by William Anderson. Wit Caty Galehar, Edmon Lefever. /s/ Mathew(sic) (x) Lefever. Proven 18 May 1809 by Caty Galehar who saw Martha Lefever sign; John Longmire J P. Rec 6 November 1809.

p512 Solomon Bird to James A Moore, Deed of conveyance, 19 July 1809, Three hundred Dollars, ninety six acres on Mountain Creek of Turkey Creek of Savannah River running on lines of John Mitchell, being part of two tracts originally granted to James Simpson Esqr 20 August 1772 and November 1772. Wit Spencer Smith, Eliza Blocker. /s/ Solomon Bird. Proven 19 July 1809 by Spencer Smith; John Blocker J P. Rec 6 November 1809.

p.513 John Arledge to Jeremiah Hatcher, Deed of Conveyance, 13 April 180[blank] fifty acres on waters of Turkey Creek of Stephens Creek of Savannah River, adj Haw Branch, John Hall. Wit James Coats, John Arledge. /s/ John (I) Arledge. Proven 6 November 1809 by James Coats; Thos Swearingen J P. Rec 1 November 1809.

p.513 John Revlin of Abbeville District to John Williams, Deed of Conveyance, 31 August 1807, one hundred fifty [dollars?], one hundred fifty acres on Wilsons Creek of Saluda River bounded by lands of Edward Buck, Thos Forqur, Thos Forker, granted to Jacob Young [date blank]. Wit Alex Jordan, Bart Jordan. /s/ John Revlin. Proven 11 Octr 1809 by Alexr Jordan; Jas Cochran J P. Rec 9 November 1809.

p.514 John Williams of Abbeville to Mary Griffis, Deed of Conveyance, [blank] October 1809, One hundred fifty Dollars, one hundred fifty acres on Wilsons Creek of Saluda River adj lands of Thomas Anderson Esqr, heirs of Thomas Ross, Thomas Forquer, John Hardy. Wit John H Lesley, Richd Edward. /s/ John Williams. Proven by Richd Edwards; Wm Wilson J P. Rec 9 Novr 1809.

p.515 William Fowler to Richard Yarbrough, Deed of Conveyance, 19 November 1800, One hundred fifty Dollars, One hundred acres, part of land originally granted to Samuel Messer, on Moors Creek of Saluda. Wit James (x) Fowler, Enoch Fowler, William Fowler. /s/ William (F) Fowler, /s/ Lucy (x) Fowler. Proven 21 June 1801 by James Fowler; Elkanah Sawyer, J P. Rec 14 November 1809.

→ p.515 Elijah Riley to Elijah Chapman, Deed of conveyance, 2 June 1809, Six hundred Dollars, one hundred acres originally granted unto John Davis on Little Saluda River binding on lands of Thos Davis, Henry Ethridge, Charles Pur[binding], John Davis, Joshua Martin. Wit Thomas Sheriff, Lewis Blalock. /s/ Elijah Riley. Justice Sampson Pope

p.516 James Rodgers Junr to Philip Pow, Deed of conveyance, 27 September 1806, Two hundred Dollars, one hundred acres originally granted to John Douglass by Gov Wm Moultrie 6 February 1786; willed by him to his granddaughter Abba Douglass now wife of Collen Cockran, conveyed from Collen Cockran & wife to me, on Canebreak Branch of Little Saluda River. Wit John Ratten, Patk Ardagh. /s/ James (x) Rodgers Junr. Proven 27 September [year lost in binding], by John Ratten; John Pope J Q. Justice John Pope certifies the relinquishment of dower rights by Sarah Rodgers wife of James Rodgers Junr, 27 September 180[year lost in binding]; /s/ Sarah (x) Rodgers. Rec 16 November 1809.
