Another Revolutionary Soldier Gone. Died, at Lexington Court House, S. C., on the 14th inst., Mr. George Hillan. He called at the house of the writer, some four or five months ago, and remained until his death. He seemed to be merely passing, and for the satisfacton of his friends and relatives, if any are living, I would say, from his certificates, relative to his pension document (and he had no others), he was late from Tennessee; though he said he was raised in Barnwell District, South Carolina, and in the war of the revolution was occasionally with Gen. Marion, near Purysburg..... He was buried in the family grave yard where he died, on the 25th and on the 16th his funeral sermon was preached in the Lutheran Church (in our village) by the Rev. Mr. Margarth. A. H. Fort.
