After removing to Newberry District, he served at various times under Capt. James Liles and Cols. Waters, Casey and John Liles. (Moved to Ky., Ala. and Tenn.) A.A.1190; X2466.

Chandler, Shadrack, Jr.

He served in the militia under Col. Waters. A.A.1190; X2467.

Chandler, Solomon King

He served under Capts. James and Henry Liles and Edward Kelly and Col. Waters during 1780 and 1782. At some time, he was under Col. Casey. C.S.; A.A.1191; X1894; X2472.

Chandler, Thomas

He served as a lieutenant under Capt. John Neilson and Col. Richardson. In addition, he served under Maj. James and Maj. Gamble of Marion's brigade. At sometime, he was an adjutant. (Addison, Thomas); C.S.; A.A. 1192; W189.

Chandler, William

He served in the militia during 1780. C.S.; X1263.

Chaney, John

b. 1757, Randolph County, Va.

d. 12 September 1845

While residing in the Ninety Six District, he served under Capt. John Ryan and Col. Hammond or Pickens. In 1780 or 1781, he served under Capts. James Latham and Ross and Col. Myddleton and was in the engagement at Juniper Springs, where he was wounded. He rejoined the service under Col. William Washington and was in the battle at Eutaw Springs and in the engagement at Potato Patch. After returning to North Carolina, he joined a unit there. (Moved to Tenn. and Ind.)

Chaney, William

He served in the Second Regiment under Capt. Richard Mason during 1779. Saffell, p. 294.

Channel, Archibald

He served two hundred eighty days in the militia during 1782. C.S.; A.A.1196; Q426.

Chapell, William

He enlisted on 2 March 1776 and served in the Sixth Regiment, N.A.853.

Chapell, William

He served in the light dragoons under Capt. Jacob Barnett, Lt. Col. Henry Hampton and Gen. Sumter and was dead prior to 16 March 1782. Salley, <u>Doc.</u>, p. 54; C.S.

He enlisted in the Sixth Regiment on 3 April 1776. N.A.859.

Chapman, Giles

He served under Col. Waters after the fall of Charleston. C.S.; A.A.1198; X2481.

Chapman, John

He enlisted in the Fifth Regiment on 21 June 1776. He served as a private and sergeant under Col. Waters before and after the fall of Charleston. C.S.; A.A.1199; X2479; X2480; N.A.853.

Chapman, Joseph

b. 25 December 1745, Halifax County, Va.d. 18 January 1836

At first he served in a North Carolina unit. Thereafter, he moved to South Carolina and settled at Turkey Creek. After the fall of Charleston, he enlisted and served under Capt. Robert Anderson and Col. Pickens. He was at the siege of Ninety Six. Thereafter, he reenlisted to serve under Capt. Robert Maxwell and Gen. Pickens and marched into the Indian country. He was wounded. At sometime, he was a sergeant. A.A.1200; F421; K202.

Chapman, Joseph

He served under Capt. Edward Martin and Col. Winn from 1 June to 5 July 1781 and from 1 May to 20 May 1782. A.A.1200; C.S.

Chapman, Robert

He enlisted on 24 July 1776 and served as a private, corporal and sergeant in the Third Regiment. During 1779 and 1780, he was under Capt. Uriah Goodwin. He was at the capture of Savannah and the battle at Guilford Courthouse. (Moved to Tenn.) C.S.; A.A. 1200A; Q44; N.A.246; N.A.853.

Chapman, Shade

Chapman, Shadrack

He served in the Sixth Regiment from 1 April 1776 to 1 July 1781. At sometime, he served under Captain Alexander Boyes. N.A.246; N.A.853; N.A.859.

He served under Col. Manning. A.A.1200B.

Chapman, William

He served under Capt. Alexander and Gen. Sumter.

Chapman, William

He served under Capt. Aramanous Liles and Maj. John Pearson and was at Russell's Ferry under Col. Winn. He was at Orangeburg under Col. Thomson and at Four Holes under Col. Winn. A.A.1201; Y838; C.S.

Chapman, William

He enlisted in the Third Regiment on 1 December 1776. On 1 August 1779, he became a sergeant under Capt. Uriah Goodwin. After being captured at the fall of Charleston, he was a servant to Goodwin prior to November 1780. He deserted. S.C.H.&G., V, 149, 150; VI, 60; VII, 23; N.A.853.

Chapman, William

He served in the Third Regiment from 1 April 1777 to 1 July 1781, was taken prisoner, and was exchanged. N.A.859.

After moving to Richland District during 1764, he enlisted on Easter Monday (or 25 June) 1775 and served under Capt. Robert Goodwyn and Col. Thomson. In October 1776, he enlisted and served under Captain Richard Winn and Col. Thomson and was in the battle at Fort McIntosh (Ga.), where he was captured. After being exchanged, he joined Sumter and was appointed lieutenant under Cols. Lacey, Hill and Bratton. From 28 July 1780 to 15 June 1781, he served as a lieutenant under Col. Thomas Taylor, and was in the battle at Fishing Creek, where he was taken prisoner. He escaped and rejoined Sumter. Thereafter, he served as a lieutenant under Wade Hampton and was in the battles at Wright's Bluff, Scot's Lake and Lynch Creek. At some time, he was an aide to Gen. Sumter. He was promoted to captain and served under Col. Taylor. P.I.; C.S.; S.C.H.&G., II, 179; A.A.1202; W191; W193; Green, p. 35; N.A.853.
