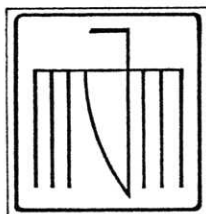

already laid out from the Horse-Shoe Road to Pocotallico Causey in the Parish of St. Bartholomew; and to keep the said Road in repair. And for appointing Commissioners to cut a Creek from Ashepoo River to Pon Pon River, at the upper end of the Goose Marsh between the said Rivers: and also to cut another Creek through the Marsh between Chehaw and Ashepoo Rivers," with the original Bill, up to the Council Chamber, and that he do examine the said ingrossed Bill by the Original, with one of the Members of His Majesty's honorable Council; and that he do afterwards attend the Governor with the said ingrossed Bill, and acquaint him this House desires that his Excellency will be pleased to order the Great Seal to be affixed to the said ingrossed Bill.

Ordered, that Mr. Lowndes do carry the ingrossed Bill intituled "an Act to appoint and establish new Lists of Jury-men to be drawn by Ballot in this Province. And to impower the Courts of Law to draw Jurors in Cases therein mentioned," with the original Bill up to the Council Chamber, and examine the said Bill by the Original with one of the Members of His Majesty's honorable Council; and that he do afterwards attend the Governor with the said ingrossed Bill & acquaint him this House desire that his Excellency will be pleased to order the great Seal to be affixed to the said ingrossed Bill.

And then the House adjourned [till three] of the Clock in the Afternoon.

The House met according to Adjournment.
