John Gilbert Hill Quattlebaum (9, 5, 3, 1) was born December 19, 1854, about twelve miles north of Eufaula, Barbour County, Alabama. He was a lumberman and operated sawmills in various places in the western portion of Georgia. He was a Mason. He was married twice. He was married, first, to Lavina Williams, of Sasser, Georgia, March 31, 1881. She was born, September 5, 1860, at Brownwood, Georgia, daughter of Merrill James and Elizabeth (Stanley) Williams. She died at Bluffton, Georgia, December 20, 1899.

His second marriage was to Effie Bell Land, of Bluffton, Georgia, December 22, 1901. She was born in 1869 in Clay County, Georgia, the daughter of Allen and Sarah (Brooke) Land. She died, and was buried at Fort Gains, Georgia, June 15, 1928. John Gilbert Hill Quattlebaum died November 9, 1939, and is buried in New Park Cemetery, Fort Gains, Georgia.³⁰ Children by the first marriage:

Benjamin Irwin Quattlebaum (17g, 6, 3, 1) was born December 29, 1840, in Alabama. He enlisted as a private in Company "A", 29th Regiment, Alabama Infantry, Confederate States Army. He was paroled as a sergeant at Greensboro, North Carolina, at the end of hostilities. While working his way back to Alabama, he stopped at the home of Sam Webb, in Edgefield District, South Carolina, and there married, January 4, 1866, Webb's widowed daughter, Martha (February 14, 1843–September 13, 1923), whose husband, George Little, had been killed while serving in the Confederate Army. At the time, Martha had one daughter, Joanna Little. Benjamin Irwin Quattlebaum died in Edgefield County, South Carolina, November 24, 1919. Children:

Peter Quattlebaum (4, 1) was born in Newberry District, South Carolina, in 1798. As a young man, he moved to Edgefield District, South Carolina. He was there with a wife and four children in 1850. He, and family, are recorded in census records of Newton County, Mississippi, 1860 and 1870. This is the last record we have of the family. His wife was Ann A. Grisson, known in the family as "Nancy". Children:

Joseph Quattlebaum (4, 1) was born in Newberry District, South Carolina, June 29, 1800. He seems to have been the only member of the family who remained in Newberry District. His descendants are numerous, and most of them are to be found in what is now Newberry County. He was married twice. His first marriage was, 1827, to Nancy Threat, daughter of Edward and Margaret Threat (Theweate). His second marriage, 1833, was to Margaret Lynch (September 28, 1811–March 16, 1892), daughter of Reverand Elijah and Elizabeth (Chapman) Lynch. Joseph Quattlebaum died January 22, 1848.
