Died in Spartanburg District on the 12th of April last, in the 55th year of her age, Mrs. Gray, widow and relict of Capt. Peter Gray of the Revolutionary Army. Mrs. Gray was the daughter of Mr. Wilson, was born in Philadelphia, and at an early age removed with her father to Charleston, South Carolina, and afterwards intermarried with Capt. Gray who removed to Spartanburg District and for a number of years was a useful and respectable citizen of that District. Fifteen years ago Mrs. Gray was left a widow by the death of Capt. Gray. She was the mother of thirteen children, six of whom have survived her. (eulogy) (July 2, 1831)

Married on the 19th inst., by J. H. Goodlett, Esq., Mr. James McNeely to Miss Juriah Wilson, all of this District. (July 23, 1831)

Died in Spartanburg Village on the 23d inst., after a short illness, George, eldest son of Mr. William Walker in the 14th year of his age... (July 30, 1831)

Departed this life on Thursday morning last, John H. Goodlett, aged about 42 years. This event, though long apprehended from the many years of ill health of the deceased, cannot be otherwise than painful to his friends and acquaintances... He has left an amiable widow and two infant children, to whom this stroke... has created a loss which nothing can supply. (August 6, 1831)

Died in the 36th year of his age, after an illness of nine days, at Belfast, his residence in Barnwell District, S. C., on the 22d July 1831, Mr. Isaac Redfield. He was born in the town of Saybrook, Connecticut. Although Mr. Redfield had resided but six years in South Carolina, his enterprise had extended his reputation throughout the state. Mr. Redfield had but a short time been married, and his infant son knows not the loss which he has sustained. (eulogy) (August 20, 1831)

Died in this town, yesterday morning, Margaret Ann Folker, infant daughter of Mr. Richard Burnham, aged seven months and eleven days. (September 10, 1831)

Having lived for the greater part of his life in this District, the deceased was well known to most of his fellow citizens (ibid.).

Departed this life in Laurens District on Sunday, the 1st inst., Mr. Francis Allison, between 70 and 80 years of age. The deceased had been a pious and orderly member of the Baptist Church more than half of his life. He was an affectionate husband, a kind and obliging neighbor, and a good master (<u>ibid</u>.).

Married on Tuesday last by Rev. Mr. Buist, Mr. Joseph Gaston to Miss Margaret, daughter of Mr. William Caldwell, all of Spartanburgh District (Mar. 13, 1840).



Died very suddenly near Mount Zion, in Spartanburgh District, on the 18th of February last, Capt. Memory N. Chapman, in the 47th year of his age.... The deceased commenced a career of public usefulness at an early period of his life. At the age of 22 years he was tax collector for Spartanburgh and discharged the duties of that appointment with a degree of ability and accuracy due from riper years. For several years he served in the Legislature of the State with credit and honor to himself, and benefit to his constituents. But it was

only in the private walks of life that the excellence of his character was duly felt and appreciated.... The deceased has left numerous relations to lament his death, but the most agonizing affliction falls on the head of a fond and aged father, who, for many years past seems to have lived almost alone on the society and filial kindness of the deceased... Abernathy, and family had spent the winter in North Carolina, and on their return to Alabama was taken ill on the road. She lingered for three weeks... She had been a member of the Presbyterian Church for many years... She has left an affectionate husband and three small children to mourn her departure ... The Lincolnton, N.
