#### WILL FILL VACANT POST

# Action Is Reversal of 1948 Position When Two Others Were Refused Recognition After Convention

WASHINGTON, June 24. Atty. Gen. J.P. Coleman Tuesday was recognized as national committeeman for Mississippi by the Democratic National Committee.

Recognition was granted by national chairman Frank E. McKinney after Mr. Coleman presented credentials showing he had been formally elected by the States' Rights-dominated Mississippi Democratic Executive Committee on June 13 to fill the vacant post. No announcement was made by the executive committee at the time of Mr. Coleman's election.

#### **Went with Senators**

Mr. Coleman was accompanied by Senators James O. Eastland (D., Miss.) and John Stennis (D., Miss.) when he called on Chairman McKinney.

In recognizing Mr. Coleman as national committeeman the national committee reversed its position taken after the Democratic Convention of 1948 when it refused to accept credentials of J.B. Snider and Mrs. Hermes Gautier as national committee members

Mrs. John A. Clark of DeKalb and Clarence Hood of Meridian were then named acting committee members by the national committee. Mr. Hood later was removed from the acting post after the United States Senate Investigating Committee held hearings on charges that Post

Office jobs in Mississippi had been "sold" by member so the so-called pro-Truman faction of the party.

Also, the national committee cut the ground out from under attempts by Mrs. Clark and others to organize a state convention for election of a slate of "loyal" delegates to the national convention in opposition to the regular organization's delegates.

When questioned as to the effect his recognition as national committeeman would have on the efforts of Mrs. Clark and others to organize precinct, county, and state conventions in opposition to the regular party, Mr. Coleman said no national committeeman or committee women have the authority to take such action.

### **Vested in State**

He said that according to the official Democratic Manual, this authority is vested wholly in the state party organization. Therefore, the national committee has never authorized or condoned the action of Mrs. Clark or any other person in attempting to set up a new Democratic organization in Mississippi.

A spokesman for the national committee said Mr. Coleman had "correctly" interpreted the situation and said the national committee had not and did not intend to meddle in state affairs.

Mr. Coleman's election was for the unexpired term ending at the close of the national convention late next month in Chicago.

The state convention meeting Thursday in Mississippi is expected to name a national committeeman and committee woman who will present their credentials when the new committee is organized.

Mrs. Clark will continue to serve as acting committeewoman through the national convention.

"This acknowledges receipt of the certification of the resolution adopted by the Mississippi State Democratic Executive Committee whereby, under the authority vested in it, J.P. Coleman has been named as national committeeman, to fill the existing vacancy in that post," Chairman McKinney said in a letter given Mr. Coleman.

## For Existing Term

"Pursuant to that action, the Democratic National Committee, through me as chairman, hereby acknowledges and recognizes the Hon. J.P. Coleman as the national committeeman for the state of Mississippi for the duration of the existing term which expires at the termination of the forthcoming Democratic National Convention to be held in Chicago."

"I appreciate the confidence which the Mississippi State Democratic Executive Committee has reposed in me by electing me national committeeman," Mr. Coleman said in a statement.

"Chairman McKinney's approval of this action constitutes formal recognition by the national committee of the validity of our state committee and of its authority to act. Al questions in that regard from any source is now definitely settled," he said.

The new Mississippi national committeeman was turned down two years ago by President Truman for the Northern Mississippi District United States attorney.

Mr. Coleman has been recommended by Senator Stennis, but because of his asserted criticism of some of the President's actions, Mr. Truman refused to send his appointment to the Senate.

He is known to favor no action at Thursday's Democratic State Convention which would serve as a bar to the national convention seating the States' Rights-dominated faction.

The annual reunion of the Coleman-Feaster-Moberley family association was attended by a record crowd on Sunday, July 22<sup>nd</sup> at Feasterville, composed of descendants of Robert Coleman (1745-1811), Andrew Feaster, Revolutionary patriot, and Edward Moberley, Revolutionary soldier. The meeting was opened with devotional service led by Rev. Ted. R. Morton, Jr., with Mrs. Sumter Williams at the piano.

Hon, J.P. Coleman, of Winnsboro, presented the president of the association, the Hon, J.P. Coleman, governor of Mississippi, who presided. Gov. Coleman stated that of all the honors that had come to him, he appreciated none so much as being president of the family association. Miss Mary Bess Coleman, secretary, read the minutes of the last meeting. The following officers were elected to serve for the next two years: President, Hon. J.P. Coleman; 1<sup>st</sup> Vice President, Wm. M. Mobley; 2<sup>nd</sup> Vice President, Samuel P. Bolick; Chaplain, Rev. David T. Lauderdale; Asst. chaplain, Rev. John Lyles; Rec. Secy., Miss Mary Bess Coleman; Cor. Secy., Mrs. Etta Rosson; Treasurer, Miss Julia Faucette; Registrar, Mrs. Benton C. Beam; Historian, Mrs. James C. Tennant; Genealogist, D.B. Clayton, Jr.

The highlight of the meeting was the address by Governor J.P. Coleman. He told of the first Colemans, Robert Coleman and his wife, Elizabeth Roe, coming to Fairfield from North Carolina in 1775; and later of the move west by many of their descendants, with other families of this section, in the 1830s and 1840s. His great-grandfather, Isaiah Daniel Coleman, son of Allan J. Coleman, son of Robert, above, went to Mississippi when the Choctaw Indians were moved further west, and his descendants have lived there ever since. Gov. Coleman reported on his work on the Coleman genealogy, which he says is practically ready for the printer, with the exception of the first chapter, on which he will do some more research, to carry the line as far back as possible. He has had research done in Virginia and in England. He related interesting stories pertaining to some of the early Colemans, such as one being fined for "cursing the king", which, he added, "was not too unpatriotic a thing to do at that time." He will call his Mississippi plantation "Fairfield" in honor of Fairfield County, S.C., from which his ancestors came.
