## Summary and Chronology

The progenitor of this particular genealogical Coleman line was Robert Coleman authenticated as being in James City County, Virginia residing on the south side of the Appomattox River where it joins the James River in 1652.

First generation: Robert Coleman Sr. d. 1688, Charles City County, Virginia. On November 5, 1652, Lt. Col. Walter Chiles, of James City County, Virginia, in which Jamestown and Williamburg were located conveyed to Robert Coalman a tract of 813 acres of land on the south side of the Appomattox River in Charles County, now Prince George County.

> On September 29, 1668, Robert Coleman Sr. a land patent to a part of this same land.

May 20, 1663, Robert Coleman Sr., by deed of gift conveyed to his son Robert Colman Jr-part of my land on the south side of the Appomattox River.

Robert Coleman Sr. died in 1688. In December of that year, it was ordered that the witnesses to Robert Coleman's will do not appear at the next court.

Second generation: Robert Coleman Jr. b. ca 1642-d. ca1721. On October 20, 1665 Robert Coleman Jr was granted 450 acres of land in Charles City County, Virginia- south of the Appomattox River, beginning at the headline of Robert Coleman Sr.

On November 10, 1717, Robert Coleman Jr of his own motion was acquitted from paying the county levy for the future. ( age of infirmity )

On October 9, 1716 Francis Coleman Sr and rancis Coleman Jr of Bristol Parish, Prince George County. Virginia conveyed to John Coleman a tract of land " where on he now liveth " This land was not patent ( Horse Pen branch of the Apportation ) to John Coleman until July ninth, 1724.

#### Third and Fourth generations:

We have already seen that Francis Coleman was a surety in 1688 which established his birth before 1667. He appeared as the owner of 150 acres of land in Prince George County, Virginia on the 1704 Quit Rent Rolls.

On October 9, 1716, Francis Coleman Sr. and Francis Coleman Jr. of Bristol Parish, Prince George County, Virginia conveyed Robert Bolling a tract of 100 acres of land on the south side of the Appomattox River ( Deed 125 ).

On July 13, 1719 Francis Coleman Sr. conveyed to William Parsons 150 acres of land "whereon the said Francis Coleman late did live at a place called Baylys. Edward Goodrich, Attorney for Honor Coleman, wife of Francis Coleman, appeared and relinquihed dower. The Power of Attorney was dated April 14, 1719.

On August 7, 1719 Francis Coleman Jr., and wife Mary his wife conveyed 150 acres of land to Adam Sims. ( deed 359 ).

On November 10, 1721 (deed 500) Francis Coleman Sr. conveyed by deed of gift to his son Francis Coleman Jr. 100 acres of land on the South side of Butterwood Run on Horse Pen Branch, land where Francis Coleman Jr now liveth.

When Robert Coleman of Halifax County, North Carolina purchased land on New Horse Pen from William Roberts, Francis Coleman witness the deed.

Bristol Parish Register-Francis Coleman Jr and Mary his wife also had a daughter Amy born in 1718, and a son William born 1733.

#### Fifth generation:

Robert Coleman " The Elder " of Halifax County, North Carolina

He patented land in Edgecombe County in 1756. Part of Edgecombe County later became Halifax County, North Carolina, Page 174 Land Deed Book 8, Halifax County, N.C.

In the will of Thomas "athis dated October 15, 1764 admitted to probate in Halifax County North Carolina, Francis his daugther was the wife of Robert Coleman the Elder.

On January 25, 1774 Land Deed Book 13, page 32, Robert Coleman and Frances Coleman, his wife conveyed 357 Acres in Halifax County, N.C. She signed with an X and he used RC.

Will of Robert Coleman made March 31, 1795, proved Jan. 20. 1796 Recorded Book 2, Pages 117, 118. Apt 2, File 51. Fairfield County, South Carolina.

The marriage ceremony was performed by his brother David Roe Coleman. Henry Jonathan Coleman was a soldier in the War of 1812. Enlisted at Winn's Bridge, South Carolina. Perved from 10/6/1812 till 2/28/1815 in Capt. Wm. Nevitt's Company of South Carolina Militia. Acquired 2000 acres of land. Six sons served in the Confederate Army- only two survived. W.O. 10-397, He was a hatter by trade.

Henry Jonathan Coleman was born 6/22/1793, Feasterville, Fairfield County, South Carolina, the son of Robert Coleman Jr and Elizabeth Roe. He died 2/3/1861, Feasterville, Fairfield County, S.C. married 12/31/1818 Feasterville to Mary Feaster born 1/10/1798, the daughter of John Feaster and Drucilla Moberley. She died 11/6/1873 Feasterville, Fairfield County, S.C.
