

JOHN ELLIOTT ROBINSON

John Elliott Robinson died before he was forty but by his marriage to Mary C. Horton became the father of nine children, the last two being twins. The first born died at birth and one of the twins also but the others for the most part lived long and useful lives and their descendants are numerous and prominent.

John Elliott Robinson himself was a soldier in the southern army and died of a fever in 1863 while at home on furlough. Mary Horton, *Hartin's* the wife and mother of this family must have been a woman of unusual strength of character to have kept her flock of young children together and have given them the creditable start in life which each one received.

Our records of these are rather brief but they indicate a very unusual family group.

The eldest, James Edward Robinson, was married twice but our records lack the dates for the children of the first marriage, although the names are given. There are doubtless a number of grandchildren belonging to this marriage whose names are not here included as the youngest son, William Edward Robinson left four children when he died, two sons and two daughters. William Edward Alexander Wyatt, Louise P. and Martha. All of these are supposed to have married.

We are more fortunate with the second marriage and the resultant five children. James McEe Robinson lives at 765 Spring St., Macon, Georgia and it is understood is in possession of the old family bible. He has one son, named for himself.

Robert F. Robinson, the next son lives at 25 Wright street, Sumter, South Carolina. He married Jessie Vogt and has three children, Robert F., Eben Davidson and Eleanor Wallace. He is the Commercial Agent for the Atlantic Coast Line at this place, having taken up railroading like so many of his father's family.

To Charles Lawton Robinson, the seventh child of James Edward Robinson we are indebted for the outline of his father's family and the addresses of most of those. His wife was Lula Blaine Banks and they have two small children, Mary Lee and Henry Edward. He lives in Chester, South Carolina and writes of himself - "I am just a plain, honest citizen, proud of my Scotch-Irish blood and heritage. I have a common-school education, was born a Democrat and professed my faith as a Baptist. I am a jack of all trades and not much good at any but for the present and for the past ten years have been a rural mail carrier out of Chester."

Of the eighth child, Fred Leonard Robinson, born September 17, 1896, we have no record or address.

The ninth child, Lee Whitley, died in 1914 at the age of fifteen.

This brings us to the third son of the original group, William Morrison Robinson, still living at this writing (1931) in Macon, Georgia, where he is a well known Civil and Valuation Engineer. In addition he is President and General Manager of the Augusta and Summerville Railroad Company. His busy life has evidently been spent in railroad construction and operation. He was born December 30, 1849 and married Minnie Lee Allen of Newton County, Georgia in 1889. Their family was small, consisting of three sons and a daughter. The second son, Charles Edward, died when about ten years old. William Morrison, Jr., from whom our information regarding this family was secured, is also a civil engineer and lives in Augusta. He was married to Sarah Blanchard Watson. Henry Allen Robinson, the other son, married Roberta Vodelte and is the father of the only grandchild, Anzie Vodelte Robertson. The daughter of William Morrison Robinson's family is Mary Laura, who is still at home and unmarried.

The fourth child of John Elliott Robinson was Caroline M. who became the wife of W. E. G. Castles. Of her three children, Edna Jane married George W. McKeown and John Elliott Castles married Bessie White, but the record does not show any children for any of these unions. Willie Agnes Castles is unmarried and is employed in secretarial work in an insurance office in Chester, South Carolina.

The fifth child was Robert Henry Robinson who died in 1901, leaving three children born to him and his wife Salise Coleman, to whom he had been married in 1877. The oldest, Daisy Evelyn Walters, has an only son, Henry Robinson Walters, recently married to Mayme Breden. The second daughter, Celestye Collie, had two daughters, the oldest Frances, married to H. B. Walker and they have the only great-granddaughter of Robert Henry Robinson, whose name is given as Dokie. Dorothy Collie the second daughter is unmarried. Celestye Collie died in 1929. W. H. Robinson, the son is unmarried. He is a physician, at present connected with a hospital in Jersey City, 1025 Boulevard.

John A. Franklin Robinson comes next, born in 1856 and died in 1921. Mrs. Robinson, who was Mary M. Hunt, is still living at 572 Logan St., Atlanta, Georgia. During his lifetime he was connected with the Georgia Railroad. Eighteen years before his death he suffered an accident which resulted in a broken hip and although active until a month before he passed away, blood poisoning from this cause precipitated the end. He was born in Fairfield County, South Carolina and went to Georgia at the age of thirty. He had five children, all of whom are living and three of whom are married and have small families as may be seen by referring to the record. Lillie May and Robert Harnden are reported as still single.

Mary Victoria Robinson is the widow of J. W. Coleman who died in 1928. She is one of the two living children of John Elliott Robinson.

Her oldest son, Dr. John F. Coleman, was married twice and has seven children, six of whom are living and of school age or beyond. His second is Bertha May, now Mrs. J. P. Eaddy, with one daughter. Georgia

Robinson Coleman is Mrs. Walker J. Sojourner who has two daughters. The next child, Susie Victoria, died in girlhood. The remaining three are Robert Wilcy with a young son of the same name, Minnie Louise, Mrs. James C. Tennant, also with a young son, and Margaret Coleman whose husband is Broedus A. Robinson, by whom she is the mother of three.

Mrs. J. Wilcy Coleman has been one of the most helpful and efficient correspondents in the assembling of records and information relating to her father's family and this acknowledgement is due her for the assistance rendered.

The last member of this family was Mrs. Margaret P. Robinson Clark who died in 1911, leaving three children, one of whom, Mary, the wife of Robert D. Vandiford, has also passed away. Her son is Frank Clark, who married Leta Ketchins and has three daughters. The youngest of Margaret Clark's children is Mrs. James W. Roberts of 115 E. Baugh St., Greenville, South Carolina who has reported seven children, whose ages range between 1914 and 1928, including one pair of twin sons.

There was another son in the John Elliott Robinson family named Samuel Milton, who evidently died young.

Taken altogether this is one of the noteworthy families in the Elliott record. With no exceptions the various members and their descendants have been enterprising, well educated and good citizens wherever located. Practically all of them are in the southern States and a credit to the Elliott name and blood is traced from Jeannette Elliott Robinson.

*These dates are not absolutely certain in all cases. Mrs. Elizabeth Orr Fee, a daughter of Margaret Elliott Orr, said there was a son, whose name was supposed to be John or John Alexander, but there is no evidence supporting this. Adelia Doddridge Elliott Dye, a grand daughter Daniel Elliott, the Second, always claimed that this son was known as Francis or Frank. There is definite knowledge that he lived in Fairfield County, So. Carolina, and later migrated to Kentucky.

This family also lived in the same county as the preceding where the parents died and were buried, presumably in the neighborhood of Monticello. All their children are reported to have migrated to Arkansas, probably after the Civil War, when there was such an active westward movement and all of them are now dead. It is likely that some of the next generation may yet be located but none of their relatives in South Carolina know anything about them. As stated below, these two families belonged to John Robinson's first marriage. Mrs. Alice Wilson Heron, a daughter of the second marriage to Gailie McFreight, is the only person remembering these members of the first family.

It is evident that Martha Elliott Robinson died soon after the birth of her second daughter and it is known that her husband re-married as we have the names of several additional children whose birth dates are not given but the names of the persons to whom each one was married is in the record as given below.

- J. W. Robins, married to Jane Jennings.
- James Robinson, married to Elizabeth Wilson
- Elizabeth Robinson, married to David Wilson.

It is also known that other children, in addition to those names were born to this second marriage of John Robinson.

Marion B. Jennings, an attorney of Sarasota, Sarasota County, Fla., has compiled and written a very complete history of the Jennings family which covers the line to which he belongs, that of Robert Henry Jennings. From this carefully written outline, which reveals the legal dress of an attorney, have been taken the data and other information needed to round out this record, using so far as possible the text of the author. (This data was compiled in 1931)

Nancy Malinda Robinson was born December 21, 1816 in Fairfield County, South Carolina. She married Henry Reid Jennings, who was born Mar. 28, 1815 in the same county on January 21, 1836.

Henry Reid Jennings died within a few years after the age and Nancy remained a widow for many, many years and finally on November 1, 1881, and was buried at Bethel Church about twelve miles southerly from the town of Wimsboro, the county seat of Fairfield County. Her grave was marked by her son, Robert Henry Jennings as was also the grave of her mother Jeannette and her father Robert Robinson who were interred in what is known as the old Brick Church Burying Ground in the same part of Fairfield County. There were only two children in the family, as noted above, but the large families of both of these and their descendants constitute a numerous company.

These two girls married: Mary Jane to William Armstrong and Martha S. to Charles Martin. Extensive search has resulted in the scant references to be found in the genealogical record following these two.

This brings the record down to Jane or Jennet Elliott who married Robert Robinson and through her ten children left a most numerous posterity. The various spellings given her name are quite confusing but the name on her gravestone in the old cemetery is carved "Jane." Many of her descendants became prominent in Fairfield and Chester Counties, S. C. while others migrated westward and became pioneers in Texas. Her oldest daughter Martha married B. H. Smith but left no children although she lived many years.

From the remaining eight children who were married (one son, William McKinnear, having died at the age of sixteen), a very numerous posterity resulted. Several years before her death in 1885, a compilation of her descendants was made by one of them, a copy of which was furnished me by her grand-daughter, Mrs. Maggie Tate of Lisdale, Texas. This was dated August 1, 1873.

It will be noted that only her children who had married and had children are included, as the record shows there were eleven in her immediate family. A complete compilation at the present time would be difficult on account of missing data but it is safe to assume that the number has more than doubled since that date.

An old tintype photograph of Jane Elliott Robinson, loaned by Mrs. Janet West of Blythewood, South Carolina reveals the face of a woman of strong personality and the accompanying autograph maintains the same impression. She was buried in the Old Brick Church cemetery. Because of the prominence of this family it is given more than usual space in these pages.

The second daughter, Nancy Melinda Robinson, married Henry Reid Jennings and although they had but two children, a son and daughter, they both founded large families. Miss Jane married Dr. Seymour Russell and their family included ten children who are widely scattered throughout the South. A full sketch of both Eliza Jane and her brother Robert Henry Jennings will be found in the pages where the family record has been placed.
