Probate date 13 August 1713. Witnessed by Elizabeth Faulconer, Edward Faulconer and Samuel Dry.

"Unto my son Robert and my daughter Elizabeth each of them twenty shillings.

Unto my son Edward

Coleman half that tract of land that I purchased of Captain Thomas Pettit, the whole tract being

488 acres, that part next and adjoining to Botem's line. Unto my daughter Grizzel Chamberline the

other half of that land I purchased of Captain Thomas Pettit and for want of issue, to my daughter

Anne. To my loving wife Ann Coleman all that my tract or seat of land that I have in possession

at the place where I now live during her natural life and at her death my son Spilsbee Coleman have

the land. All the rest of my lands unto my daughter Anne Coleman. All the rest of my estate to my

loving wife Ann Coleman who I do appoint Executrix." (WB 13, p. 439, Essex County, Virginia)
