I believe my John Cooper, b. 1812, and Athey McDaniel to be brother and sister and their father could be the William Cooper on the Richland County 1820 Census. He was in Richland County as late as 1828 and 1830 when his name appeared on the Inventory of the Estate of Gnunson Tedwell, Pages 359, 360, 367 (copies of these documents ordered from the SC Archives, 15 Feb 1991).

Jesse Cooper petitioned the court to sell or divide the land owned by his brother James Cooper, SC Richland County Probate Court, Box 64, Pkg 1590, 25 Jan 1841. Jesse Cooper and a John Schultz ended up buying the property on 5 Apr 1841. One-half went to his brother James's widow, Martha Ann, and the other half was divided among James's "legal heirs", his five brothers and six sisters.

The land was on Big Branch Waters of Crane Creek of the Broad River, adjacent to land of Ezekiel O'Quin, Estate of John Abbott, and Dolly Wallace and Andrew Wallace containing 146 acres being part of that originally granted to Thomas Franklin.

Why wasn't Jesse's name scratched through? Was it because his brother George Cooper assumed the responsibility of Jesse and Ann's children? By 1858 the children's ages would be: Clifford, 21; Jesse, 20; Green, 17; Keziah, 14; and Douglas 11. (Reference 1850 Census, Richland County, SC, Page 43, Dwelling 27, Family 27.)

John Cooper was the brother of Joel Cooper (b. ca 1780, VA). John and Joel were shown on the Richland County, SC, Census of 1820. John had a wife and two sons at the time. Court documents of estate papers of Dawson Wages, Richland County, SC, 1850, prove that John and Joel were brothers. John Cooper was a magistrate for 14 years in Richland County prior to leaving SC and moving to Muscogee County, GA. John's oldest son (name unknown) did not go to GA with the family. John, wife, and two sons (another son was born after 1820 Census) were shown on the Muscogee County, GA, Census of 1840. By 1850, John had moved to Tallapoosa County, AL, and was shown on the census as living alone, 77 years of age, b. NC, farmer. Apparently his wife had died. One of his sons, William C. Cooper, is listed on the Muscogee County, GA, Census of 1850, b. 1815, in SC. He was married (wife, Caroline), and had a three year old son named John W.

John Cooper (b. ca 1772) came back to SC to testify in court in 1850. It is not known if he remained in SC or returned to AL. Since his family lived across the river from him in Muscogee County, GA, I would imagine he returned home.

Reference Petition of Estate of James Cooper, Richland County, SC, 25 Jan 1841, in which the LEGAL HEIRS of James Cooper were listed: Widow, Martha Ann; Brothers: Jesse, Thomas, William, John, Ithamur; Sisters: Polly, m. William Rose; Nancy, m. John McDonel/McDaniel; Atha, m. James McDonel/McDaniel; Lucy Cooper; Harriet Cooper; and Catherine Cooper. There was no mention of a mother or father. According to SC Genealogist Brent H. Holcomb, if parents were alive, they would have been listed as Legal Heirs as well.

Joel and Elizabeth Cooper were the only couple with a large number of unaccountable children in their household. If they were the parents of all of the above children, why weren't they listed as Legal Heirs?

There was also a William Cooper on the Richland County, SC, 1820 Census; he was not on the Richland County, SC, 1830 Census (see MRIN 77).

Joel Cooper's older brother "Old Squire" John Cooper left Richland County, SC, about 1832/33 and moved first to Muscogee County, GA, and then to Tallapoosa County, AL. He returned to SC in 1850 with John Duncan, Jr., to testify at the above mentioned Dawson Wages Estate settlement. Old Squire John Cooper had a son, William C., b. 1815, SC, who moved to Muscogee County, GA, with his father in 1832/33 and he married there. William C. Cooper, age 35, b. SC, Gun Maker, m. Caroline, age 23, b. GA, and son John W., age 3, b. GA is shown on the Muscogee County, GA, Census of 1850.

According to the Richland District Census of 1850, Joel Cooper was living there, 70 years of age (would have been born in 1780), blind, and a pauper. Both he and wife Elizabeth were shown as being born in VA.

Proof that John and Joel Cooper were brothers is shown in the Richland County Probate Journal 1840-1864, PP 46-51, Estate of Dawson Wages. Mrs. Mary Thomas (also a witness in above case) is almost certain to be a sister of John and Joel Cooper and the mother of Renatus Thomas (see Brent H. Holcomb's letter of 22 March 1989).
