Kershaw County Deeds Book S, pages 380-381: South Carolina, Kershaw District. Benjamin Umphries of State and District aforesaid, for natural love and affection for Polly wife of Wiley Watkins and for one dollar paid by Nathaniel Umphress of same, land in Kershaw District, on Jumping Branch, adj. Sumter, Wm Hall, and myself, 100 acres part of 200 acres I purchased of Elias Wilson, in trust for the use of Mrs. Polly Watkins wife of Wilie Watkins... 21 April 1851. Benjamin Umfress (X), Wit: Nathan Umfress, W. H. Ratcliff. I accept of the above trust, N. A. Umfress. [plat included]

Kershaw County Deeds Book T, pages 755-756: Nathaniel Humphreis of District and state aforesaid, for \$5 and love and affection towards my brother Benj Umphries Jr, land on head waters of Bell Branch and Black River, 253 acres, part of land former owned by John Williams deceased, with this acception that my father and mother Benj Humphreis and Penelope Humphries shall have the free use and priviledges belonging to said land during their natural life ... 18 April 1857. N. A. Umphries (LS), Wit: John Folson, Penelopy Umphries (X).

Kershaw County Deeds Book BB, page 448: South Carolina, Kershaw District. Penelope Unphress, Nathaniel Unphress, Nathan Unphress, Benjanin J. Unphress, Wiley Moore and Melissa Moore, Jonathan Beasley and Penelope Beasley heirs at law of Benjanin Unphress deceased for \$38.85 paid by Wiley Watkins, 37 acres part of land granted to Janes Tiller 6 June 1796, conveyed by hin to Thomas Bradshaw, and by Thomas Bradshaw to John Williams, and by Elias H. Wilson to Benjanin Unphress deceased, adj. S. B. Hall, said Wiley Watkins... 2 Feb 1864. (This proves that Benjanin Hunphries had died by 1864 and his widow Penelope was still living.)

Lancaster County, SC Deeds, Book N, page 132: South Carolina, Lancaster District. Benjanin Humphress of staet and district aforesaid, for \$100 to E. H. Wilson, one third part of tract of land on branches of Bear Creek adj. Glass Caston, 297 acres on south side the part whereon I for nerly lived... 16 August 1836. Benj Humphress (X) (LS), Wit: Nathaniel Humphress Jr., John Humphress (X). Proved by Nathaniel Humphress Jr., 10 Aug 1836.

State of South Carolina, Lancaster District. Twenty one years ago I gave to my son Benjn Humphress verbally the within land & put him in possesson of it he has lately contracted sold or exchanged the same land with E. H. Wilson as appears within, now know ye that I hereby release & relinquish to the said E. H. Wilson all right, title & interest that I have... 16 August 1836. Nathaniel Humphress (LS), Wit: Thos Twitty, Robert Marshall, John W. Marshall. (This proves another generation before Benjamin Humphries, an older Nathaniel Humphress of Lancaster District, SC.)
