Generation No. 1

1. JOHN¹ DIXON, SR was born Abt. 1719 in BARROW PARISH, KINGS CTY., IRELAND, and died Abt. 1804 in KERSHAW CTY., S.C.. He married ELIZABETH Abt. 1738 in BARROW PARISH, KINGS CTY., IRELAND.

Notes for JOHN DIXON, SR:

John Dixon, Sr. with his wife Elizabeth arrived in Charleston, South Carolina on July 22nd 1753 on the Snow Hitchcock fom Whitehaven under command of Captain Peter Gibson. They arrived with four children: Sarah born 1739, Thomas born 1744, John Jr. born 1748 and Jane born 1751. They appeared before the Charleston, South Carolina council on August 6, 1753 and petitioned for land bounty of 300 acres but were denied bounty because, " they did not have a certificate of character from their Congregation in Ireland."

Sources: The South Carolina Magazine of Ancestral Research, Volume XV11, Winter 1989, Number (1) states: "Read the Petition of John Dixon humbly Setting forth that he Petit'r came to this Province from Ireland with Intent to settle with his Countrymen and having a wife and four Children viz Sarah aged about 14, Thomas about 8 years, John between 4 & 5 years, Jane under 2, for whom nor yet for himself has any Land been assigned, he humbly prays his Excellency and their Honors to order the Surveyor General to cause 300 acres of Land to be Laid out to the Petitioner free of Chrarges....Cha's Town the 6th of August 1753.

The said Petition being considered and the Petitioner appearing and affirming as a Quaker to the truth of his said Family Right the Prayer as to the Land was Granted.... but as the Petit'r did not produce a Certificate about his Character from the Congregation whence he came no Bounty or Charges were allowed." John applied again for Land on January 6th, 1756, "He says he is from Barrow Parish in Kings County Ireland (now County Offely), that he is a Protestant of the Church of Ireland and not a Quaker as previously stated in 1753." He again says he has four children. John Dixon, Sr. was probably born about 1719. He was given 300 acres on Granies Quarter Creek in Kershaw District by the Wateree River, all borders of his land were vacant. There was a trail shown through his property paralleling Granies Quarter Creek called "Road from Pine tree to Lynche's Creek". (Pine tree was the oldest name of Camden, South Carolina). He was given this land because he produced a certificate of good character signed by his neighbors from Ireland: John Belton, Henry Belton, Josiah English and witnessed by Samuel Wiley. In a petition on the same day in 1756 one Dennis Hagen of Dublin, Ireland, who came on the same ship Hitchcock, (who had indentured himself to Robert Belton) applied for land (he was now a free man) in the Camden area. Ms Rebecca Starr, who has helped Woodward Rion Dixon with some of his research, feels that when John and his family were not granted any land in the beginning that they probably squatted land and or worked for the Beltons. John Dixon, a planter, carpenter and Wheelwright as stated in a land lease of October 31, 1758 from William Sloan to John Dickson of Craven County (early Kershaw County) in the province of South Carolina. On November 1st, 1758, John Dickson, carpenter and his wife Elizabeth receive 200 pounds for 300 acres on the Northeast side of Wateree River on Granies Quarter Creek in Craven County, bounded on all sides by vacant land, from William Sloan. There are several other land transactions in the Beaver Creek and Wateree River areas of Craven District which was later in both Lancaster and Kershaw Districts.

John Dixon, Sr., next appears on the muster roll of Colonel Richard Richardson's Battalion in the Cherokee expedition to Fort Prince George in the Mountains of North Carolina. He is listed in Captain William Cantey's Company. His neighbors, Nehemiah Joyner, Jeremiah Joyner, William Sloan, Abraham Stover, Edward Mobley, Clement Mobley, Joseph Brown, John Marshall, James Marshall and others. They were paid 38 pound each. It is my understanding (Rebecca Starr) that they were conscripted or required to go to prevent further raids on their families by the Catabaw Indians and on their crops by the Cherokees.

John Dixon, Sr., four children all married. Sarah the eldest child, born 1739 married William Maxwell and in the estate of William Maxwell of February 11, 1795 which had adminstrators Thomas Dickson and John Maxwell mentions heirs Polly, John, Betsy and the widow Sarah Dixon Maxwell (John's oldest daughter).

Thomas Dixon born 1744 married Mary Gardner. Their daughter Elizabeth married Jacob P. Lucius of Camden, South Carolina on Tuesday, December 24th, 1816. This marriage is reported in Camden Gazette Newspaper, Thursday, December 26, 1816. Mrs Mary Gardner Dixon appointed her nephew Samuel Dixon (son of John Dixon, Jr.) to be trustee of her estate and guardian of her daughter Elizabeth Dixon Lucius' children. These and many other papers establish the close association between these two Dixon families and confirm that they are the Thomas Dixon and John Dixon who are the sons of John Dixon, Sr., mentioned in his petition for land in 1753.

Note about John Dixon Sr.

Records indicate that John Dixon, Sr., was a Quaker when he arrived in South Carolina or maybe became a Quaker later on in life. Quakers have been in South Carolina since 1666, and a few groups have had such an impact for their size as have these simple, peaceful Friends. From the founding of Charleston in 1670 until the establishment of the Church of England in 1705, the Friends played a major role in the political leadership of the infant colony, at times almost dominating the government. Even after 1705, some low country Quakers compromised their testimony against oaths to retain seats in the colonial Assembly and formed political alliances. Numbering less than 3% of the population, they provided two of the Governors during the crucial proprietary period.

The total number of Quaker families throughout the 175 year period from 1666 to 1840 was only around 2000 in South Carolina and Georgia, with a total of around 9000 individuals. Nearly 1900 of these 2000 failies are identified in this book.

About two-thirds of these Quakers were located in the Piedmont region during the brief period from 1750 to 1820. In 1801 most friends began leaving for the Midwest because of their opposition to slavery. By 1840 there were no Meetings still strong enough to have regularly scheduled worship and many of the remaining members joined other churches. By 1900 there were probably no more than a dozen Quakers left in South Carolina and Georgia, though there are now active Meetings in Columbia and Charleston, S. C., and Atlanta, Augusta, Savannah, Macon and Statesboro, Ga.

Quakers were among the earliest pioneers in the Camden area, on the Pee Dee River, and in the Piedmont counties of Newberry, Union, Laurens, Spartanburg, Greenville, Saluda, Edgefield, and Anderson.

I have found in my research this interesting fact: John Dixon, Sr., is listed as a Quaker along with his family, Ch: Jane b1751, John, Jr., b1748, Sarah b1739 and Thomas b1745. (Arv. SC from Ireland 1753: had land at (Bush River 1754).

Dixon, John, Jr. died 1798, wife Elizabeth, Ch: Sarah, Polly, Lucy, Rebecca, Theeny, William, Samuel.

South Carolina History of the Liberty Hill John Dixon Family, by Dr. Woodward Rion Dixon, 200 sweet Bay Road, Hartsville, South Carolina 29550.

1. First documentation: S. C. Council Journal, Vol. 21, page 569.

On August 6, 1753, John Dixon, from the Province of Ireland petitioned for land with his countrymen on the Watree. Asked for land for his wife and four children: Sarah, aged 14, born 1739; Thomas, aged 8, born 1745; John, between 4 and 5 years, born 1749 and Jane, under 2 years, born 1751. Asks for 300 acres. Appeared and affirmed as a Quaker but as the petitioner did not produce any certificate from his congregation where he came, no bounty or charges were allowed.

Mr. John Alexander of Ireland also rejected on the next day, August 7. 1753. Next petitioner was Margaret Warbuoton of Ireland who came with her country people and relations to this province on board the (Snow) Hiscock under Captain Peter Gibson of Whitehaven.

2. Second document on S. C. Council Journal, Vol. 25, pages 26-27, jan. 5, 1756. Denis Hagen claims to be an Irish protestant from Dublin arriving in Charleston, S. C. on the ship Hiscock about three years ago as an indentured servant to Robert Belton with whom he had served his time and was free.

On the same date and at the same time or on the same page, John Dixon petitions as coming from the province of Ireland with his wife and four children on the Snow Hiscock as a free Protestant and that he never had had any land or bounty in the province for himself, wife, nor his said four children. He asks for 300 acres of vacant land.

A certificate was attached saying, "We the undernamed do certify that we know John Dixon, late of the Parish of Borrow in the King's County, Ireland for many years past and that he is a protestant of the Church of Ireland as by law established, and descended from an honest Protestant family and that he always behaved himself honestly and justly given under our hands this 31st day of December, 1755." Signed: John Belton, Joseph Mickle and Joshua English. "I know the above subscribers to be honest men and believe the above to be true." Signed: Samuel Wyly.

The petition was approved.

3. From colonial plats, Vol. 6, page 129.

300 acres of land deeded to John Dixon in Craven County on the Northeast side of Wateree River or Granny's Quarter Creek bounding on all sides by vacant land. The land was a square with Granny's Quarter Creek running through one corner, the road from Pine Tree to Lynches Creek running through the middle, and another creek through the other corner (un-named). The land surveyed and dated January 30, 1756. Signed: Samuel Wyly.

4. Pay list of Col. Richard Richardson's battalion of the Cherokee Expedition under pay list of Captain William Cantey appears the name of John Dixon, Edward Mobbly, Abraham Stover, Joseph Brown, Henry Hale, Nehemiah Joyner, Richard Hilton, Jeremiah Joyner and may others. About 1760 I believe is when they marched to Fort Prince George (Keowee).

5. John Dixon of craven County, carpenter, and his wife Elizabeth, sell 300 acres plantation to William Sloan, planter of Craven County. The 300 acres are on Granny's Quarter Creek on the North side of Wateree River in Craven county and still bounded on all sides by vacant land on October 31, 1753. Witnessed by John Alexander, John Gray and John Hewitt.

6. July 2, 1765, John Dixon exhibits a memorial for 50 acres of a plantation on the Northeast side of the Wateree River on Granny's Quarter Creek bounded on the South by land of William Sloan and on all other sides by vacant land. Surveyed by John Belton.

7. Recored January 15, 1770: John Dixon buys 100 acres on October 3, 1769, located in Craven County on Northside of Wateree River, bounded on Northwest by Nehemiah Joyner and Southeast by said John Dixon, purchased from Eleanor Adamson and on the West by the Wateree River, and on other sides by vacant land.

8. July, 1783: State of S. C. to John Dixon for one horse loast at General Sumter's surprise on the Catabaw River in August, 1780, appraised at 75 pounds and sworn by Jeremiah Hamilton and Samuel Patterson.

9. Petition of inhabitants of Beaver Creek and White Oak settlements, near the upper part of Kershaw County to S. C. Senate in General Assembly at Columbia, S. C., in 1791, concerning Lancaster and Kershaw County Boundaries. Signed by John Dixon, James and Lemuel Perry, John Kirkland, Robert Lee, John Lee, Shaw Brown, Robert Brown and many others.

10. Will of John Dixon, May 1798, shows eight children living heirs. Jane not mentioned among 5 youngest children. Lucy's share was divided among her siblings. Persons purchasing property were Sion Coates, George Perry, Arthur Cunningham, William Kirkland, James Perry, William Dixon, Polly Dixon, Richard Harrison and several others. Administrators were William Dixon and Samuel Dixon.

11. March 8, 1803. Will of Thomas Dixon of Kershaw District of S. C. Surviving wife Mary, daughter Elizabeth. Much land, cattle, horses, slaves. Witnessed by James Maxwell. Elizabeth later married Jacob P. Lucius and had a son. Thomas Dixon Lucius, Susannah K. Lucius, P. Jacob Lucius, Laras L. Lucius and Maryan Lucius. Executors of Estate: Samuel Dickson, John Barnes, William McCullock on October 15, 1831.

12. General Assembly of State of S. C. makes resolution appointing Samuel Dixon, John Bell, and Robert Davidson as managers of election for Kershaw District at Liberty Hill, December 20, 1822. Noted that Joseph Cunningham refused to serve.

13. June 12, 1838. Last will and Testament of Samuel Dixon. Filed and sworn to by Tilliam Lee Dixon, William Dixon, David Mabry Mobley, John Barnes, James Benson and H. Robertson.

14. Constituion of the Liberty Hill Democratic Association. Dated May 11, 1865. Charter Members: John G.

Richards, T. G. Thompson, William Dixon and Pattersons, Cureton, McDow, Browns, Cunninghams, simpsons, Johnsons and etc.

15. Church Record of Liberty Hill Presbyterian Church show that William Dixon was a founding elder of that church and an elder for 51 years. They were in the Beaver Creek Presbyterian Church before that, as were his Father, Grandfather and Great Grandfather and Uncles and Aunts.
