I, Charlotte R. Douglass of the Town of Winnsborough State of South Carolina being of sound mind and memory, do declare this to be my last will and testament.

I give and bequeath to my son John W. Douglass all the fixtures, household goods furniture and effects, everything contained in this his home in the Town of Winnsborough also all that I may have in my home house which said and tract of land is willed to him by his Father to be his after my death any of the things contained in each house is his, he having purchased them.

I also give and bequeath to my son John W. Douglass aforesaid any money that I may have in my possession, and any money that may be owing to me from the sale of any property of any kind that I may have disposed of or have on hand to dispose of, I make provision for my son in this way as some reparation for his lack of education which was due to the losses sustained by his Father, causing him to be unable to assist him as he desired, whereas our son was thrown at an early age on his own resources, and only by his own efforts made his way through College and moreover he did not receive the home care that was due him, having to leave home to enter into his work for a living.

I am trying out of my small savings to repay him for his care and kindness to me all along through his life and especially in my declining years I leave him with only one request that is to abstain entirely - not touch strong drink that has proven such a snare and curse to him I pay that when I am gone he will obey me in this.

To my other three sons James E. Thomas J. Charles H. Douglass I will say that I grieve not be able to give them out of this small pittance but I am convinced they are each in better circumstances than their younger Brother and for him I crave their love and assistance when I am gone. I pray that they may help him in any and every way possible, and prove to be more loving with each other than before.
