Be it remembered that I CHARLES B. DOUGLASS, of the County of Fairfield and State aforesaid, do make publish and declare this to be my last will and testament.

Item 1. It is my will that all of my just debts be paid.

Item 2. I devise and bequeath all of my property real and personal to my wife MARY E. DOUGLASS and my son CHARLES B. DOUGLASS JUNIOR for the period of their joint lives, to be held and enjoyed by them equally; and at the death of either, it is my will that all of my said property shall be to the survivor for life, with remainder at the death of the survivor to such issue as my said son CHARLES B. DOUGLASS JUNIOR may leave living at the time of his death. I appoint my wife MARY E. DOUGLASS and my Son CHARLES B. DOUGLASS Jr. Executors of this will. Executed by me this 21st day of Nov 1906.
