Widow Emily lived in Clarke Co, AL in 1840. Presumed children are Abraham J. 1809-1892; Osman A. ~1812-1874; Julia M. ~1816-after 1866; and Darrington J. ~1819-bef 1900. The 7 missing children were likely Meranda born ~1803; unknown son b~1806; unknown daughters born ~1813, 1817, 1821, 1823; and an unknown son b~1827. Children born before 1820 were likely born in SC and those born after 1820 either in SC or Clarke Co, AL area.
