He served a tour against the Cherokees under General Sevier, and was in several

→ skirmishes with those Indians...Married in North Carolina....came to Greenville in 1783. He lived more than sixty years at the place he first settled when he came to Greenville.... For several years he was in receipt of a pension. (ibid.)

Died at his residence in Lafayette County, Mississippi on the 28th of April last, after a severe illness of five or six weeks, of what is called Winter Fever, Mr. Peterson Boroum in the 39th year of his age, leaving the beloved partner of his joys and sorrows, with a large family of children.... (July 18, 1845)

William Andrew Jackson Boroum died at the residence of his father in Lafayette County, Mississippi on the 13th of April 1845, in the 30th year of his age.... The only family or charge that he left was that of his aged parents, several sisters, and an only surviving brother, the youngest son of his parents. Communicated. (ibid.)

Henry in the 24th year of his age, with Typhoid Pneumonia, of which he was ill but a few days.... Capt. Henry had been a member of the Presbyterian Church nearly three years, and... he adorned the profession he had made. (eulogy) (ibid.)

Died at his residence near the Blue Ridge, in Henderson County, N. C., a very extensive acquaintance, having for many years kept a public house at the foot of Saluda Mountains. He was a captain in command of the company of Volunteers in the War of 1812 in the Indian Nation under General Jackson, and suffered many hardships in the memorable campaign. In 1837...for the Florida War Col. Hodges was among the first to offer his services. (long account) He has left an aged widow and large number of children. (ibid.)

Died at the residence of Mr. Silas Woody, on Spring Creek, Buncombe County, N. C., on the 17th ult., William Woody, Sr., aged 114 years. He was a soldier in the War of Independence, and for a great many years an orderly and acceptable member of the Baptist Church. (ibid.)

Departed this life, near Versailles, Mo., on the 24th of October 1849, Mrs. Elizabeth Salmon, aged about ninety years. The subject of this obituary was born in Frederick County, Va., in December 1759. She emigrated to the State of South Carolina at an early day, being about twelve years of age.
