Dear Carol:

My search continues for the connection between my two great grandmothers, Lucinda (Edrington?) Duncan and Priscilla (Edrington?)Woodward, whom I believe may have been sisters. (See enclosed research material) If they were, they were two of six daughters and one son of John Edrington and Bathsheba (Basha) Fant who lived in Fairfield County from 1800/ 1830, then were in the census of Union County in 1840.

The search seems fairly promising, and working with Mr. William Cheatham of Crofton, Maryland (through your reference to Claire Utt), I am hoping we can fill in that line of the Edrington family. I wish I had more time to send some of my findings to you, but feel compelled to make finishing my book on the Woodwards's a priority, due to my age, and I am reluctant to send undocumented research material. After that, I hope to send you a file on some of my research that will be a comprehensive addition to your files, not only on the Woodwards, but of Fairfield County people who settled in Pickens County, Al.

Some possible names I would like to pursue are through the Fants, the Yongues, Nevitt, Hilliard (Hillard), Alcorn, Watts and Strickland. If these appear in any of your resources, especially wills, deeds, estates, or matters of record, I would be most interested in receiving them. Of course I will reimburse for costs of same, and I know you are busy with other requests, so am willing to stand in line. Meanwhile, I am enclosing a small stipend today.

I cannot remember if I responded to your last letter, as my life has been overly busy and I have been going through an extremely bad time with chronic back pain, but am finally seeing some relief, and have found some new exercises I can do. I am always appreciative of your prompt, cheerful, and helpful responses, and do look forward to adding to your archives.

Enclosed is a possible scenario that Mr. Cheatham and I have projected, so you may have a better idea of our efforts. The sixth generation (enclosed) regarding Lucinda Duncan and Priscilla Woodward Eubanks is well documented. The documentation to prove they were sisters is still lacking, as well as that they were both really Edringtons. Since most of John Edrington's children were girls, I feel the best way to prove or disprove is through a will or administration papers from John Edrington, and I have someone in Union County working on that. However there may have been connections through marriage, church, neighbors that could shed some light on their lives. John Edrington signed the application for the administration papers of Isaac Woodward by Priscilla Woodward, his widow. Lucinda Duncan stated in an affidavit that she was an "Eddington", and that she was married in Fairfield County. This was dictated to a J.P. in Pickens County, AL . and I suspect he may have erred, since I have found no Eddingtons in census records in Fairfield or Union Counties. Both Lucinda and Priscilla seemed to have had a closer relationship than through their children, Mary and James P. Wodward, who married each other.

I am also very interested to find a copy of the original deed in Fairfield County fromRandal (Randolph, Sr.) Woodward as follows:

Fairfield County Deed Book HH 45, Page 45..." a deed signed 18 February 1830.... A tract or plantation of land in Fairfield to MY SONS:*

<u>Randolph Woodward Jr..</u> <u>Isaac Woodward</u> <u>Ioseph Woodward</u>

+ page to file

<u>"Plantation of land which was an original grant to JOHN BELL and lying between lands of Isaac</u> Woodward, Richard Woodward, heirs of William Woodward.".

If you have a copy of the will in your records, I would very much like to have a copy.
