C and what is taken away by the prior Grant of
Richard Lambert at A and what is conveyed to
Loughbridge at E Situate on waters of the water
Creek in Fairfield District Having such form
mark & Boundary as the above plat represents.

That we William Ellison, John Ellison, James
Ellison and Joseph Ellison of Fairfield District
and State aforesaid Planters James Edger and Sarah
his Wife of the City of Charleston and same State
in consideration of one hundred and fifty Dollars
to us paid by William Edger of the District of
Fairfield and same State merchant. Have granted
bargained sold and released and by these presents do
Grant bargain sell and release unto the said
William Edger, all that plantation or tract of Land
containing one hundred and forty three acres situate

being what remains of a tract of three hundred and
 fifty acres of Land originally granted to Robert Ellison
 on the 5th Day of November anno Domini 1756 after
 Deducting therefrom the Land claimed under prior
 Grants, and said plantation or tract of 143 acres of
 Land is represented by a plat of resurvey thereof
 made by Samuel L. Ellison the 14th Day of January 1617
 and to these presents annexed and hath such shape form
 Marks, Cuttings and Boundings as the said plat of
 resurvey represents, Together with all and singular
 the rights members, hereditaments and appurtenances
 to the said premises belonging or in any wise incident
 or appertaining. So have and to hold all and singu-
 lar the premises before mentioned unto the said
 William Dodger his heirs and assigns forever - and
 we do hereby bind ourselves our heirs executors
 and administrators to warrant and for ever defend
 all and singular the said premises unto the said
 William Dodger his heirs and assigns against our-
 selves and our heirs, and against every person whom-
 soever Lawfully claiming or to claim the same or
 any part thereof. Witness our hands and Seals

 States of America
