ally granted to the said Robert Ellison the 6th
of November 1786, and situated in Fairfield county
on Wimmshorough roads and having such form
and marks as the plat annexed to the said grant
represents, and whereas the said **Thomas Lupton**
departed this life intestate, leaving his widow
Anne Lupton and his children **Mary Lupton** **John**
Lupton **William Lupton** and **Thomas Lupton**, and whereas
the said **Anne Lupton** hath intermarried with
George Wallerson, and the said **Mary Lupton** hath
intermarried with **William Mills** of Chester District
and whereas the said Robert Ellison in like manner
did grant bargain sell and release convey unto
John Stinson one other piece of Land being

the aforesaid tract upon the death of the
said John Stinson came and descended to
his widow Jane Stinson and his daughter

conveyed the said last mentioned piece of Land
to William Adger Excepting about four
acres thereof adjoining one side of the Wims-
borough Road etc. Know ye that we the
said George Wallerson and Anne Wallerson his
wife, William Mills and Mary Mills his wife
John Leslie, William Leslie and Thomas
Leslie in consideration of five and fifteen
Dollars to us paid by William Adger of Fair-
field District and state aforesaid, Merchant have
granted bargained sold and released and by the
presents do grant bargain, sell and release unto
the said William Adger all those two piece
or parcels of Land above mentioned and described
that is to say all that piece or parcel of Land
conveyed by Robert Ellison to Thomas Leslie
and all the residue of that piece or parcel of Land
conveyed by Ellison to John Stinson and not here-
to fore conveyed by Jane Stinson and Anne Leslie
to the said William Adger, which said two piece
or parcels of Land adjoin each other and contain
the one hundred and three acres and are situate

the said John Stinson came and resided to
his widow Jane Stinson and his daughter
Anne Leslie, and whereas the said Jane
Stinson & Anne Leslie bargained sold and
conveyed the said last mentioned piece of land
to William Adger excepting about four

conveyed by Ellison to John Stinson and not here-
tofore conveyed by Jane Stinson and Anne Leslie
to the said William Adger, which said two pie-
ces or parcels of Land adjoin each other and con-
tain together one hundred and three acres and are now
situated by and have such shape, marks and bound-
aries as appears from a plat of resurvey
