

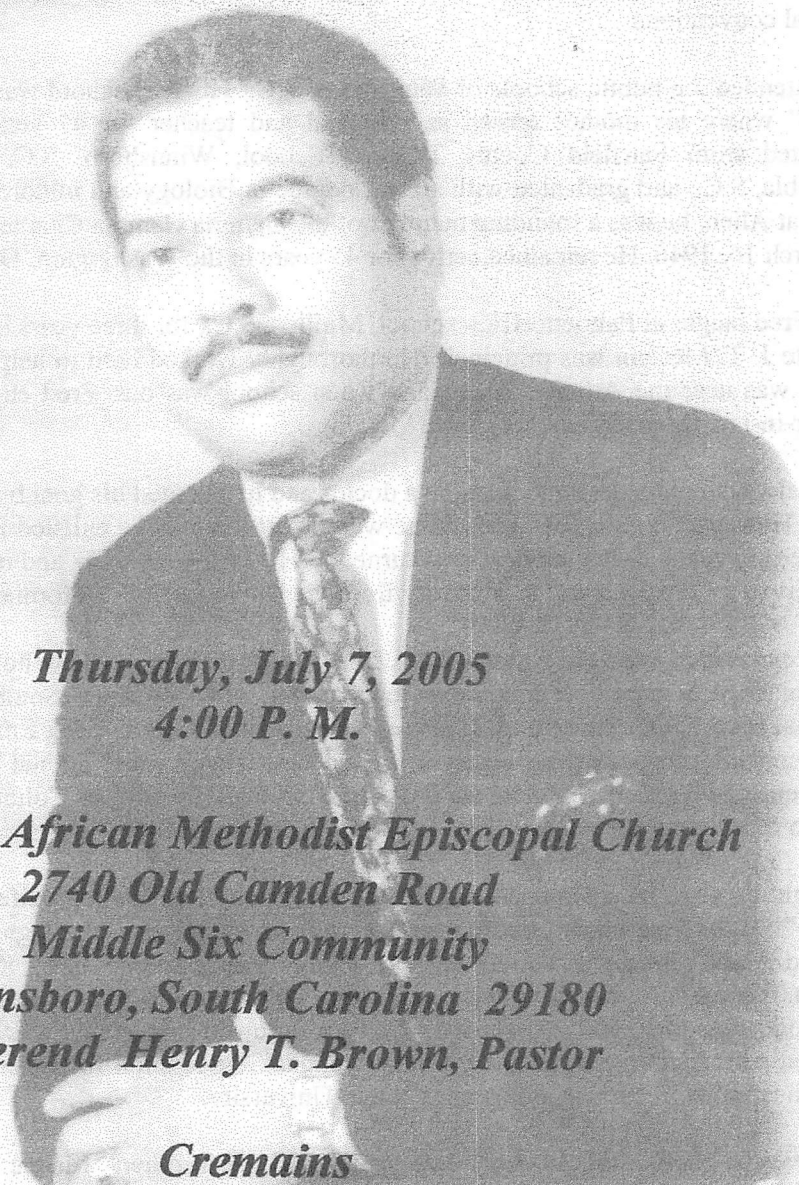

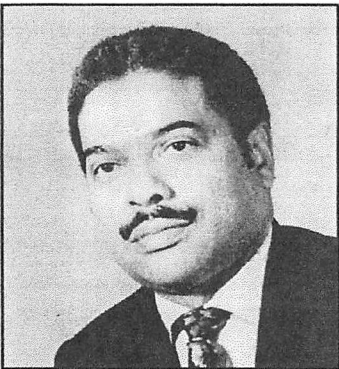

Frederick Wallace Ford

Federal Agent (Retired)



In June 1968, the Bureau of Drug Abuse Control (BEDAC), which was a Special Operation Division of the Food and Drug Administration was merged with the Bureau of Narcotics and Dangerous Drugs under the United States Justice Department. Mr. Ford who was a member of BEDAC was then assigned to the New York District Office of BNDD, as a Senior Investigator, working on major cases involving the investigation of drug smuggling. In 1971, Mr. Ford was promoted to the position of Group Supervisor in BNDD's New York office. He supervised other agents in the investigation and apprehension of violators, in New York and New Jersey, who were major traffickers in illegal narcotics. In July 1973, BNDD was reorganized and became the Drug Enforcement Administration.

In 1976, Mr. Ford received a promotion and was transferred to the Bangkok Regional Office, in Southeast Asia, where he supervised investigations of drug trafficking throughout Southeast Asia. Mr. Ford returned to the U.S. in 1980 and was assigned as a Supervisory Special Agent at DEA Headquarter, where he retired in 1981.

In 1988, Mr. Ford was selected to be one of the first Drug Program Agents covering the National Football League's, (NFL) drug abuse problem. Mr. Ford was assigned as the representative to the Washington Redskins. He resigned from this position in 2002.

Frederick Wallace Ford, B.S. degree in Biology from Allen University, and a South East Asian diplomat, retired from the Department of Justice, Drug Enforcement Administration as a senior criminal investigator in 1981. Following Fred's retirement, he began a second career with the National Football League's Regional Drug Enforcement Program, covering the areas of Maryland, the District of Columbia, Virginia, and, North Carolina.

During Fred's career with the Department of Justice, he received numerous "Excellence in Performance" awards for continuous outstanding service. Since retirement, Fred has received a most cherished award from NAFEO (National Association for the Equal Opportunity in Higher Education) for dedicated service to his dear alma mater, Allen University. This institution of higher learning motivated Fred to pursue further training at Howard University and later he received a Certificate in Criminology from the University of California at Berkeley.

Throughout Fred's career, there is one thing that has remained constant in life. It is his undying love for "Ole A.U." and his tireless efforts to preserve the legacy of the founding fathers, by fulfilling the dreams of our people, especially the young, to attend college. May the living God continue to bless Fred and may Allen University remain forever in the Annals of Higher Education history as a haven for all those who need assistance in following their dreams of "going to college".
