CHILD #2 - JACOB JR., WAS ADMIN. OF ESTATE OF HIS BROTHER JOSEPH L. GIBSON CHILD #3, WHOSE ESTATE WAS PROBATED FAIR, CO. S.C. 1806

WHAT I BELIEVE IS THIS JOSEPH L. GIBSON HAD A SON JOSEPH GIBSON, POSSIBLY A JR., AND THAT HIS WIFE WAS LYDIA.

I BELIEVE THAT JOSEPH JR. AND WIFE LYDIA MOVED WEST AND LIVED FOR SHORT PERIODS IN TENN. AND ALABAMA BEFORE SETTLING IN MONROE CO. MISS. WHERE HE APPEARS IN 1820 CENSUS. HE DIED THERE IN 1849. HE HAD A LARGE FAMILY.

DO YOU HAVE ANYTHING THAT MIGHT SUGGEST WHAT I BELIEVE IS TRUE,

I WOULD LIKE TO KNOW WHERE IN TENN. OR ALA. THEY LIVED EARLY 1800'S. MAYBE OTHER GIBSONS WERE THERE TOO.

IN MONROE CO <sup>MISS.</sup> CENSUS OF 1820 THERE WAS ALSO A JAMES GIBSON AND LARGE FAMILY. THIS COULD BROTHER OF JOSEPH L.
