After Mary died, Henry Gibson migrated to Louisville, Winston County, Miss., and is buried there. This Mary Gibson was a daughter of Mary (Gladden) Gibson and Capt. Henry Gibson. Mary (Gibson) md. James Davis, in Fairfield County, S.C., before moving to Miss. C. ISA The enclosed document lists the heirs of Dorcas (Gladden) (Hall) Montgomery. The brothers and sisters. Some were deceased, but she listed the names of their children. You will find the names of Mary (Gladden) Gibson and Capt. Henry Gibson's children. Their names are:
