He was a widower. (?) Gertrude Mayfield in Chester told me in 1965 that their father was Silas Gladden, Sr. Cousin Gertrude was elderly at that time. Her mother was a Kirkpatrick and a sister to my dad's grandmother, Martha (Kirkpatrick) Carter.

My grandfather, James Henry Gladden, was born 28 Nov. 1859, died 3 June 1930. He was 1st md. to Regina (Carter) and they had the following children: Mary Boyd Gladden, who married John S. Estes; James McCollum Gladden, unmd. when he died in 1918; Charles Luther Gladden, who migrated to Miss. when he was about 19 years old; Joe Gladden, who disappeared in his teens and no one knows where he went. My mother, Martha Geneva Gladden, b. 11 Feb. 1889, Chester County, S.C.; and he she lost her left leg when she was 5 years old. She went to Miss. when she was 23 years old, and made her home with my uncle. Regina (Carter) Gladden d. suddenly 18 Jan. 1891, bur. in Calvary Baptist Church Cemetery in Baton Rouge Community, Chester County. Then my grandfather md. 2nd: Nannie Coyle (Quinton), and they had six children. They were md. in 1894.

Now getting back to Mary (Gladden) Gibson family. On another sheet of paper I am going to give you the names of Mary Gibson Davis children and family data. Some of the children were born in Ridgeway, S.C., and the others were born in Louisville, Winston County, Miss. I wonder if Capt. Henry Gibson stayed in S.C. until after the Civil War. I have a book "The CENTENNIAL HISTORY OF WINSTON COUNTY, MISS., by William T. Lewis, who was from North Carolina (1811-1893), who came to Miss. in 1836, and resided there until his death, and in 1876, he wrote his "MEMOIRS". It covers the history of Winston County from its earliest days through the War between the States.

He resided in Winston County for fifty-seven years and was closely identified with his history, having served in elective offices. The copy of the Manuscript, copied from the original, which is on file at the Miss. Dept. of Archives and History, and was presented to the Winston County Library in 1955, by the It was copyright 1970, & published Library's Board of Trustees. by GLOBE PUBLISHERS INTERNATIONAL, P. O. Box 5386, Pasadena, Texas. An elderly friend of mine, at least she is 90 years old now, Josie Worthy Holman sent me a copy. She was the one who did so much of Colonel Ivan E. Bass's Book, "THOMAS WILKES AND HIS DES_ CENDANTS, 1965, research work on the S.C. Wilkes family, who had migrated to Miss. In this book of Mr. Lewis's, he listed all the men from Winston County, Miss., who served in the CSA. Some having served several times and names of those who donated money. As Capt. Henry Gibson did not show in the list of names having been in the CSA. So he must have migrated to Louisville, after his wife, Mary Gladden, died. I will make a separate record of Mary (Gibson) Davis and James Darling Davis family. It is supposedly a Bible Record of Dr. Henry Hinds Davis family, which is now in possession of the family of his son, James Dwight Davis.

I knew that Keziah Gladden was married to Rev. Thomas Hall. Would you mind giving me the other children of Keziah that was not mentioned in that document. When I was a little girl or when I was growing up a lady in our area told me that she and my mother were kin. She was Irma (Taylor) Slaughter and she had grown up in Leake County, Miss., which adjoined Winston County on the SW.

I have been interested and working in genealogy since 1964, and I have gathered a lot of family material. There was a time that I could go to the Mormon Library and order all kinds of microfilms of land, deeds and probate records and I covered a lot of territory during those days, and then Salt Lake City Mormon Genealogical Library, stopped sending out the films to their inter library loans to their branch libraries. I have always had a good memory of Chester Co. area, and how to put the families together. I have a copy of Admiral Bass's Wilkes Book and the Colvin Book. I belong to the Chester Chapter DAR, "Mary Adair Chapter. I am on the Gen. Committee. In 1980 I put together all my Gladden data. I once took the Winnsboro paper and I have been taking the Chester paper for 18 years. So I' keep all my obituaries on the different ones. I have scads of material on Chester County and its people.

I established my line back to George Phillips, Patriotic Services, during the American Revolution. He was the father of Mary (Phillips) Elam, and wife of Martin Elam, parents of Frances (Elam) Arnette. I thought that your husband probably descended from John Q. Arnette, too. Sarah Arnette, their daughter, married Herndon Chalk, and they were my dad's grandparents. Mary Ann Arnette died young. She had md. Ellege Land and they had two children. I will give you that document. Sarah lived until after Herndon Chalk had died, because she gave them a hard time about giving her a dower, after Herndon's death. A certain amount was set aside of the land for her dower. My dad descended from Sarah and Henrdon's son, Benjamin P. Chalk, who md. Alice Frances Carter, dau. of John Joseph Carter and Martha (Kirkpatrick) Carter. Benjamin P. Chalk was accidentally killed in 1887 while they were living in Arkabutla, Tate County, Miss., which is in the NW Corner of Miss.

Jesse Gladden's son, William Gladden, who d. in 1828, Fairfield Co., S.C., Jesse Gladden, his brother, and Elisha Gayden, his brother-in-law, were administrators of the estate, as he died intestate. It also mentions Sterling Tidwell. They had a lot of trouble settling that estate. They filed a Summons in Partition. It mentions Silas Gladden, Elijah Gayden and Sarah, his wife; Thomas Hall and Kezziahr his wife; Jesse Gladden, James Gladden, John Gladden, John Hall and Dorcas, his wife; Nancy Tidwell & William Tidwell, legal heirs. It was on the waters of the Wateree Creek. That name Calvin interests me. I am wondering if the C in John C: Gladden's name might have been Calvin, as he had a grandson named William Calvin Gladden, a son of John L. Gladden and Martha (Hyatte) Gladden.

My mother always said that the Gladden family had come from Ireland, back during the Potato family. I have checked all kinds of records to see if they came to Fairfield from Ireland, but I am more inclined to think they might have come from Virginia. I really wish that I knew for certain. I have had a hard time learning much about the early family, except what I have learned from probate records, etc. My mother has a half-brother, who lives in Rock Hill, S.C. But Uncle William worked out of the State of S.C. during all his working years. Granddaddy Gladden was knownfor his genealogy accuracy, but he passed on when I was ten years old. I have a copy of the Gladden family that I put together for the DAR in 1980. It is over 130 pages and about 101 pages are history and the other 31 pages include the index. Maybe if someone saw it they might be able to put some of it in Perspective.

In a couple of weeks I will take my Gladden history and have a copy xeroxed off and send you. A lady in Texas is trying to convince me that Minor Gladden was my descendant, but I am not sure she is right, as it is on supposition, and all worked out mostly from the census, and I know that the censuses are not always right. Raymond Gladden, a son of Mrs. Mary Gladden and the late Frank Hall Gladden, gave me a copy of his family, but he isn's definite or doesn't know which family that he descended from. Raymond lives in Great Falls. He had a sister that lived in Menlo Park, Calif., and I got to visit with her on two occasions when she was out. We lived in the San Jose area, until 1976, when we moved to Chico.

I have a book I will give you for your Museum. It is "A Sketch of Fairfield County," by Julian S. Bolick, 1963. It is like a historical sketch of the old places there, and would be of interest to the ones back there. I will be happy for you to have it.

Wish that I could answer more of your questions. Any Gladden data that you might have could possibly be of help. I am real interested in the Silas Gladden that you mentioned that died 12 Feb. 1872, and buried at Olivet. Louise K. Crowder once asked me if I would like the cemetery records of the Gladden's there. I give her a lot of records that I have done and she gives me a lot of things. She told me that I had really straightened out some of her work, since I have a good insight to the Chester County families.

Sometime I want to do some work on the Virginia Gladden's and see what I can come up with.

In 1970 I put together 100 copies of "MY CHALK FAMILY", and I will see if I can find a copy or put one together for you. I still have some covers and copies left.

I am enclosing some James Darling Davis and Mary (Gibson)
Davis Bible Records. Also, I have some Arnette material that
you might like to have or maybe you know it already.

So glad to have heard from you. Will look forward to hearing from you again, as I enjoy sharing what I have and what I know. I have so much material on the Chester County people, etc. Thank you.
