I was so glad to get your latter. I had heard about your visit to my brothers house. Hope uoy enjoyed your visit and trip down south.

I would like to let uou know that I am very interested in the GLADDEN history. Would love to have anything about Gladdens you can send me. You see my line of Gladdens I have traced back to JESSE and Nelly Gladden, b. 1750 and 1755. They had 10 children, l- Silas, 2- Jasse Jr.,3- William, 4-Sarah, 5- Keziah, 6-Mary 7- John, 8- James, 9- Dorcas and Lydia or Sylvia.

Of these John and James were twins, they married twin sisters Rebecca and Elizabeth Coleman. James Gladden and Elizabeth Roe Coleman are my great great grandparents. Most of this is facts and can be proven. Jesse and Nelly's children are not in order. I am enclosing my chaet from James and Elizabeth To me. The William my Brother was talking about is our Grandfather. The oldest Gladden's I have come across is from THE ROBERT COLEMAN FAMILY, Book page 424, TITHES OF LUNENBERG CUNTY, VIRGINIA - 1748 - It list two Gladden a RICHARD GLADDEN and WILLIAM GLADDEN. The next year (1749) they are not listed. This comes from some information I got from Regina Evans "from Calif." Story told to James A. Gladden of Great Falls, S.C. by his Father James A. "Jim" Gladden born Jan. 1869, who was the son of Jesse Gladden born in1833, married Sarah "Sallie" Gayden, (they left out Jesse Gladden J. married Nancy Grafton) who was son of Jasse (1) born ca. 1750's and md. Nelly. The story handed down to James A. Gladden from these generations of his family was that two Scotch-Irish brothers came from the Old Country to Virginia then into the North Centeral part of S. C. Brother to father of Will, Jesse and John went to North Carolina and the other brother stayed in South Carolina. (This was told to Helen per telephone call on May 19, 1980- Helen age 44 years).

(My mother, Martha (Gladden) Chalk always said that the early Gladden family came from Ireland during the Potato Family, and I believe that the early family into Fairfield County, S.C., came from Virginia.) By R. Evans, Chico, Calif.

Now there is a lot of other things that make me beleave that this story is clost to the truth, and this is what I have been working on in my spare time, which I havent had much of sence my home burnt a little over a year ago. I am building it back my-self sence I did not have it Insured.

As for the Gladden's you mentioned in the Information you sent me. I am sending you some info on Brig-General Adley Hogan Gladden, if you havent allready seen it I think you will. It is not a good copy job because it is about the third time copy, hope you can make it out.

I am hoping to put togather some more on William Gladden, (The brother to Jesse and John plus more I think. I HAVE ON PROOF of this yet). I think that this is the William born 1750 in your charts. In coppies from CAMDEN DISTRICT, S. C. WILLS & ADMINISTRATIONS 1781 - 1787, William Gladden applied for Admn. on the estate of William Gladden, Planter, decd., as nextofkin, 21 may 1782. This could be Father and son, it also (the younger one) could be the William Gladden you are talking about, I THINK.

Must stop for now. Please excuse me if I do not get to answer your letters as soon sa possible. When the weather will permit me I am working on my home. I go to work from a house trailor parked in a trailor park in Norcross, my home is in Jasper Ga.

I am looking forward to hearing from you and corosponding with you on the Gladdens. Please excuse my typing I use the hunt and peck system. Would love to hear from you and hope to get and give info on your line of Gladdens.
