Ordered that a Warrant Issue to the Petitioner for 400 acres of Vacant Land he swearing to his said family Right.

Read the Petition of Nathaniel Ford praying his Family right Consisting of Six persons on Vacant Land. Granted.

Read the Petition of John McPherson praying his family Right of Seven persons in the Township of New Windsor. Ordered that a Warrant Issue to the Petitioner for three hundred and fifty acres and a Town Lott in New Windsor.

Meeting of Tuesday the 12th September 1738

On Motion of the Hon'ble Mr. Wragg for 2500 acres of Land being thereto intituled by His family Right. Ordered that a Warrant Issue to the said Mr. Wragg for 2500 acres of Land Vacant and that Mr. Secretary or his Deputy prepare the Same.

Meeting of Tuesday the 16th September 1738

Read the Petition of Major Christian Mote praying a Warrant for 500 acres of Land in Consideration of his Services as Major and a Magistrate in the Township of Orangeburgh, SaxeGotha, and Amelia. Ordered that a Warrant do Issue according to the prayer thereof.

Read the Petition of Mary Larrimore Setting forth that She has ten persons in family for which she has hitherto had no Land and therefore praying a Warrant of survey may Issue to her for 500 acres of Vacant Land. Ordered That a Warrant do Issue to the Petitioner according to the prayer of her Petition.

Read the Petition of William Anderson Setting forth that he has Eight persons in his family for which hitherto he has had no Land & therefore praying a Warrant of Survey may Issue to him for 400 acres of Vacant Land.

Read the Petition of Kenneth Mackenzie setting forth that he hath nine Slaves and three White Servants in his family for which he had hitherto had no Land and therefore praying a Warrant of Survey may Issue to him for 600 acres of vacant Land. Ordered that a Warrant of Survey do Issue to the Petitioner pursuant to the prayer of his Petition.

Meeting of Thursday the 16th November 1738

Read a Certificate Signed by Major Christian Mote in favor of Herman Geager of SaxeGotha who had two Sons born at one time and therefore prays for a warrant of one hundred Acres of Land without any Charges. Granted.

Ordered That whereas a Grant of Seven hundred Acres of Land in Craven County passed the 19th of Feby 1738 to Martha wife of John Goodwin by the name of Martha Bell her former husbands name through a Mistake. That the Minutes of Council relating thereto & the Grant shall be altered accordingly.

The Hon'ble Joseph Wragg Esq'r a member of this Board desireing a Special Warrant to Survey the Marsh on Land fronting or lying before the Land Granted to said Wragg & Paul Jenys Esq'r on the head of Chehaw River so Farr as the Said River or the Run that leads to the same, and the said request appearing just and reasonable, It is orderd that a Special Warrant do Issue to the said Wragg according to his Desire.

Meeting of Thursday the 17th November 1738

The Hon'ble Joseph Wragg Esq'r in behalf of his brother Samuel Wragg Esq'r of London, applied to this Board by his Memorial of the 23d day of February last to grant him on Order of Council for John Ouldfield & George Pawley Esq'rs or either of them to make diligent search and Inquiry for two Tracts of five hundred acres of Land each granted by the late Lords Proprietors to the said Samuel Wragg and Jacob Satur in the year 1714 as appears P said Grants and the said memorial of the said Joseph Wragg and of the 7th Day of March following, an order of Council passed to Empower the said John Ouldfield and George Pawley or either of them to put the said order in Execution but as no Return hath yet been made by either of them, and the said Wragg being desirous that Cap't Meredith Hughes be added to the said Ouldfield & Pawley to perform the said Order. It is therefore Ordered that Cap't Meredith Hughes be added to the said John Ouldfield and George Pawley Esq'rs and he is hereby authorized & empowered to put the said Order of the 7th March last in Execution Joyntly with the said John Ouldfield & George Pawley or either of them or separatly by himself exclusive of said Ouldfield and Pawley.

Read the Petition of Randal Varley praying a Warrant for one hundred acres of Land having Sworn to his family Right. Granted.

Read the Petition of Mr. Paul De St. Julien praying a Warrant for Eleven hundred acres of Land having Sworn to his family Right. Granted.

Read the Petition of Mr. Benjamin Mazyck praying a Warrant for five hundred acres of Land having Sworn to his Right. Granted.

Read the Petition of Abiah Small, widow, praying a Warrant for three hundred acres of Land having Sworn to her Right. Granted.

Read the Petition of Mr. Jerome LeBeuf praying a Warrant for one hundred acres of Land having Sworn to his Right. Granted.
