HENRY BONNEAU, 25 Jan. 1775: 1000 acres in Colleton County. Bounded E on Stono River; S on the Atlantic Ocean; W on vacant land; N on Keyawah Creek. Survey certified 9 July 1774; granted 19 Aug. 1774. Quit rent in 2 years. Henry Mouzon, Jr., DS. Delivered 7 Mar. 1775 to A. Vanderhow. [13-257:2]

PETER BOQUET, 25 Jan. 1775: 616 acres in Ninety Six, N side of Beaverdam Creek. Bounded S by Samuel Simpson; SE by Thomas Hanbie; NW on land laid; W on Samuel Hanbie. Survey certified 12 May 1773; granted 19 Aug. 1774. Quit rent in 2 years. Jonathan Downs, DS. Delivered to memorialist 10 Feb. 1778 by C. J. L. [13-257:3]

ALEXANDER BROWN, 26 Jan. 1775: 100 acres in Craven County on small branch of Wards Creek, a branch of Tyger River. Bounded W by Andrew Cowan; other sides vacant. Survey certified 15 Mar. 1773; granted 19 Aug. 1774. Quit rent in 2 years. Andrew Thompson, DS. [13-257:4]

JOHN BROWN, 26 Jan. 1775: 350 acres in Craven County on N side of North Fork of Tyger River. Bounded SW by said river; NW by Saml. Snowdy; other sides vacant. Survey certified 19 Jan. 1773; granted 19 Aug. 1774. Quit rent in 2 years. James Wofford, DS. [13-257:5]

JOHN CAMPBLE, 26 Jan. 1775: 150 acres in Berkley County in fork between Broad and Saludy Rivers on small branch of Tyger River called Pagets Creek. Bounded SE on Henry Clark; other sides vacant. Survey certified 8 July 1774; granted 19 Aug. 1774. Quit rent in 2 years. Enoch Pearson, DS. Delivered 7 Feb. 1775 to Enoch Pearson. [13-258:1]

WILLIAM CARSEN, 26 Jan. 1775: 200 acres in Waxaw Settlement on a branch of Cane Creek. Bounded W and N on Thomas Simpson; other sides vacant. Survey certified 6 July 1774; granted 19 Aug. 1774. Quit rent in 2 years. Pat. Cain, DS. Delivered 27 Jan. 1775 to Wm. Nesbitt. [13-258:2]

WILLIAM CATTELL, 26 Jan. 1775: 960 acres in Granville County, Prince Williams Parish. Bounded NW on Andrew Postell; SW on James Smith and Joseph Brailsford; SE on Ephraim Mitchell; NE vacant. Survey certified 15 July 1774; granted 19 Aug. 1774. Quit rent in 2 years. Jno. Fenwicke, DS. Delivered 27 Mar. 1775 to John Fenwicke. [13-258:3]

DAVID CLANTON, 26 Jan. 1775: 350 acres in Craven County on Little River. Bounded SW on bounty land and John Grant; NE on Edward McGraw; other sides vacant. Survey certified 2 Mar. 1773; granted 19 Aug. 1774. Quit rent in 2 years. John Winn, DS. Delivered 29 Mar. 1775 to Richd. Winn. [13-258:4]

JAMES CASSELLS, 26 Jan. 1775: 611 acres in Craven County on Waccamaw Neck. Bounded S on land granted to {-} Smith, now held by Anthony Mitchell; W on Huger and land said to belong to Mr. Allston; NE on land granted to Lingard; SE on land granted to Jno. Turner, now held by Henry Clark. Survey certified 4 June 1773; granted 19 Aug. 1774. Quit rent in 2 years. Geo. Pawley, DS. Delivered 10 June 1775 to James Cassells. [13-258:5]

JOHN COMBEST, 26 Jan. 1775: 50 acres in Craven County on both sides of Fishing Creek. Bounded W by Peter Culp; SW and NE vacant; NE by Lattes. Survey certified 8 July 1774; granted 19 Aug. 1774. Quit rent in 2 years. Delivered 20 Sept. 1775 to Samuel Neely. [13-258:6]

WILLIAM GORDON, 27 Jan. 1775: 300 acres, when runout in Anson County, N. Carolina, on N side of Enoree River joining Mrs. Ruth Anderson. Originally granted 23 Feb. 1754 to John Gordon, Sr. by Mathew Rowan, Esqr., which tract, after divers conveyances became property of Thomas Gordan, but, by a late resurvey, now falls in S. Carolina, in Craven County. Also, 200 acres in Berkley County on a branch of Enoree River called Broad Branch. Bounded SE part on Isaac Pitchlyn and part vacant; other sides vacant. Originally granted 22 Mar. 1769 to Thomas Gordan, who, by his wife, Elizabeth, conveyed the above tracts to William Gordan, the memorialist, by L & R 12-13 Apr. 1773. William Gordan. [13-259:1]

JOHN ANDING, 27 Jan. 1775: 100 acres in Colleton County. Bounded by vacant land, being part of a tract of 48,000 acres originally granted by the Lord Proprietors to Landgrave Thomas Smith, and by him conveyed to Wm. Fuller 22 and 23 Nov. 1724, and after became vested in Wm. Fuller, Jr. (as son and heir at law of Wm. Fuller, Sr.), who sold the tract of 100 acres to John Anding, the memorialist, by L & R 26-27 Jan. 1761. Margaret (X) Anding. [13-259:2]

RICHARD CURTIS, 27 Jan. 1775: 100 acres in Craven County on N side of Peedee River on a

ert Roseborough and vacant land; other sides vacant. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. E. Pearson, DS. {Margin note: "Irish"}. [13-508:2]

JAMES FOSTER, 13 June 1775: 100 acres in Granville County on waters of NW Fork of Long Cane. Bounded SW on Charles Hamilton; SE on Robert Clayton; NE on Robert Campbell; NW on Edward Fletchall. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. Robt. Anderson, DS. {Margin note: "Irish"}. [13-508:3]

ISABELLA FOSTER, 14 June 1775: 100 acres in 96 District on Long Cane Settlement. Bounded NW on Mary Parkinson; NW on John Anderson and vacant land; other sides vacant. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. Pat Calhoun, DS. {Margin note: "Irish"}. [13-508:4]

WILLIAM FOSTER, 14 June 1775: 300 acres in 96 District, Long Cane Settlement. Bounded NW on Maria Magdalen Bellot, John Betty and Jacob Langel; NE on Thomas Lyndis and Township line of Hillsborough; SE on Sarah Foster and vacant land; SW on Jane Bellot. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. Pat Calhoun, DS. {Margin note: "Irish"}. [13-508:5]

SARAH FOSTER, 14 June 1775: 100 acres in 96 District, Hillsborough Township. Bounded NW on William Foster; other sides vacant. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. Pat Calhoun, DS. {Margin note: "Irish"}. [13-508:6]

MARGARET FULTON, 14 June 1775: 100 acres in Granville County, Belfast Township. Bounded SW on Thomas Eslar; NW on John Fulton and vacant land; NE on Robert Ewin and vacant land; SE vacant land. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. Pat Calhoun, DS. {Margin note: "Irish"}. [13-509:1]

JOHN FINLAY, 14 June 1775: 100 acres in Craven County on waters of Dry Fork of Fishing Creek on the Saludy Road that goes to Fish Dam Ford on Broad River. Bounded NE on Richd. Ferrell; other sides vacant. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. Jno. Gaston, DS. {Margin note: "Irish"}. [13-509:2]

WILLIAM FAIREY, 14 June 1775: 200 acres in Craven County. Bounded E on William Boyl and

David Chesnut; SW on John Pike and Mathew Gunil {?}; N on Elisha Garret; other sides vacant. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. Alexdr. Turner, DS. {Margin note: "T"}. [13-509:3]

RACHEL HARPER, 14 June 1775: 80 acres in Craven County on Broad River. Bounded SE on Jacob Ingelman; E by Joseph Owen; NW on Thomas Nelson; NW on David Tenant; SW on Nicholas Edwards. Also, 20 acres, as above, on a branch running in N side of Broad River. Bounded SE by Daniel Edwards; NE by William Ballantine; NW by Thomas Hubbard; SW by John Duncckly. Both surveys certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. John Ellison, DS. Delivered 18 Sept. 1775 to William Land (X). {Margin note: "Irish"}. [13-509:4]

ROBERT HARPER, 14 June 1775: 250 acres in Craven County on a small branch of Wateree Creek. Bounded NE and E by Hugh McDonald; other sides vacant. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. Alexdr. Turner, DS. Delivered 18 Sept. 1775 to William Land (X). {Margin note: "Irish"}. [13-509:5]

JAMES HARPER, 14 June 1775: 100 acres in Craven County. Bounded SW on John Hawthorn and Peter Grant; SE and NW vacant land; NE by Jeremiah Herris. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. Robert Ellison, DS. Delivered 18 Sept. 1775 to William Land (X). {Margin note: "Irish"}. [13-510:1]

JEAN HARPER, 14 June 1775: 100 acres in Craven County. Bounded W on John Powell; NE on Thomas Parrot; SE on Bounty land and Patk. Smith; S on William Rabb. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. Robt. Ellison, DS. Delivered 18 Sept. 1775 to William Land (X). {Margin note: "Irish"}. [13-510:2]

AGNESS HANNAH, 14 June 1775: 100 acres in Craven County on draughts of Rocky Creek. Bounded N and NE on William Ballentine; NE on David Hunter; SW on Ralph Baker. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2 years. Robt. McFaddin, DS. {Margin note: "Irish"}. [13-510:3]

MARY HANNAH, 14 June 1775: 100 acres in Craven County on waters of Rocky Creek. Bounded NE on Nicholas Bishop; SE on William Miller; other sides vacant. Survey certified 30 Sept. 1774; granted 8 Dec. 1774. Quit rent in 2
